GOLF CART LIABILITY WAIVER

The Arabian Horse Association of Arizona (AHAA), producers of the Scottsdale Arabian Horse Show, will require Patrons to provide their own liability insurance for the rental vehicle (golf cart). AHAA must receive a copy of the insurance card for all authorized drivers with the submission of their patron application. Patron acknowledges access to the rental vehicle is provided as a courtesy, and they are not obligated to accept or use the vehicle. The decision to accept and use the rental vehicle rests solely with the Patron.

As a condition to the acceptance and use of the rental vehicle(s), Patron agrees to defend and indemnify the Association, their agents, officers and employees against all claims, liability, loss, and expense arising out of the use or misuse of the vehicle. Patron also agrees to waive any right of subrogation he may have against the association as the result of any such loss. I understand that by signing this agreement, I am giving up any right to sue the Arabian Horse Association of Arizona, WestWorld, City of Scottsdale, and the Bureau of Reclamation and their affiliated companies and each of their respective present and former officers, directors, employees, partners, agents, contractors, representatives and assigns, from any and all claims, demands, suits, investigations, losses, costs, damages or expenses resulting or arising from any injury to or death of any person or damage to any property caused by an act, omission or negligence of Patron or Patron's agents, employees, invitees, contractors or guests which occurs at the Event Facility, in each case whether or not caused by the negligence of Scottsdale Arabian Horse Show and whether or not the claim or suit has merit. Patron agrees to use rental vehicle at own risk and hereby releases Scottsdale Arabian Horse Show from all claims for any damage, loss or injury to persons or property to the full extent permitted by law. Patron shall be responsible for the control of the rental vehicle during the entire term for which they have possession. The rental vehicle shall be returned in its original condition. Patron is liable for and agrees to pay promptly for all damage to the rental vehicle when such damage is caused by Patron, or by any of Patron's agents, employees, invitees, contractors or guests. Patron also understand that by signing this agreement, they agree to be financially responsible for any damages or claims asserted against the Arabian Horse Association of Arizona resulting from my use of rental vehicle as part of this sponsorship. Patron agrees to defend (using counsel satisfactory to Scottsdale Arabian Horse Show), indemnify and hold harmless Arabian Horse Association of Arizona, their owners, employees, or agents, for any injury or damages while using rental vehicle as part of this sponsorship.
