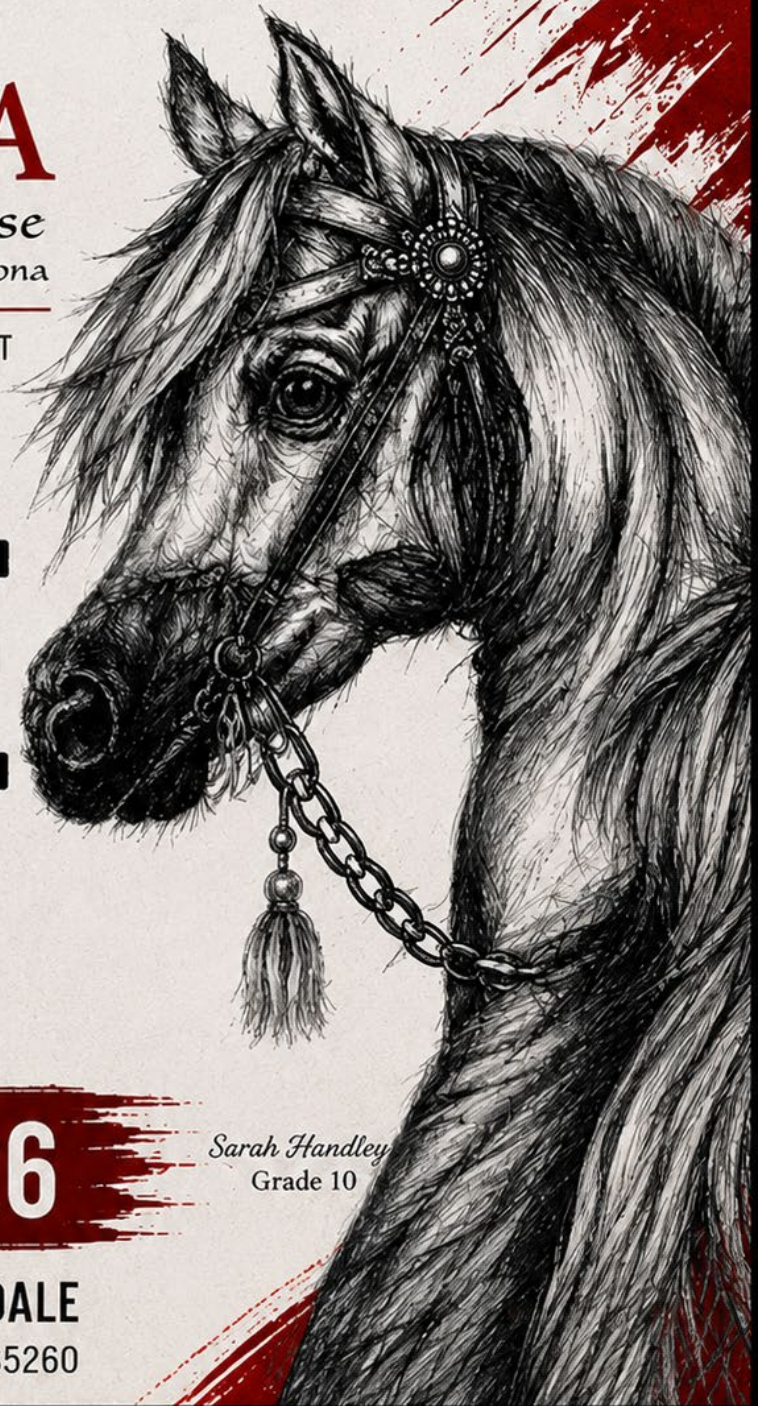

CLASS INFORMATION

Classes will be run and adjudicated based on the current USEF Rulebook. All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason, including but not limited to: unsportsmanlike conduct and animal cruelty. Copies of Registration papers and signed waivers for owners, trainers, and riders must be presented at the time of entries.

This Horse Show is conducted in accordance with the Rules of the USEF, particularly the Arabian, Half-Arabian, and Anglo-Arabian Horse Division, and the rules of the Arabian Horse Association (AHA). The official rulebook of each organization will prevail for this show. Each participant in this show is responsible for knowledge of these rules and is subject to these rules. Any changes or corrections to the rules will automatically become part of this prize list. Questions that may arise that are not covered by either the AHA or USEF rulebooks will be decided by the Show Committee, and their decisions will be final.

A/HA/AA Classes ONLY - Horses shown in this division must have been issued a certificate of Registration from the Arabian Horse Registry of America, Inc. (or in the case of a foreign entry, have been issued a Competition Visa by the Arabian Horse Registry of America) and/or the Canadian Arabian Horse Registry and registration applied for and must be entered under their full registered name. (Only weanlings that have had registration applied for may show without registration papers.) All entries, except in equitation and showmanship classes, must be serviceably sound. A copy of the registration papers showing proof of ownership MUST be submitted with the entry form at the time of making entry. In the case of a sale or lease, it is required that a contract of the sale or lease, or a statement from the owner be submitted with a copy of the registration papers. All entries must be in good condition. Horses with loss of sight in one eye may compete in performance classes only. Half-Arabian or Anglo-Arabian horses will be allowed in the Half-Arabian classes only (except where otherwise specifically stated) and must have been issued a certificate of registration from the Arabian Horse Association in the Half-Arabian or the Anglo-Arabian Registry, or a Canadian Half-Arabian registration paper, AND MUST BE ENTERED UNDER THEIR FULL REGISTERED NAME. PHOTOCOPY OF BOTH SIDES OF THE REGISTRATION PAPERS OF EACH HORSE MUST BE SUBMITTED WITH THE ENTRY FORM. A FEE OF \$10.00 WILL BE CHARGED FOR EACH HORSE WITHOUT A COPY SUBMITTED WITH THE ENTRY.

DISQUALIFICATION - Refer to the current USEF Rule book. Any horses doctored in any way artificially, improperly, or unfairly prepared, or tampered with before entering the show ring will be disqualified. If it is ascertained that any exhibitor has made or caused to be made, any false statement regarding any animal or article exhibited, or if any exhibitor attempts to interfere with judges in the performance of their duties, they shall be excluded from competing or exhibiting or showing case of any horse being disqualified, the winner of the next succeeding prize in the class shall take the prize that has been awarded to such disqualified horse.

ENTRIES - Entries must be on the official entry form or a photocopy of the document for this show. Copy of horse's registration papers must accompany all entries in the A/HA/AA division. All horse(s) entered belonging to one owner must be entered on one entry form (additional entry form sheets may be attached). No horse may be entered on more than one entry form. The complete name and address of the registered owner must appear in the space entitled OWNER INFORMATION. One, and only one, the owner can appear on each entry form. The owner, trainer, and rider must sign the entry form in the spaces provided. If the owner, trainer and rider are the trainer same, owner must sign in both spaces. (Trainer is "any adult responsible for the care, training, custody or performance of a horse"). The permission for a minor to show section on the entry form must be completed with the birth date of the junior exhibitor and the signature of parent or guardian.

ELECTRONIC COMMUNICATION - Electronic communication devices used for coaching, etc., between competitors and individuals outside the ring shall be prohibited in all classes in the Arabian Division. Exempt from this rule are handicapped riders who have submitted written proof to USEF.

SHOEING REGULATIONS - Refer to the current USEF Rule Book.

GENERAL SHOW INFORMATION

Under Arizona law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a

participant in equine activities resulting from the inherent risk of equine activities. Pursuant to A.R.S. §12-553

ALCOHOL - IT IS UNLAWFUL FOR ANY PERSON OR ORGANIZATION TO BRING ALCOHOLIC BEVERAGES ON TO THE PREMISES. ALL ALCOHOL MUST BE PURCHASED THROUGH AHAA OR DESIGNATED VENDOR. NO EXCEPTIONS. THIS WILL BE STRICTLY ENFORCED.

ATTENDANTS, DUTIES, AND APPEARANCE - All Attendants in charge of horses, or assisting with the preparation and showing of the horses, will be subject to orders of the Horse Show Manager. All Attendants MUST be suitably and neatly dressed when entering the ring. Exhibitors must be correctly attired for the class, and attendants be neatly dressed and horses properly presented.

AWARDS – Qualifying classes will award Ribbons to sixth place in all classes. No prize money will be offered in any of the classes.

CLASS CALLS - Due to unforeseeable problems with any mechanical device, the public address system must be considered a courtesy. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate at the prescribed time. Every effort will be made to maintain a working public address system to carry class calls. As the first horse enters the in-gate, a two-minute time rule shall be enforced. Exhibitors should notify the ring announcer AND gate personnel if a tack change is required.

COGGINS, HEALTH CERTIFICATE & VACCINATIONS - **Mandatory for all horses coming onto the WestWorld property as per Arizona state law:** All horses 6 months of age and older must have proof of a negative Coggins (*dated within the previous twelve months*) and horses from out of state must have a valid Health Certificate (*dated within the previous thirty days*). Coggins, Health certificate and Vaccinations must match the horse being entered into the show and must include a complete description of the horse and must specify the home location of the horse. **Horses will not be permitted on the WestWorld property without the submission of a Coggins, Health Certificate and Vaccination records. Horses caught on the property without necessary paperwork will be asked to leave the grounds and will not be given a refund of any fees. PLEASE SUBMIT A COPY OF THE PAPERWORK WITH ENTRIES AND HAVE ORIGINAL COPY WITH YOU AS INSPECTIONS MAY BE DONE by show officials or designated representatives from the City of Scottsdale. Back numbers will not be released until show office has copy of Coggins, Health Certificates and Vaccination records. ANY EXHIBITOR, TRAINER, OWNER WHO KNOWINGLY BRINGS A SICK HORSE ONTO THE SHOW GROUNDS WILL BE LIABLE FOR ALL DAMAGES INCLUDING BUT LIMITED TO NEGATIVE FINANCIAL IMPACT ON THE SHOW, HORSES, THE CITY OF SCOTTSDALE AND THE ARABIAN HORSE ASSOCIATION OF ARIZONA. USEF EQUINE VACCINATION RULE:** All Federation licensed competitions; horses more than 7 months of age entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (*Rhinopneumonitis*) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. BOD 1/17/15 Effective 12/1/15.

COMPETITION AREAS - Dimensions - Equidome Arena: 135' x 290'; Wendell Arena: 180' x 360'; 3, 4, 5, 5A, 6,7,8 & 9:150' x 300'. ALL ARENAS have native clay and sand composition.

DIRECTIONS to WESTWORLD – 16601 N. Pima Road, Scottsdale, AZ North of Frank Lloyd Wright Boulevard - Pima Frontage Road is for northbound traffic only.

North (Flagstaff): I-17 South to SR-101 Loop - Eastbound into Scottsdale. Take the Pima/Princess exit. Make a left at Bell Road (second light) Continue east on Bell Road. Turn right on 94 Street. Travel south to the WestWorld entrance.
South (Tucson): I-10 to US-60 (Superstition Freeway). US-60 East to SR-101 Loop. SR-101 North to Frank Lloyd Wright Blvd. Exit at Frank Lloyd Wright Blvd., move to the far-right lane. Continue straight, crossing the Frank Lloyd Wright intersection. WestWorld entrance is ½ block north on the right at large horse statue.

DISCIPLINE - Exhibitors are warned that any act of discourtesy or disobedience to staff or officials on the part of the owner, groom, rider, driver or member of the family of the person participating in the show, will disqualify the horse/rider from adjudication. The management reserves to itself the right to remove any of the above named from the show without being liable for compensation or damages.

Excessive use of the whip on a horse on the competition grounds before or during the show, by any person, constitutes a violation and renders the offender subject to penalty. Judges will be expected to enforce this in the arena. Any action(s) against a horse by a participant deemed excessive by Staff, Officials or the Show Commission will be punished by elimination from the show. It is a violation of USEF Rules to commit any act or make remarks during the show that are considered offensive or made with intent to influence or cast aspersions on the judging, and any exhibitor may be barred from the show for this offense by the Show Commission.

DISPUTE NOT COVERED BY RULES - Should any question or dispute arise not provided for in the governing rules, the same shall be referred to the Show Committee, whose decision will be final.

DOGS - Scottsdale City Ordinance requires dogs to be on a leash at all times. THIS RULE WILL BE ENFORCED WITHOUT WARNING. Any pet in stall area must be on a leash or secured. No pets allowed in show office or arenas. Owner assumes all liability for pet animals.

DRUGS AND MEDICATIONS - The drugs and medication rules contained in the USEF Rule Book will be enforced.

EXCESSIVE USE OF THE WHIP ON ANY HORSE IN A STALL, RUNWAY, SCHOOLING AREA, SHOW RING OR ELSEWHERE ON THE COMPETITION GROUNDS BEFORE OR DURING A SHOW, BY ANY PERSON, CONSTITUTES A VIOLATION AND RENDERS THE OFFENDER SUBJECT TO PENALTY. JUDGES WILL BE EXPECTED TO ENFORCE THIS IN THE ARENA.

FARRIER – No farrier will be on the grounds for the day.

FIRST AID - First aid treatment will not be available during all performances.

HALTER BREEDING CLASSES: The Arabian Horse Association of Arizona has implemented new rules for the paddock and entry area for all Halter classes. These rules will be strictly followed. EFFECTIVE IMMEDIATELY, one person per class will be designated to assist with the entry of the Halter classes. Only that person will be allowed to use any sort of device to enhance the performance of the Halter horses. The designated person will be provided a whip with appendages that can be used to enhance the Halter horses in the paddock area. No other devices will be allowed. No one, including the designated person, will be allowed to hit or use any other objects, such as trash cans, walls, plastic signs, etc. to make additional noise. Additionally, no one will be permitted to use plastic or paper bags of any type or size in assisting with entrance into the Halter arena. Should this rule/policy be violated, the person violating the rule and the handler and/or trainer associated with the person violating the rule can be subject to sanctions. The gate will close when final horse has entered. All horses will be called to walk, horses will be judged at the walk. Upon completion of walk Judges will then begin individual judging of horses. Only the next horse on deck is allowed to school. After all horses have been presented in center ring there will be a 5-minute final review of the horses on the rail (it is not mandatory that the judges do a final review). See general conduct according to USEF rules.

ADMISSION TO RING - There will be an assigned order of go in all Halter classes. The Order of go shall be determined and posted by the birth date of each horse, from oldest to youngest. The prescribed order of go must be strictly followed. Horses that have missed entering the arena in the assigned order will be led in by the steward to their assigned order of go position on the rail. It is the exhibitor's/handler's responsibility to enter the arena in the posted order of go. **RING PROCEEDURE:** Horses will enter the arena in-hand at a trot, guiding in a counterclockwise direction. Each horse shall trot in one at a time and shall proceed at the trot until reaching its designated position in line as directed by the ringmaster. The judges and show management at their discretion may omit the walk on a loose rein from the halter classes.

INSURANCE ADVISORY - We urge each exhibitor to verify their liability insurance coverage, and their livestock mortality coverage, with their own insurance carrier(s).

Be sure your coverage is in effect. The AHAA One Day Show and the Arabian Horse Association of Arizona, its members, agents, employees, and volunteers accept no responsibility for any losses, injuries or actions caused by any individual.

JUDGES - In the event that due to an illness or failure of a Judge to attend the show or to perform their duties, the Show Committee reserves the right to substitute a Judge for the one who is officially designated in the Premium List, according to current USEF Rules. No contact shall be made with Judges during the period of the show unless accompanied by a member of the Show Committee designated by the Committee for such purpose. Further, no exhibitor shall approach a Judge regarding a decision unless he first obtains permission from Show Management, who shall arrange an appointment with the Judge at a proper time and place.

JUDGING SYSTEM - The comparative Judging system will be used for all halter classes and performance classes, reining score card, ranch riding score card will be used in each division.

LOCATION OF CLASSES - Management reserves the right to change the arena location of classes with the proper notification to exhibitors concerned.

MOTORIZED VEHICLES - Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

NON-RESPONSIBILITY AND INDEMNITY - All entries are accepted with the understanding that the Arabian Horse Association of Arizona will not be held responsible for any loss, damage or injury to any horse exhibited or any article of equipment of any kind. All horses shall be under the control and direction of the Show Committee solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animals or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Arabian Horse Association of Arizona, the City of Scottsdale and the U.S. Bureau of Reclamation against any and all loss, damages and liability thus occasioned, including but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Exhibitors, grooms, handlers, owners, etc. are hereby warned that they may not use any device or conduct which may cause harm to any other person(s) horses, or equipment. THE SUBMITTING OF AN ENTRY FORM TO THE SECRETARY SHALL CONSTITUTE AN ACCEPTANCE BY EACH PERSON SIGNING SAME OF THE PROVISIONS HEREIN SET FORTH.

PARKING - Any vehicle, truck or trailer, within the fenced area of the barn/arena area, or not obeying "NO PARKING" or "FIRE LANE" signs in other parts of the grounds will be subject to towing and impounding at owner's expense, and will also be subject to citations and/or towing by the City of Scottsdale.

PHOTOGRAPHS - Anyone who attends this show automatically grants AHAA permission to publish photos taken by AHAA photographers and/or staff in which they and/or their horses appear. No written release is required for AHAA to publish these photos in promotional material.

PROTEST - A protest must be filed as set forth in the AHA Rules.

REFUSAL OF ENTRIES - The Show Management reserves the right to refuse, accept conditionally or cancel any entries of any exhibitor as stated in the current USEF Rule Book.

REFUNDS – Once entries have been submitted horses may be scratched from the show at the discretion of the

owner; **HOWEVER, UNDER NO CIRCUMSTANCES WILL ANY FEES OR STALL AND TACK ROOM CHARGES BE REFUNDED TO THE EXHIBITOR.**

RETURNED CHECKS - All returned checks will be assessed a \$100.00 charge per attempt. Additionally, all declined & invalid credit cards provided will be assessed a \$100.00 charge per transaction (attempted). All fees must be paid in full by cash, cashier's check or money order before packets will be released in the Horse Show Office. The Show Management reserves the right not to accept checks from persons that have provided returned checks previously.

SCHEDULE - Show Management reserves the right to change the dates and/or the location of the show or to cancel the show altogether. In the event of a cancellation, all entry fees and stall fees will be refunded (office fees are non-refundable). Neither the Show Management nor the Arabian Horse Association of Arizona, shall have any liability to any exhibitor, owner, handler or other person, firm or corporation by reason of any change or cancellation of the show, except for the return of fees as aforesaid.

SECURITY - Exhibitors are advised that it is their responsibility to secure all their valuables while on the show grounds. AHAA will not be responsible for lost or stolen items. No security will be provided by the show.

SHARPS CONTAINERS – Trainers, owners, exhibitors or agents are advised that improper disposal of needles or other sharp disposable instruments will result in fines of \$100 per occurrence.

SHOW OFFICE HOURS - The Horse Show Office will open for entries at 7am and will close 30 minutes following the last class of the day. In an effort to help our show secretary, we ask that you send in your entries early.

STATE ENTRY - Tax & Requirements - If any tax is levied, it is the responsibility of the exhibitor and not the show. At the border of Arizona, you will need a HEALTH CERTIFICATE AND COGGINS on your horse(s) including a complete description of horse, complete home address and complete address of the show. The certificate must also state that the horse is coming to the show and must give the location of the return trip. This certificate must be dated within 30 days of the show.

STALLS – All stalls will contain stall doors. No shavings will be provided. NO STRAW IS ALLOWED. Stalls will be available at 7:00 a.m. the day of the show and must be vacated the same evening. **Early move-in may be approved on Friday at 3 pm, early move-in price will be \$40/stall.** To order feed & Bedding in advance contact WestWorld at 480.312.6814

STALL DAMAGE - Stalls must be vacated in their original condition. STALLS MAY NOT BE STRUCTURALLY ALTERED IN ANY WAY. DO NOT PUT NAILS INTO STALL WALLS. Exhibitors will be financially responsible for damage to their stalls and/or labor costs for removing materials used for stall decorative purposes. Damage, labor and replacement costs will be billed to exhibitor at the current WestWorld fee schedule. NO SMOKING IN THE BARN AREA.

STABLING RULES - Each horse must be assigned a separate stall and must be entered in the show. Only manure must be placed in areas designated, violators caught placing anything other than manure and shavings in designated areas will be fined according USEF rules. **ALL SHAVINGS MUST BE PURCHASED FROM THE ON-SITE APPROVED VENDOR. Violators are subject to a fine and/or removal from the grounds.** Horses must be placed in stalls assigned and no changes will be permitted except by the express consent of the Barn Manager. The use of electric, open flame or space heaters is prohibited. If you overload the electric circuit with extra lighting and blow out circuit breakers, you will be billed for the labor to repair or reset the circuit breakers. Cooking or any heat/flame or food preparation is not allowed in the stall area. AUTHORIZED ELECTRICAL APPLIANCES FOR GROOMING PURPOSES MAY BE USED IN DESIGNATED BARN AREAS ONLY. NO UNAUTHORIZED ELECTRICAL APPLIANCES MAY BE USED, OR IF USED, THE APPLIANCES WILL BE CONFISCATED. THE ELECTRICAL SYSTEM MAY NOT BE ALTERED OR TAMPERED WITH UNDER ANY CIRCUMSTANCES.

TBA CLASSES - Adding TBA Classes TBA classes can either be Arabian or HA/AA with the exception of classes that can be combined. Classes can be selected from any AHA class in these divisions: Country English, Equitation, English, Halter, Hunter, Ladies Side Saddle, Native Costume, Reining, Ranch Riding, Show Hack, Western and Walk-Trot. (See www.arabianhorses.org for a list). To activate a TBA class, exhibitor must: 1) Select AHA eligible class 2) Select the TBA Class # in the schedule 3) Email entries@scottsdaleshow.com the class 4) Once class has been added to the schedule, enter and pay for the class on the official entry form. TBA classes will be first-come, first-served; there is no fee to add them, and once all spots have been filled, no other spots will be available. Once the class has been added any exhibitor can enter the class. If TBA classes are not requested, the class number will be canceled and the

next class will follow. Management reserves the right to modify the class title/restrictions to promote competition and prevent one-horse classes.

VETERINARIAN – A vet will NOT be on-site for this one-day show. Veterinarian information will be posted and available in the Show Office.
