Arabian National Breeder Finals High Point Breeder Award

Sponsored by Rae Dawn Arabians

The Arabian National Breeder Finals is the only Arabian Horse Show in the Country that offers an award to breeders of show Champions. The award was created in honor of the show's title, Arabian National BREEDER Finals and has quickly become a valued tradition of the show.



Awards are presented to the breeder of selected Show Champions during the Award Ceremonies. Breeders of the Champions are invited to center ring to receive public recognition of their breeding accomplishment while the owner and handler are receiving their Show Championship Awards.

In addition to the individual Champion Breeder Awards, a High Point award is presented annually to the breeder who achieves the greatest success with horses shown at the ANBF Show. Horses competing will earn points for success in all the show championship classes (*excluding futurity classes*). The High Point breeder (*defined as that breeder listed as such on the original registration papers in the stud book of origin*) that accumulates the greatest number of points with multiple horses attributed to one breeding program in each annual event will be awarded the Arabian National Breeder Finals High Point Breeder trophy.

Breeders are Our Future –

HIGH POINT SCORING SYSTEM - A 10-point descending scale will be used for classes as follows: 10 points for 1st place, 9 points for 2nd place etc. For classes that have fewer than 10 entries, points will be awarded to the winner with a point value equal to the number of horses in the class. For example, if there are 5 horses in the class, 1st place will receive 5 points, 2nd place will receive 4 points, 3rd place receives 3 points, etc. Classes are not to exceed 10 total points. The rule for breaking ties will be as follows: 1. High Point Award to be awarded to the breeder who has won the most Gold Championships. 2. If the tie remains, the Silver Championship awards will be counted. 3. In the event the tie remains, the award will be given to the breeder who has then won the most first place awards in classes of five or more exhibitors. 4. In the event the tie is still not resolved, each tied breeders second place awards will be counted. Classes counted will include Junior & Senior Championships ATH, Championships JTH, Egyptian Heritage Related Championships, Liberty Championship, Weanling, Yearling, Junior & Senior Championships.

Indoor Air-Conditioned Stalls on a first come first serve basis.

Limited to 20 per Trainer. **Sponsors will receive priority.**

Also, Four (4) Performance Trainer Cabanas will be offered
on a first come first serve basis. **Sponsors will receive priority.**

Entries received after the deadline will be charged a \$100/horse late fee. Exhibitors will be allowed to add horses and/or classes BUT all additions must be received in the office, the SESSION PRIOR, to the class in which the horse is being shown. Post entries and added classes will not be listed in the official show program.

TBA CLASS INFORMATION:

TBA classes will be first come, first serve, and once all spots have been filled, no other spots will be available. Performance TBA sponsorships are \$100/class. Show Management does have the right to adjust the name of the TBA class to allow for more potential entries. If a TBA class is added and not entered, the person who added the class will be responsible for paying the sponsorship and entry fee. If there are more than 3 horses entered in a TBA class the sponsor of the TBA class will not be charged. If TBA classes are not requested, the class number will be canceled, and the next class will follow. No prize money or Arabian Breeders Sweepstakes points (*) will be awarded in TBA classes. JTR/Walk-Trot/Jog Classes will not be allowed to fill TBA classes.

SHOW RULES & PROCEDURES

ALL changes and additions to this Prize List will be published on the Arabian Horse Association of Arizona website www.scottsdalshow.com

This Horse Show is conducted in accordance with the Rules of the AHA and USEF, particularly the Arabian Horse Division. The official rulebook for USEF will prevail for this Show unless otherwise specified in this prize list. EVERY CLASS OFFERED HERIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. Each participant in this Show is responsible for knowledge of these rules and is subject to these rules. Any changes or corrections to the rules will automatically become part of this prize list and will be posted online. Questions that may arise that are not covered by either AHA or USEF rulebooks will be decided by the Show Committee and their decisions will be final.

Under Arizona law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risk of equine activities. Pursuant to A.R.S. §12-553

ADHERENCE TO RULES OF CONDUCT - Organizing committee members, show officials, judges, exhibitors, and handlers will unconditionally submit themselves and their accompanying persons to the 'Show Rules of Conduct and Procedures' and will accept the jurisdiction of the United States Equestrian Federation (USEF), the Arabian National Breeder Finals Show Committee (ANBFSC) when enforced. The ANBFSC, USEF, and the USEF Show Steward shall not be liable for any consequence of any decision they may make, **and a zero-tolerance policy for unsportsmanlike behavior will be strictly enforced.** These Rules will be interpreted where necessary under the provisions by such committees. This Show is recognized by USEF and the Arabian Horse Association.

ADMISSION TO RING - There will be an assigned "Order of Go" in all halter qualifying classes **oldest to youngest in all classes.** Due to the changes in USEF rules for Breeding/Halter and In-Hand Competition, the prescribed "Order of Go" must be adhered to. Horses entering the ring in the wrong order or those who have missed entering the arena in the assigned order will be walked into their position in the line by a show official. It is the exhibitors/handlers' responsibility to enter the arena in the posted "Order of Go".

AHA MEMBERSHIP STATEMENT EACH COMPETITOR (This includes at least one recorded owner and all trainers, drivers, riders, halter handlers, coaches, and the person(s) signing the entry blank) in an Arabian Horse Association recognized Arabian division, at the time of entry into a competition, must submit a copy of a valid AHA membership/competition

card, join AHA or pay an AHA single event membership fee per competitor. When an agent signs for the owner at an AHA-recognized competition, both the owner and agent must be members of AHA or pay the AHA single event membership. Single-event membership is not acceptable at AHA regional or national competitions. Exhibitors in walk-trot classes are exempt from AHA membership requirements at qualifying competitions but must have an AHA membership with a competition card at AHA regional and national competitions. Exhibitors in lead line classes or parents/guardians signing for minors are exempt from AHA membership requirements. (BOD 5/12)

AMATEUR STATUS - Every handler having reached their 19th birthday by December 1 must possess a current USEF Amateur card. Only active Federation members may obtain amateur certification; Amateur cards are no longer available for non-members. Any person who enters the show ring in any class without having their USEF Amateur card on file in the show office will be assessed a \$100 fine and will be disqualified from the class. A handler change form will be invalid if the amateur card has not been provided to the show office prior to the class. Combined ownership is not permitted in Amateur Owner classes unless all owners are members of the same family. Leased horses are not eligible for amateur-owner classes.

ATTENDANTS, DUTIES, AND APPEARANCE - All Attendants in charge of horses or assisting with the preparation and showing of the horses will be subject to orders of the Horse Show Manager. All Attendants MUST be suitably and neatly dressed when entering the ring. Exhibitors must be correctly attired for the class, attendees must be neatly dressed, and horses must be properly presented.

BARN CALLS - Barn calls are a courtesy only. Exhibitors must ascertain when and where classes are being judged. Every effort will be made to advise the exhibitor of any changes in the Tentative Schedule. Due to unforeseeable problems with any mechanical device, the public address system and paddock calls over that system must be considered a courtesy. It is the responsibility of the exhibitor to be sure that their horse is at the gate at the prescribed time. Every effort will be made to maintain a working public address system to carry class calls, however, no protest will be upheld, nor will any section or class be changed based on the public address system malfunctions. Exhibitors are responsible for reporting all entries to the Gate attendant before each respective class is called for showing and must enter the ring promptly when called. Remember, the Gate attendant cannot see you; therefore, it is important that you listen carefully and report immediately to the holding area when your class is called. Two-Minute Gate: In collective classes, the gate will close **two (2) minutes** after the first horse enters the ring, or in large classes taking more than two minutes, the gate will be closed after the final horse in a continuous string of horses enters the ring. After the gate is closed, no entry will be allowed unless approved by the Judge or Steward. **No exceptions.**

DISCIPLINE - Exhibitors are warned that any act of discourtesy or disobedience to the officials on the part of the owner, groom, trainer, rider, driver, or member of the family of the person participating in the Show will disqualify the horse from adjudication. The management reserves to itself the right to remove a groom, horse, rider, trainer, or driver from the Show without being liable for compensation or damages. It is a violation of USEF Rules to commit any act or make remarks during the Show that are considered offensive or made with intent to influence or cast aspersions on the judging, and any exhibitor may be barred from the Show for this offense by the Show Committee.

DISQUALIFICATION - Refer to the current USEF Rule book. Any horses doctored in any way artificially, improperly, or unfairly prepared or tampered with before entering the show ring will be disqualified. If it is ascertained that any exhibitor has made or caused to be made any false statement regarding any animal or article exhibited, or if any exhibitor shall attempt to interfere with judges in the performance of their duties, he or she shall be excluded from competing or exhibiting. In case of any horse being disqualified, the winner of the next succeeding prize in the class shall take the prize that has been awarded to such disqualified horse, and the lowest monied prize in the class shall go to the reserve number.

DISPUTE NOT COVERED BY RULES - Should any question or dispute arise not covered in the rules, it shall be referred to the Arabian Horse Association of Arizona Board of Directors, whose decision will be final.

DIVISION OF CLASSES - Classes with 25 or more will be divided into two or more sections (*for example: classes with 25 entries will be divided into 2 classes of 12 & 13 horses*). Classes will be split by the date of birth of the horse. Exhibitors must scratch horses from classes at the horse show office at least 2 hours prior to the start of the session in which the class is to be run - **failure to do so will result in a fine of \$100 per entry. If the classes are split and then scratch down the show committee has the option to combine the classes and run as one class up to approximately one hour prior to the class start.** The show management at any time has the authority to change the split numbers at its discretion.

DRUGS AND MEDICATIONS - The drugs and medication Rule contained in the USEF Rule Book will be enforced. Horses in competition will be subject to examination by a licensed veterinarian appointed by USEF. Said appointed licensed veterinarian, with approval of the USEF, may appoint a technician to perform certain duties under USEF rules. The examination may include physical, saliva, urine, blood tests, or any other test or procedure at the discretion of said licensed veterinarian necessary to effectuate the purposes of this rule. These representatives must be treated with respect. All horses will be charged a drug fee per horse to defray the expenses of drug testing. **CAUTION: REFUSAL TO SUBMIT A HORSE FOR EXAMINATION, WHETHER IN COMPETITION OR NOT, AND TO COOPERATE WITH THE VETERINARIAN AND TECHNICIANS UNTIL THE SAMPLES HAVE BEEN TAKEN CONSTITUTES A VIOLATION AND SUBJECTS THE RESPONSIBLE PERSON TO THE PENALTIES UNDER THE RULES.**

ENTRIES - All entries must be submitted through the official online entry portal designated for this Show at www.ringsideproductionsllc.com. A digital copy of the horse's registration papers must be uploaded at the time of entry. The complete name and address of the registered owner must be provided in the OWNER INFORMATION section of the online form. Farm or stable names may only be used if (1) the farm or stable is the registered owner listed on the horse's registration papers or (2) the farm or stable name is registered with USEF, and the USEF certificate number is entered where indicated. A copy of the Farm/Ranch membership card must also be uploaded with the entry. **A completed W-9 (or W-8 for International Owners) must be submitted at the time of entry.**

The owner, trainer, and rider must each digitally sign the entry form in the appropriate sections. If the owner, trainer, and rider are the same individual, the owner must sign all applicable sections. (A "trainer" is defined as any adult responsible for the care, training, custody, or performance of the horse.) For junior exhibitors, the permission for a minor to show section must be completed, including the junior exhibitor's birth date and a digital signature from a parent or legal guardian.

All entries must be submitted with valid payment. If payment is not processed at the time of entry, a post-entry fee will apply. Once an entry is submitted, the person or farm submitting it is responsible for full payment. **No back numbers will be released until all entries associated with that farm are paid in full.**

ENTRY CLOSING - We are encouraging all entries to be completed (*by midnight*) on August 21st

Entries that are received after August 21st will be accepted with an additional \$100 per horse post-entry fee. An entry is not considered received via email or mail unless a confirmation notice has been verified. Confirmations will be sent once the entry has been processed. If you do not receive a confirmation, please check with the show secretary to ensure your entries have been received. Entries received after the deadline will be charged a \$100/horse late fee. Exhibitors will be allowed to add horses and/or classes, BUT all additions must be received in the office the session before the class in which the horse is being shown. *Post entries and added classes will not be listed in the official show program.*

EXCESSIVE USE OF THE WHIP ON ANY HORSE IN A STALL, RUNWAY, SCHOOLING AREA, SHOW RING, OR ELSEWHERE ON THE COMPETITION GROUNDS BEFORE OR DURING A SHOW BY ANY PERSON CONSTITUTES A VIOLATION AND RENDERS THE OFFENDER SUBJECT TO PENALTY. JUDGES WILL BE EXPECTED TO ENFORCE THIS IN THE ARENA.

GLOBAL CUP CLASSES - The Emirates Arabian Horse Global Cup classes are stand-alone classes and are only open to those horses owned by small breeders. Eligible horses must be registered at birth in the WAHO-recognized studbooks of the United States, Canada and/or Mexico for the EAHGC North American Championship in Scottsdale. Emirates Arabian Horse Global Cup classes will follow USEF/AHA rules, although class conduct will follow ECAHO procedures. Global Cup classes are not recognized by USEF. North American owners who produce more than 15 foals each year during the preceding three years before the show are not allowed to enter their horses. A declaration, confirming the number of bred and registered horses during the last three years, must be signed by the horse owner and must be sent together with the entry form. For more information on the rules and eligibility verification, please see visit the Emirates Arabian Horse Global Cup web page at <https://eahgc.ae/>. Emirates Arabian Horse Global Cup will provide all awards and pay all prize money associated with this program. Global Cup classes will be judged by three pre-selected judges from the halter panel.

HANDLER CHANGE - A \$100 fee will be assessed (per incident) to those exhibitors who do not fill out a handler/rider change form in the show office prior to their class.

HOOF INSPECTION - Random inspection of shoes, pads, and hoof length by appropriate show officials, in the presence of the trainer, may be done at the discretion of the show management. Champion and Reserve Champions may be inspected.

JUDGES - In the event of an illness or failure of a judge to attend the Show or to perform the duties, the Show Committee reserves the right to substitute a Judge for the one who is officially designated in the Premium List, according to current USEF Rules. No contact shall be made with judges during the period of the Show unless accompanied by a member of the Show Committee designated by the Committee for such purpose. Further, no exhibitor shall approach a Judge regarding a decision unless he first obtains permission from the Steward, who shall arrange an appointment with the Judge at a proper time and place. The judges will be available for 15 minutes following the last class of the horse show to review their placements with exhibitors.

JUDGING SYSTEM - All halter classes will be adjudicated using the five-judge comparative system. The scoring systems are explained in detail on the website www.scottsdaleshow.com.

- (a) A call judge will be used in each class
- (b) All halter classes will utilize the five (5) judge system
- (c) Judges may not change class procedure; show management must approve all changes to show procedure.
- (d) Judges will have 3 minutes to do their final walk around, with 30 seconds left there will be a warning, and count-down music will be played
- (e) All horses will be judged independently, and comparatively, judges must not confer

LINE-UP OF CLASSES - Once all judges have placed the class, horses will line up in front of each judge according to their placings. The only classes where horses will not line up in front of the judges are classes with four (4) or fewer horses and the show championship classes.

LOCATION OF CLASSES - Management reserves the right to change the arena location of classes with the proper notification to the exhibitors concerned.

NON-RESPONSIBILITY AND INDEMNITY - All entries are accepted with the understanding that the Arabian Horse Association of Arizona will not be held responsible for any loss, damage, or injury to any horse exhibited or any article of equipment of any kind. All horses shall be under the control and direction of the Show Committee solely at the risk of the exhibitor, who will be responsible for any loss, damage, or injury to any person, animals, or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Arabian Horse Association of Arizona, the City of Scottsdale and the U.S. Bureau of Reclamation against any and all loss, damages and liability thus occasioned, including but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Exhibitors, grooms, handlers, owners, etc., are hereby warned that they may not use any device or conduct that may cause harm to any other person(s), horses, or equipment. **THE SUBMITTING OF AN ENTRY FORM TO THE SECRETARY SHALL CONSTITUTE AN ACCEPTANCE BY EACH PERSON SIGNING THE SAME OF THE PROVISIONS HEREIN SET FORTH.**

NUMBER OF ENTRIES IN A CLASS - Any class with less than three entries may, at the discretion of the Show Committee, be combined with another class or canceled. All information will be posted on the website. Large classes may be divided at the discretion of the show committee (*see Division of Classes*).

PADDOCK RULE - Each exhibitor will be permitted one designated person to assist with the entrance of in-hand horses into the ring. The designated person will be allowed to use only the whip and appendages of the same length as those currently allowed for the individual handling the horse. AR114.2. Show Management will be responsible for providing the whip to be utilized by the designated person, no other whip may be used by the designated person when assisting with the entrance of the in-hand horses. Show Management will create or identify an area with dimensions no greater than 6' by 15', in which the designated person must remain while assisting with the entrance of in-hand horses. The designated person will not be permitted to hit or use other objects, such as trash cans, walls, etc., to make noise. Except for as permitted by AR114.2. Show Management and the USEF Steward(s) are responsible for ensuring the designated person understands the new halter policy and their role. **Should this rule be violated, a warning card may be issued to both the handler and the designated person who initiates this violation. Upon multiple violations, these individuals are subject to penalties, including disqualification.**

PROTEST - A protest must be filed as outlined in the USEF Rules.

REFUNDS - UNDER NO CIRCUMSTANCES WILL ANY FEES, STALL, AND/OR TACK ROOM CHARGES BE REFUNDED TO THE EXHIBITOR. If payments are made with a credit or debit card the convenience fee of 4% will be deducted from any refunded overpayments. Noncompliance of the rules will not be eligible for any refunds.

REFUSAL OF ENTRIES - The Show Management reserves the right to refuse, accept conditionally, or cancel any entries of any exhibitor as stated in the current USEF Rule Book.

REGISTRATION REQUIREMENTS - Horses shown in this Show must have been issued a certificate of Registration from the Arabian Horse Registry of America, Inc. (*or in the case of a foreign entry, have been issued a Competition Visa by the Arabian Horse Registry of America*) and/or the Canadian Arabian Horse Registry and registration applied for and must be entered under their full registered name. All entries must be serviceably sound. A copy of the registration papers showing proof of ownership **MUST** be submitted with the entry form at the time of making entry. In the case of a sale or lease, it is required that a contract of the sale or lease, or a statement from the owner be submitted with a copy of the registration papers. All entries must be in good condition. A PHOTOCOPY OR SCAN OF THE REGISTRATION PAPERS OF EACH HORSE **MUST BE SUBMITTED WITH THE ENTRY FORM.** A FEE OF \$25 WILL BE CHARGED FOR EACH HORSE WITHOUT A COPY SUBMITTED WITH ENTRY. **Weanling entries must have a pending registration number prior to being allowed to show in a class and must have a permanent registration number by the last day of the Show or will be eliminated from the results and will not be eligible for prize money or awards.**

RING PROCEDURES - Any exhibitor using the wrong number or having no number *may* be excused or disqualified from the class at the discretion of the call judge. No whips over six feet long, including the snapper, may be used either inside or outside the ring by the handler or assistant when showing a horse.

SCHEDULE - Show Management reserves the right to change the dates and/or the location of the Show or to cancel the Show altogether. In the event of a cancellation, all entry fees and stall fees will be refunded (office fees are non-refundable). Neither the Show Management nor the Arabian Horse Association of Arizona shall have any liability to any exhibitor, owner, handler, or other person, firm, or corporation because of any change or cancellation of the Show, except for the return of fees as aforesaid.

SCRATCHED CLASSES - A \$100 fee will be assessed (per class) to those exhibitors who do not show up for their scheduled class and have not officially scratched their entry at the Show Office prior to the session. Scratches can be made via email or text; this will be strictly enforced.

SILVER-SIRE FUTURITY - The Silver Sire Breeder Futurity classes are stand-alone classes and are only open to those horses that have been previously approved by Silver-Sire. Silver-Sire Futurity classes will follow USEF/AHA rules; however, these classes are not recognized by USEF. For more information on the rules and eligibility verification, please see the Silver Sire website at www.silversire.com. Silver-Sire Futurity will provide all awards and pay all prize money associated with this program.

SOUNDNESS - Horses must be serviceably sound i.e., the horse must not show evidence of lameness, broken wind, or complete loss of sight in either eye. (See USEF General Rules) Horses with loss of sight in one eye may not compete in halter/breeding classes. Horses that appear to be lame will not be placed by the judges; judges will excuse lame horses from the ring.

STABLING RULES - Each horse must be assigned a separate stall and must be entered in the Show. Only manure must be placed in areas designated, violators caught placing anything other than manure and shavings in designated areas will be fined according to USEF rules. **ALL SHAVINGS MUST BE PURCHASED FROM THE ON-SITE APPROVED VENDOR. Violators are subject to a fine and/or removal from the grounds.** Horses must be placed in stalls assigned and no changes will be permitted except by the express consent of the Barn Manager. Decorations to the front of stalls cannot extend more than 6'. By order of the Fire Marshal, all aiseways between stalls must remain open. All materials used for decorative purposes must be treated with flame-proofing and approved by the Fire Department. The use of electric, open flame, or space heaters is prohibited. If you overload the electric circuit with extra lighting and blow-out circuit breakers, you will be billed for the labor to repair or reset the circuit breakers. Cooking or any heat/flame or food preparation is not allowed in the stall area. AUTHORIZED ELECTRICAL APPLIANCES FOR GROOMING PURPOSES MAY BE USED IN DESIGNATED BARN AREAS ONLY. NO

UNAUTHORIZED ELECTRICAL APPLIANCES MAY BE USED, OR IF USED, THE APPLIANCES WILL BE CONFISCATED. THE ELECTRICAL SYSTEM MAY NOT BE ALTERED OR TAMPERED WITH UNDER ANY CIRCUMSTANCES. It is important that you read the rules as the Scottsdale Fire Departments has informed us that in 2025, they will be enforcing City of Scottsdale fire safety rules at the show which includes but is not limited to: Fire Department Connections (FDC) at the front of the barns must be accessible, ceilings must use a Melt Out Material (information in rules) and no sleeping in the barns will be tolerated see rules for additional information. Stalls must be vacated in their original condition. STALLS MAY NOT BE STRUCTURALLY ALTERED IN ANY WAY. DO NOT PUT NAILS INTO STALL WALLS. Exhibitors will be financially responsible for damage to their stalls and/or labor costs for removing materials used for stall decorative purposes. Damage, labor, and replacement costs will be billed to the exhibitor at the current WestWorld fee schedule. NO SMOKING IN THE BARN AREA. Indoor Stalls will be available on a limited first come first serve basis (20 per trainer) at a cost of \$250/stall. Priority will be given to patrons.

STABLING MOVE IN/OUT - All stalls will have stall doors. The fee for an outdoor box stall is \$150, and an indoor box stall is \$250, NO PRORATION. NO STRAW IS ALLOWED. Outdoor and Indoor Stalls will be available at 8:00 a.m. on Tuesday prior to the start of the Show, and must be vacated on Sunday by 6:00 am. Early move-in for Outdoor Stalls may be approved on Monday at 3 pm depending on the barns being ready for occupancy if so the early move-in price will be an additional **\$50/stall**. Early move-in fees will apply to anyone bringing horses, tack, bedding, or any other items into the stalls prior to the official move-in time. **According to Westworld's policy, a stall is considered occupied if anything at all is placed inside it.** There is no Early move-in for Indoor Stalls.

STRESS - Horses shall not be punished unnecessarily or severely anywhere on the show grounds. Excessive whipping, excessive stimulation by noise or intimidation, use of electrical shock devices, or infliction of pain by any means is forbidden in all parts of the showground, or stable areas, at all times. A committee has been established to patrol the showgrounds and abuse will be dealt with under USEF rules. All horses artificially, improperly, or unfairly prepared or tampered with before coming into the show arena will be disqualified. The use of any substance to induce temporary heat will not be allowed. If it is ascertained that an exhibitor has made, or caused to be made, any false statements regarding any animal or article exhibited, or if any exhibitor shall attempt to interfere with the judge in the performance of his/her duties, they shall be excluded from competing or exhibiting. In order to lessen stress on horses, grooms will be requested to leave the hitching ring prior to the entry of each halter class. There will be NO flapping of towels, rattling of cans or bottles, or chasing of horses into the ring.

USEF CARDS - It has been resolved that owners, trainers, and handlers must provide a photocopy of their current USEF membership card with their entry form. Anyone not having a USEF card must join prior to the start of the show. The Show Secretary cannot accept membership applications.

USEF MEMBERSHIP - Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) headline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

USEF PARTICIPANTS - USEF thanks you for participating in this competition and your support of USEF's continuous efforts to provide the safest environment possible for our athletes and other participants. Strategies for safeguarding athletes continue to evolve, and we are fully committed to keeping pace with best practices. The purpose of this letter is to remind you that you are bound by the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and Minor Athlete Abuse Prevention Policies, also known as the MAAPP. This includes the SafeSport Training requirement for adult members and participants who have regular contact with or authority over minor athletes. Additionally, please be reminded about reporting obligations. Any concerns that are non-sexual in nature, including physical and emotional misconduct and MAAPP violations, please use the USEF Safe Sport Incident Reporting Form available on the USEF website. Concerns or suspicions regarding sexual misconduct must be reported to <https://safesport.i-sight.com/portal> and the authorities if a minor is involved. All of this information can be found in the USEF Safe Sport Policy. Please take a moment to review the new USEF Safe Sport web pages on the USEF website to find comprehensive resources regarding USEF Safe Sport efforts. Thank you for your support and for helping us bring the joy of horse sports to as many people as possible! Exhibitors who do not have a current valid USEF card on file in the show office prior to their class will be assessed a \$100 fine and will be disqualified from the class.

CLASS SPECIFICATIONS

A/HA/AA CHAMPIONSHIP PLEASURE CLASSES – Classes are open to Purebred, Half-Arabian, and Anglo-Arabians. These classes are not sanctioned by AHA. Classes shall be run in accordance with USEF rules in AR-5 as designated by class title in accordance with Ladies & Gentlemen class specifications (Hunter-AR142.3, Western-AR146.3). A/HA/AA Saddle Seat Pleasure will be conducted in accordance with USEF AR138.3.

AGE OF HORSES - For horse show purposes any horse shall be one year old on the first day of January following the actual date of foaling.

AMATEURS - Every rider having reached their 19th birthday by December 1 must possess a current USEF Amateur Certification or be eligible for and have made an application for one to the Competition Secretary. Only active Federation members may obtain amateur certification; Amateur cards are no longer available for non-members. Amateurs who do not have proper USEF cards on file in the show office prior to their class will be assessed a \$100 fine and will be disqualified from the class.

BREEDERS CLUB CLASSES - The Breeders Club classes are only open to horses that have been nominated into the Breeders Club (BC) program prior to birth. BC classes are unrated by the USEF and not sanctioned by AHA. The class procedure for the BC halter classes will have these exceptions to the USEF rules: Horses will enter the arena in hand at a trot, guiding in a counterclockwise direction. Each horse shall trot in one at a time and shall proceed at the trot until reaching its designated position in line as directed by the ringmaster. The judges and show management, at their discretion, may omit the walk on a loose rein from the BC halter classes. For more information on this program, visit our website at www.scottsdalshow.com

CHAMPIONSHIP CLASS QUALIFICATIONS (Halter) - First & Second place winners in designated qualifying classes will be eligible to show in the indicted championship class. See class qualifications for more information on which classes qualify for each championship.

CLASS CONDUCT QUALIFYING CLASSES - Horses shall enter the ring at a trot in a counter-clockwise direction in chronological age order from oldest to youngest. Following the trot into the arena, each entry shall proceed to the far end. All entries **MUST** remain at the designated area while the other horses enter the arena. Once all horses have entered the arena horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster, horses will be reversed and walk in the second direction back into their place on the rail. At the conclusion of the collective walk, horses will be presented to the judges in the center ring; once the individual presentation has been completed the horse will trot off and resume their place on the rail. After all horses have been presented in the center ring there will be a 3-minute final review of the horses on the rail (it is not mandatory that the judges do a final review).

CLASS CONDUCT CHAMPIONSHIP ATH CLASSES - Horses shall enter the ring at a trot in a counter-clockwise direction in chronological age order from oldest to youngest. Following the trot into the arena, each entry shall proceed to the far end. All entries **MUST** remain at the designated area while the other horses enter the arena. Once all horses have entered the arena horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster, horses will be reversed and walk in the second direction back into their place on the rail. At the conclusion of the collective walk, horses will be presented to the judges in the center ring; once the individual presentation has been completed the horse will trot off and resume their place on the rail. After all horses have been presented in the center ring there will be a 3-minute final review of the horses on the rail (it is not mandatory that the judges do a final review).

CLASS CONDUCT HA/AA, SSS & BC Futurity Classes - Horses shall enter the ring at a trot in a counter-clockwise direction in chronological age order from oldest to youngest. Following the trot into the arena, each entry shall proceed to the far end. All entries **MUST** remain at the designated area while the other horses enter the arena. Once all horses have entered the arena horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster, horses will be reversed and walk in the second direction back into their place on the rail. At the conclusion of the collective walk, horses will be presented to the judges in the center ring; once the individual presentation has been completed the horse will trot off and resume their place on the rail. After all horses have been presented in the center ring there will be a 3-minute final review of the horses on the rail (it is not mandatory that the judges do a final review).

CLASS CONDUCT JUNIOR & SENIOR CHAMPIONSHIP CLASSES - Horses shall enter the ring at a trot in a counter-clockwise direction in chronological age of the classes from oldest age class to youngest aged class. Following the trot into the arena, each entry shall proceed to the far end. All entries **MUST** remain at the designated area while the other horses enter the arena. Once all horses have entered the arena horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster. At the conclusion of the collective walk, horses will line up with all first-place horses in the front row closest to the north and second-place horses in the same class in the second in line beside the first-place winner of the same class. Each judge will then rank the horses in order of preference on his/her card - **The Champion is required to be selected from those horses placed first in the qualifying classes** (class winners), silver and bronze placed horses can come from any placing. Only first and second place horses are qualified to progress forward into the championship classes.

CLASS CONDUCT OPEN WEANLING CLASSES - Weanlings are welcome to enter and be presented in this class with their Dams in chronological age order from oldest to youngest. Horses have the option to enter the arena at a walk or trot and will move in a counterclockwise direction. Once all horses have entered the arena, horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster. Horses will be reversed and walk the second direction back into their place on the rail. At the conclusion of the collective walk, horses will be presented to the judges in the center ring; once the individual presentation has been completed, the horse will trot off and resume their place on the rail. **A TRADITIONAL HALTER STAND-UP OF WEANLINGS WILL NOT BE TOLERATED, and handlers cannot stand in front of their horse. NO WHIPS OR LIVE CHAINS** will be tolerated in this class; using either in this class will result in expulsion from the ring. There will be no final review/walk the line for evaluation by the judges. **Handlers may show more than one horse** in this class but must provide a second handler to take over the handling of the horse after the center ring presentation. The second handler will wait in the designated area and control the horse until the end of the class.

CLASS CONDUCT AOTH WEANLING CLASSES - Weanlings are welcome to enter and be presented in this class with their Dams in chronological age order from oldest to youngest. Horses have the option to enter the arena at a walk or trot and will move in a counterclockwise direction. Once all horses have entered the arena, horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster. Horses will be reversed and walk in the second direction back into their place on the rail. Horses will stay on the rail, and the judges will walk as a group around the rail to evaluate the horses. **A TRADITIONAL HALTER STAND-UP OF WEANLINGS WILL NOT BE TOLERATED;** handlers cannot stand in front of their horses. **NO WHIPS OR LIVE CHAINS** will be tolerated in this class; using either in this class will result in expulsion from the ring.

CLASS CONDUCT YEARLING CHAMPIONSHIP CLASSES - In the Yearling Championship class a total of 10 yearlings will be pulled forward from the qualifying class(es), if 2 sections are held 5 from each section will be pulled forward and if only one section is held 10 will be pulled forward to the championship. Horses shall enter the ring at a trot in a counterclockwise direction in chronological age of the classes from oldest to youngest. Following the trot into the arena, each entry shall proceed to the far end. All entries **MUST** remain in the designated area while the other horses enter the arena. Once all horses have entered the arena, horses will walk counterclockwise in a controlled manner at the instruction of the ringmaster. At the conclusion of the collective walk, horses will line up in 2 rows in age order. This is a new class, and all horses will be judged. Each judge will then rank the horses in order of preference on his/her card.

EGYPTIAN HERITAGE RELATED CLASSES (EGYPTIAN ARABIAN CLASSES) - The Egyptian Heritage Classes are open to any horse whose pedigree is verifiable at least **25% - at least one of the four grandparents must be categorized as Straight Egyptian**. It is the responsibility of the owner and/or trainer submitting the entry to validate eligibility. If you are unsure, please submit an inquiry, and a verification of your horses' eligibility will be reviewed by the Show Committee. Horses not eligible will be disqualified from the class.

FREESTYLE LIBERTY - The ideal liberty horse is brilliant, confident, and has an Arabian type while performing with a look-at-me attitude. Ultimately the liberty horse should have great expression and is exciting to watch perform loose in the arena. Horses are to give a brilliant performance with style and presence while making use of the entire arena. If an individual horse is average or below average for a single criterion, please only deduct it from its score in that particular criterion. Judges are required to consider each category of the performance equally. Each individual criterion will be given a score from 1-10 with 10 being the highest. Freestyle Liberty is not to be judged solely on the individual's trot. Some horses may trot very little but will still exhibit type, animation, and presence while giving a brilliant performance. Judging criteria/categories:

1) Arabian Type 2) Animation & Charisma 3) Movement 4) Use of Arena 5) Crowd Participation **FREESTYLE LIBERTY RULES**- Open to purebred Arabian horses only. Horses must be shown without tack, equipment, artificial appliances, or appendages. A two-minute time limit will be allowed for each horse in the championship final round for the horse to perform at Freestyle Liberty. Time and music will start when the halter is removed. Time will expire at the signal of the timekeeper; at this time, handlers have two minutes to retrieve the horse, or it will be eliminated from the class. No more than two handlers per horse are allowed in the ring at one time. Handlers will lead the horse to the designated marker. While at liberty, the horse may perform at any gait; horses may perform tricks within their 2-minute time at liberty to count towards their overall performance score. Handler(s) shall not touch the horse with a whip or ride the horse at any time from entrance into the show ring until after the expiration of the time limit. The use of a standard halter show whip is allowed. Each entry will furnish music for their performance; the music must be marked with the horse's name and entry number. If no music is supplied, the Show reserves the right to select the music. Five judges will score each horse. The scoring system is from 1-10 in five categories: Arabian type, animation and charisma, movement, use of the arena, and overall performance, with a possible high score of 50. These classes are not AHA or USEF-recognized or approved classes. The Show Committee shall handle all disputes and inquiries, and their decision shall be final.

RAE DAWN ARABIANS HIGH POINT BREEDER AWARD SCORING SYSTEM - A 10-point descending scale will be used for classes as follows: 10 points for 1st place, 9 points for 2nd place, etc. For classes that have fewer than 10 entries, points will be awarded to the winner with a point value equal to the number of horses in the class. For example, if there are 5 horses in the class, 1st place will receive 5 points, 2nd place will receive 4 points, 3rd place will receive 3 points, etc. Classes are not to exceed 10 total points. The rules for breaking ties are as follows: 1. A High Point Award will be awarded to the breeder who has won the most Gold Championships. 2. If the tie remains, the Silver Championship awards will be counted. 3. In the event the tie remains, the award will be given to the breeder who has then won the most first-place awards in classes of five or more exhibitors. 4. In the event the tie is still not resolved, each tied breeder's second-place award will be counted. Classes counted will include Arabian National Breeder Finals: Junior & Senior Championships ATH, Championships JTH, Egyptian Heritage Related Championships, Straight Egyptian Championships, Liberty Championship, Weanling, Yearling, Production Mares 4 & Over, and Junior & Senior Championships.

PRODUCTION MARE - This class is open to broodmares that are 4 years of age & over. Eligible entries must meet the following minimum requirements: Mare must have carried, delivered, and nursed at least one (1) foal. Mare MAY be nursing a foal at the side at the time of showing.

SCOTTSDALE SIGNATURE STALLION HALTER CLASSES - The Scottsdale Signature Stallion (SSS) classes are only open to horses that have been nominated into the SSS program. The class procedure for the SSS halter classes will have these exceptions to the USEF rules: Horses will enter the arena in hand at a trot, guiding in a counterclockwise direction. Each horse shall trot in one at a time and shall proceed at the trot until reaching its designated position in line as directed by the ringmaster. The judges and show management, at their discretion, may omit the walk on a loose rein from the SSS halter classes. At the conclusion of the collective walk, horses will be presented to the judges in the center ring; once the individual presentation has been completed, the horse will trot off and resume their place on the rail. After all horses have been presented in the center ring there will be a 3-minute final review of the horses on the rail (it is not mandatory that the judges do a final review). ATTENDANTS, DUTIES, AND APPEARANCE - All Attendants in charge of horses, or assisting with the preparation and showing of the horses, will be subject to orders of the Horse Show Manager. All Attendants MUST be suitably and neatly dressed when entering the ring. Exhibitors must be correctly attired for the class, and Attendants be neatly dressed and horses properly presented.

AWARDS - Halter/Breeding Classes: **Qualifying classes** will award 1st Place, 2nd Place, and Top 10. Awards will be offered to 50% of the class based on class entries in the class at the time of showing unless there are only 2 horses in the class; both horses will be awarded. **Supreme Championship classes** Yearling, Junior and Senior, ATH, and Gelding Championships will award Gold Champion, Silver Champion, Bronze Champion, and Top 10. Championship classes Half-Arabian/Anglo-Arabian (HA/AA) In-Hand, Breeders Club & Scottsdale Signature Stallion will award Champion, Reserve Champion, and Top 10. Rae-Dawn Arabians Breeder Awards will be presented to the breeder in each designated class (*excluding Futurity classes*), and an overall high point breeder of the Show will be presented. **Prize Money will be paid out to 50% of the class at the time of showing (exception Yearling, Junior & Senior championship class, and futurity classes).** **Performance Classes:** Qualifying classes will award 1st-6th Place; ribbons will only be awarded. No prize money will be paid out in performance classes, except as otherwise listed. **A/HA/AA Championship Classes** will award Gold Champion, Silver Champion, Bronze Champion, and Top 10. **Prize money will not be paid out in classes that have 3 or fewer horses in the class.**

COGGINS, HEALTH CERTIFICATE & VACCINATIONS - Mandatory for all horses coming onto the WestWorld property as per Arizona state law: All horses six (6) months of age and older require a negative Coggins (*dated within the previous twelve months*) and a Health Certificate for all horse originating outside of Arizona. Coggins, Health certificate, and Vaccinations must match the horse being entered into the Show and must include a complete description of the horse, that the horse is coming to the Show, and give the location of the return trip. Horses will not be permitted on the WestWorld property without the submission of a Coggins and health certificate (for horses from outside of Arizona). Equine Vaccination Rule 1. At Federation-licensed competitions, horses more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhino pneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines, and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. BOD 1/17/15 Effective 12/1/15. Horses caught on the property without necessary paperwork will be asked to leave the grounds and will not be given a refund of any fees. **PLEASE SUBMIT A COPY OF THE PAPERWORK WITH ENTRIES AND HAVE THE ORIGINAL COPY WITH YOU AS INSPECTIONS WILL BE DONE.** Back numbers will not be released until the show office has a copy.

COMMERCIAL EXHIBITORS - Fee \$400. This amount is for an area of approximately 10ft. x 10ft. Set-up may begin at 2:00 p.m. Tuesday, September 14th, and be totally complete by 8 a.m. Wednesday, September 15th. The Exhibitor will not dismantle the display until the last class has been completed on Saturday evening. The display must be removed entirely by midnight on Saturday, September 19th. AHAA will not be responsible for merchandise or display on the grounds prior to, during, or preceding the show. FIRST AID - First aid treatment will be available during all performances.

FOOD SERVICE - Food service will be available on the competition grounds throughout the event. Under Arizona law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risk of equine activities. MOTORIZED VEHICLES - Minors who do not have a valid driver's license that allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule is solely responsible for any damages, claims, losses, or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that does not require a driver's license to operate, including but not limited to Segway's, hover boards, and single wheeled scooters is prohibited on competition grounds. Prize money will be mailed within 30 days after the show. **Prize checks not presented for payment within 180 days of issuance will be void, and all prize money will be forfeited.** The Social Security or Federal Tax ID number of the registered owner must be on file with AHAA before prize money is released. Every year AHAA must have a new W9 or W8 form on file for all owners to receive prize money. SECURITY - Exhibitors are advised that it is their responsibility to secure all their valuables while on the show grounds. AHAA will not be responsible for lost or stolen items. No security will be provided by the Show.

SHARPS CONTAINERS - Trainers, owners, exhibitors, or agents are advised that improper disposal of needles or other sharp disposable instruments will result in fines of \$100 per occurrence.

SHOEING REGULATIONS - Refer to the current USEF Rule Book.

SHOW OFFICE HOURS - The Horse Show Office will be open Tuesday, September 15th: 10 am – 5 pm, each day of the Show the office will be open one hour before the first scheduled class and close 30 minutes following the last class of the day.

STABLING - All stall assignments will be made at the discretion of the Show Committee. Approximately 1000 stalls with doors will be available; horses entered after the available stalls are filled cannot be guaranteed stalls. All stalls are permanent, 10' x 10' in dimension. **ONLY HORSES ENTERED IN THE SHOW WILL BE ASSIGNED STALLS.** This rule will be strictly enforced, and a fine of \$500 will be assessed to all trainers/owners who bring horses onto the grounds that are not entered into the Show. Outdoor Stalls for the duration of the Show will be available for \$150; Indoor Stalls will be available on a limited first come first serve basis, for \$250, patrons will receive priority. Day stalls will be \$75/day (*Horses using the stall for more than one day will be charged \$150*). A **\$50 charge per horse** will be charged if it is not assigned a stall on the showgrounds.

TBA CLASSES - Classes can either be Arabian or HA/AA. Classes can be selected from any AHA class in these pleasure divisions: Country English, English, Hunter, Ladies Side Saddle, Native Costume, and Show Hack. To activate a TBA class, the exhibitor must select an AHA-eligible class, select the Class # where you would like the TBA in the schedule, and **email the show secretary to schedule the class** entries@scottsdaleshow.com. Do not just put it on your entry form until you have reserved the class as indicated above. Once the class has been added to the schedule, you will be able to enter and pay the sponsorship fee of \$100 for the class on the official entry form. **TBA classes will be first come, first serve, and once all spots have been filled, no other spots will be available.** Performance TBA sponsorships are \$100/class. Show Management does have the right to adjust the name of the TBA class to allow for more potential entries. If a TBA class is added and not entered, the person who added the class will be responsible for paying the sponsorship and entry fee. If there are more than 3 horses entered in a TBA class the sponsor of the TBA class will not be charged. If TBA classes are not requested, the class number will be canceled, and the next class will follow. No prize money or Arabian Breeders Sweepstakes points (*) will be awarded in TBA classes. JTR/Walk-Trot/Jog Classes will not be allowed to fill TBA classes.

VETERINARIAN - An official Show Veterinarian will be available on the grounds from the start of the first class of the day to the end of the last class each day. Veterinarian information will be posted and available in the Show Office. All horses are subject to a physical inspection, free of charge, by the Show Veterinarians as a safeguard against communicable diseases. AHAA also reserves the right to request a postmortem examination by the Show Veterinarians, free of charge, on any horse that dies on the showgrounds.

WITHDRAWING ENTRIES - After the Close of Entries, horses may be scratched from the Show at the owner/trainer's direction. UNDER NO CIRCUMSTANCES WILL ANY FEES OR STALL AND TACK ROOM CHARGES BE REFUNDED TO THE EXHIBITOR.
