

## Treasury Prime Privacy Policy

This Privacy Policy was last updated on November 11, 2025.

Treasury Prime Inc. (“Treasury Prime”, “we” or “us”) respects your privacy and are committed to protecting it through our compliance with this policy. This Privacy Policy describes the type of information we may collect from you or that you may provide in connection with the use of the website, <https://www.treasuryprime.com/> (our “Website”) and all related services (collectively the “Services”), and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Privacy Policy applies to the information we collect:

- On our Website.
- In email, text, and other electronic messages between you and this Website.
- Offline, such as through telephone support calls.

This Privacy Policy does not apply to:

- Information collected by any third party, including through any application or content (including advertising) that may link to or be accessible from or through the Website.
- Third party websites that are linked through our Website. We do not control the content or practices that appear on these sites and are not responsible for Websites linked to or from our Website.
- Information received by us in our role as a bank service provider.

## **1 Information we collect and how we collect it**

We collect several types of information from and about uses of our Services, including information:

- By which you may be personally identified, including but not limited to a first and last name, physical or email address, phone number or any other identifier that could reasonably be linked, directly or indirectly, to you as an individual (“Personal Information”).
- That is about you but individually does not identify you; and/or
- About your internet connection, the equipment you use to access our Services, and usage details.

We collect this information:

- Directly from you when you provide it to us.
- Automatically as you navigate through the Website. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.
- From third parties, for example, our business partners.

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking). This Website does not respond to do not track signals.

The information we collect automatically may include Personal Information, or we may maintain it or associate it with Personal Information we collect in other ways or receive from third parties. It helps us to improve our Services, including by enable us to:

- Estimate the numbers and frequency of visitors to the Service and individual web pages on the Service.
- Store information about your preferences, allowing us to customize our Services according to your individual interest.
- Speed up our searches.
- Recognize when you return to Website.

We use cookies to collect information regarding your use of the Service. A cookie is a small string of data that often includes an anonymous unique identifier sent to your browser from a website’s computers, and stored on your computer’s hard drive. You can adjust your browser

settings to accept all cookies, refuse all cookies, or to notify you when a cookie is being placed on your hard drive. For information about managing your privacy and security settings for cookies, see Choices about how we use and disclose collected information.

## **2 How we use collection information**

We use information gathered through the Service for the following general purposes:

- To provide the Services to you.
- To fulfill your requests for information or services,
- To fulfill any other purpose for which you provide it.
- To improve the Service and other products and services offered by Treasury Prime or its affiliates.
- To contact you regarding the Service or other products and services offered by Treasury Prime or its affiliates, conduct research.
- In any other way we may describe when you provide the information.
- For any other purpose with your consent.

## **3 Sharing and collection of information**

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose Personal Information that we collect or you provide as described in this Privacy Policy:

- To our contractors, service providers, and other third parties we use to support our business.
- To a buyer or other successor if we are acquired by or merged with another company, in which Personal Information held by us about our users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provided the information.
- With your consent.

We may also disclose your Personal Information collected through the Service:

- If we believe it is necessary in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction
- To enforce or apply our Terms of Service.
- To protect and defend our rights and interests and those of our users.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.

## **4 Choices about how we use and disclose collected information**

We strive to provide you with choices regarding the Personal Information you provide to us. We have created mechanisms to provide you with the following control over your information:

- **Tracking Technologies.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly.
