3-DAY NOTICE OF INTENT TO FILE AN APPLICATION

NY North Country, LLC (North Country), a wholly-owned subsidiary of Terra-Gen, LLC, is proposing to construct a major electric generating facility, under Article VIII of the New York State Public Service Law (Article VIII). This notice announces that on or about February 13, 2026, North Country intends to file an Application with the Office of Renewable Energy Siting and Electric Transmission (“ORES” or the “Office”), pursuant to Article VIII seeking a Siting Permit from the Office authorizing the construction and operation of the Facility. The Article VIII process has been implemented by rules enacted by the Office and establishes a review process with uniform standards and conditions for all renewable energy projects. The uniform standards and conditions are available at 16 NYCRR 1100-6 and <https://dps.ny.gov/ores>.

The North Country Wind Project is a 360-megawatt (MW) wind-powered electric generating facility proposed to be located in the Towns of Bellmont, Burke, and Chateaugay in Franklin County, and the Town of Clinton in Clinton County, New York (the “Facility”). The purpose of the proposed Facility is to generate wind-powered electricity that will provide a significant source of renewable electricity to the New York State power grid. Under the 2019 Climate Leadership and Community Protection Act, New York State has committed to generating all electricity from renewable sources by 2040. The proposed Facility will help New York achieve that mandate. The Facility will include the installation and operation of up to 80 wind turbines, together with the associated electrical collection lines (below ground and overhead), access roads, meteorological towers, operation and maintenance (“O&M”) building, and collector substation. North Country may also construct a new point of interconnect (“POI”) switchyard and 345-kV high-voltage loop-in and loop-out transmission lines (“New York Power Authority Facilities”) adjacent to its collector substation. Upon completion, the ownership of these New York Power Authority Facilities will be transferred over to New York Power Authority.

Please note, this notice reflects a change in project layout from the October 23, 2025, 60-Day Notice of Intent to File an Application, reducing the project from 364.5 MW to 360 MW.

Upon filing the Application, North Country will provide funding in the amount of \$360,000 to be deposited into a local agency account to be made available to local agencies and potential community intervenors for the purpose of contributing to a complete record leading to an informed permit decision as to the appropriateness of the site and the facility, and for local agencies, shall include the use of funds to determine whether a proposed facility is designed to be sited, constructed and operated in compliance with applicable local laws and regulations.

Any local agency or potential community intervenor shall submit a request for initial funding within thirty (30) days of the date of application filing and such requests can be made to: the Office of Renewable Energy Siting and Electric Transmission, Attn: Request for Local Agency Account Funding, Empire State Plaza, Agency Building 3, Albany, NY 12223.
