#### 1. Call to Order

The meeting was called to order by Andrew Trelease (CCRFCD). A quorum was present.

#### 2. Comments By the General Public

3. **Action to approve the agenda (*For possible action*)**

The agenda was approved.

4. **Action to approve the minutes of the August 12, 2025 meeting (For possible action)**

The meeting minutes from the August 12, 2025 SQMC meeting were approved.

5. **Receive an update on the implementation of the new MS4 permit and the draft revised Stormwater Management Plan (for discussion only)**

John Tennert (CCRFCD) reminded the SQMC that the Las Vegas Municipal Separate Storm Sewer System (MS4) permit became effective on February 5, 2024 and the Permittees are required to submit a revised stormwater monitoring plan to the Nevada Division of Environmental Protection (NDEP) for review within 18 months of the issuance of this permit. The revised SWMP is being revised with the Permittees via discussion with NDEP. The main comments remaining to be resolved include final stabilization and notification to contractors that they are required to have coverage under a construction general permit. The draft revised SWMP is anticipated to be submitted to NDEP in November 2025.

6. **Receive a presentation on the Las Vegas Valley NPDES MS4 Permit 2024-2025 Annual report (for discussion only)**

John Tennert (CCRFCD) presented on the Las Vegas Valley NPDES Municipal Stormwater Discharge Permit – 2024-2025 Annual Report. The presentation included the area of coverage for the Permit, public outreach and education, stormwater management approach, monitoring program, MS4 maintenance program, post-construction program for new development and significant redevelopment, illicit discharge detention and elimination program, industrial facility monitoring and control program, construction site program, evaluation of characterization data, and staff and resources. The presentation included the status of the MS4 program and what was submitted to NDEP and EPA for the 2024-2025 permit year. The Annual Report requirement in the MS4 Permit was

satisfied, and the program goals were achieved. NDEP is anticipated to provide comments within a few months following submission of the Annual Report.

  - h. Annual expenditures for the reporting period, with a breakdown for the major elements of the SWMP, and the budget for the year following each Annual Report

Andrew Trelease (CCRFCD) shared that the Permittees submitted quarterly reports and are on track to meet the MS4 permit goals. It was also noted that with the approval of the SWMP an updated spreadsheet will be provided.

8. **Discuss monitoring activities and issues and take action as deemed appropriate (*For possible action*)**
  - Dry weather monitoring
  - Wet weather monitoring

Angela MacKinnon (Brown and Caldwell) reported that wet weather sampling was conducted at both sites and that results are expected to be received soon and will be presented at the next SQMC meeting. Denis Cederburg asked whether stormwater quality has changed as a result of homelessness. Angela responded that it is difficult to determine based on the current sampling locations. Historically when sampling was performed for all tributaries, most of the detected bacteria contributions were from avian sources, not human sources.
