

## **WHO WE ARE**





## **OUR STORY**

We are a group of professionals who have worked together to build an organization imploring young people to work with the community to help strengthen the refugee and immigrant population through unity and integration.

Founded in December 2015, we embarked on a journey to reestablish the way nonprofits work, and strengthen the communities they are involved with. We believe that modern-day obstacles require modern day solutions, thus the creation of The Refugee Centre and its sister nonprofit DevBloc.

### 2015

We made The Refugee Centre official by registering it in Quebec as a Non-Profit Organization.

### 2016

We secured a location in the heart of downtown Montreal to provide our services.

### 2017

Our services were running at full capacity and we were noticed by the UNHCR, the largest refugee organization in the world. We then received a visit from the High Commissioner Fillipo Grandi himself.

### 2018

Our work became nationally recognized and we were invited to the House of Commons of Canada to speak about our accomplishments.

### 2019

We were given an award by the national body of best resettlement practices, Pathways to Prosperity, an entity funded by the government of Canada to recognize best practices in the field.

### 2020

We expanded our services and added a mental health and wellness sector, made possible due to a collaboration with the Canadian Red Cross.

### 2021

We used our community fund to expand our legal clinic in order to respond to the growing demand and needs of our clients.

### 2022

We launched our Beyond the Big City program and began our journey to other parts of Canada. Additionally, thanks to two generous donors, we were able to create our "Pay It Forward" basic needs fund to help our clients with everyday necessities such as transportation, food, rent and more.

### 2023

We launched our transitional housing program and expanded our advocacy service to help develop better refugee policy in Canada.

### 2024

We significantly increased our community engagement, expanded our housing project to support more newcomers, and strengthened our commitment to advocacy for refugee rights and integration. Our efforts continue to work towards a more inclusive and supportive environment for those seeking refuge.

### **CREATIVITY**

We are made up of engineers, political scientists, human relations experts, sociologists, statisticians and entrepreneurs. We believe this makes us one of the most unique and creative groups in this field.

### **HARD WORK**

In addition to our creativity, we work had to ensure that the support we provide to our clients is holistic and sustainable.

### INNOVATION

Aside from the typical language integration services offered by the majority of NGOs, we created a one-of-a-kind economic integration and development incubator.

To create long-lasting, self-sustainable, and creative solutions to refugee integration.




### **OBJECTIVES**






## RESETTLEMENT & INTEGRATION

### RESETTLEMENT & INTEGRATION



### **ORIENTATION**

Delivering workshops and one-on-one appointments to help clients adapt to their new environment, navigate public services, including accessing language classes, obtaining social insurance numbers, applying for social assistance, obtaining a driver's license and much more.





The Health and Wellness Department oversees the general health-related and social activities & workshops. The department also oversees all client case management clients followed at the centre. Composed of five permanent members, the H&W team also welcomes: Art therapy interns from Concordia University, Nursing Students from McGill University, and social work students from Dawson College.



The H&W Department has been strengthening its ties within the Peter McGill Community, Canadian Red Cross, Moisson Montreal, Monthly Dignity, McGill University, Dawson College, Public Health Agency of Canada, Doctors of the World, as well as, other health professionals, including family physicians, physiotherapists, nurses and others.



### **CASE MANAGEMENT**

The case management system ensures quality client care by pairing clients with caseworkers based on language and urgency. This approach offers psychosocial support while addressing legal, social, and health priorities of each client.

### **BASKET OF BASIC NEEDS**



In partnership with Moisson Montreal, this program provides access to essential food items for families and individuals and presents a critical intervention that addresses food insecurity and supports the well-being of our community members.



### **ACCESSING HEALTHCARE WORKSHOPS**

### **Logistics & Documentation**

This workshop is aimed at easing the transition for newcomers into the Canadian healthcare system. Through this workshop, we empower individuals to navigate the complexities of healthcare registration, including securing family doctors, scheduling medical appointments, extending IFHP coverage, and applying for RAMQ/CSQ, and additionally providing invaluable insights into their specific challenges and healthcare requirements.

### A Guide for Refugee Claimants & Asylum Seekers

This workshop aims at empowering asylum seekers and refugee claimants with essential knowledge regarding their IFHP medical coverage and newcomers' understanding of the intricacies surrounding healthcare access in Quebec. With recurring updates, this workshop is always informed with changes in the healthcare system.



### HEALTH ADVOCACY & BARRIER TO CARE

From Barrier to Care is a pivotal initiative aimed at bridging the gap in healthcare accessibility for refugees, asylum seekers, newcomers, and immigrants in Quebec. This presentation focuses on educating service providers and healthcare professionals about the complexities of healthcare access for the newcomer populations, the Interim Federal Health Program, the importance of cultural sensitivity, and challenges service providers to gain new perspectives regarding the clientele they are serving.

### **SOCIAL ACTIVITIES & HEALING HAND IN HAND**



The Social Activities Program at The Refugee Centre is a transformative initiative dedicated to enhancing the integration experience of refugees, asylum seekers, newcomers, and immigrants in Quebec. From cooking workshops to movie night events, the initiative offers a vibrant array of opportunities for individuals to connect, share experiences, and build meaningful relationships.

### ART PROGRAMMING ( )



These initiatives are rooted in combining the realms of creativity and well-being, aiming to introduce how art-making can facilitate connections, self-expression, and healing. We have facilitated a variety of different bi-weekly, monthly and annual workshops including:

<u>Deeply Rooted Art Workshop series</u>, which is a collaborative initiative that started in 2021, between The Refugee Centre and the Black Healing Centre, and is dedicated to inviting & empowering BIPOC guest artists & community members through creative exploration.

<u>The Art Hive Workshops</u> is an initiative that aims at facilitating an open community art studio for all community members to try out new art materials, networks and have a good time. We have hosted the art hive both at The Refugee Centre, and at partnering organizations such as PRAIDA.

Art in the Park is a summer program that invites our community members to try out a variety of creative mediums, from painting on tote bags to kite-making.

<u>We Are More</u> is an annual art festival that is centered on spotlighting and uplifting refugee & newcomer artists and vendors in our community!

## TRANSITIONAL HOUSING



Innovative, affordable & supportive are the cornerstones of The Refugee Centre's Transitional Housing program. The goal of this program is to remove barriers to the housing market that people, particularly newcomers, often face. We strive to provide stability and affordability, allowing individuals to focus on building a life in Canada, rather than struggling with housing uncertainties.

In the past year, we have been able to secure partnerships with other community organizations which own and operate social housing in the greater Montreal area. This has allowed us to secure access to:

8 apartments

to operate as transitional housing for our clients. During the clients stay, we pair them with caseworkers who work diligently to holistically support them throughout their time in the program.

We are grateful for the partnerships that we've secured with multiple community organizations, universities and private landlords.



### TRANSITIONAL HOUSING

Our goal is not only to prevent homelessness, but also to pave the way for success and integration into Canadian society. Our program ensures that newcomers not only have a roof over their heads, but also gain valuable resources such as credit history and landlord references. This is an important step in establishing a solid foundation in their new homeland.

By providing a stable living environment and necessary support services, The Refugee Centre's Transitional Housing Program serves as a springboard for newcomers, offering them a safe starting point and a promising path to a successful life in Canada, transforming the daunting journey of relocation into one of hope and growth.



## HOUSING RIGHTS & ROOMMATE WORKSHOP

Hosted YMCA Residence the partnership with PRAIDA, The Refugee Centre designed a housing rights workshop geared towards refugee claimants seeking roommates. The event provides attendees with vital information on housing resources and tenant rights, empowering them to navigate housing challenges more effectively. Open to participants in English, French, Spanish, and Arabic, the workshop attracts a diverse group of attendees. The interactive session helps raise awareness about housing rights, and networking among the refugees.


## LEGAL AID CLINIC



At the heart of The Refugee Centre, our legal clinic works tirelessly to embody a philosophy centered on education and preparation.

We strongly believe that empowerment lies in knowledge, which is why we are dedicated to educating new and future residents on the essential legal issues that pertain to their unique situation.

With a dedicated team of two attorneys, one paralegal and five rotating legal interns, we leverage our expertise and passion to provide a range of services tailored to our clients' needs. Our goal is to ensure that our clients are not only informed, but also equipped to navigate the complexities of the legal landscape.



### **LEGAL AID CLINIC SERVICES**

#### **WORK PERMIT APPLICATIONS**

We provide comprehensive advice to those seeking to obtain a work permit, ensuring they understand the process and prerequisites.

#### STUDY PERMIT APPLICATIONS

We assist individuals who intend to pursue their studies in the country by guiding them through the study permit application process.

### HUMANITARIAN AND COMPASSIONATE APPLICATIONS

We extend our services to those who need to apply for humanitarian exemptions, helping them effectively demonstrate their unique situation.

### **REFUGEE CLAIMs**

Our experts help people understand and navigate the refugee claim process, while ensuring that their rights and interests are adequately represented.

### PRE-REMOVAL RISK ASSESSMENT APPLICATIONS

We help people who are at risk of removal from the country complete Pre-Removal Risk Assessment applications, a process that assesses the potential risks of returning to their home country.

### **LEGAL AID CLINIC SERVICES**

#### **IRCC PORTAL WORKSHOP**

This workshop aims to help refugee claimants navigate the IRCC Portal confidently and submit quality applications. By providing a free and reliable service, we remove the financial and digital literacy barriers that claimants often face. These workshops are offered twice a week at the Refugee Centre and once a week at PRAIDA where the attendees are provided with computers and get to complete their refugee claims in the IRCC portal from start to finish. This is made possible by our dedicated team of legal professionals, staff and volunteers.

### PERMANENT RESIDENCE APPLICATIONS

We guide potential residents through the intricacies of applying for permanent residence, ensuring they are well prepared and well informed.

### BASIC OF CLAIM (BOC) VALIDATION SESSIONS

This session is designed to ensure that each client's Basis of Claim form complies with the necessary requirements for submission. It is NOT to evaluate the merit of their case. This session is provided weekly by our legal team.

### REFUGEE SPONSORSHIP APPLICATIONS

We support groups who wish to sponsor refugees, providing clear guidance at every stage of the application process.

## THE LEARNING CENTRE



## IELTS AND DUOLINGO PREPARATION COURSES

Our IELTS (English Proficiency Test) preparation courses help students prepare for the tests they need to take to get into college or find a job. In addition, our teacher will cover topics that will prepare you for the now widely accepted Duolingo exam.

### **FRENCH COURSES**

French is one of the most important skills newcomers need to learn when they arrive in Quebec and we offer our French classes and conversation circles to help them do just that.

## ENGLISH COURSES

We offer beginner and intermediate English courses for people of different levels. Many students then take the IELTS course.

## ENGLISH AND FRENCH CONVERSATION CIRCLES

Conversation Circles are meant to help individuals practice English or French in a small, informal setting. These circles help individuals make connections in the community while simultaneously practicing their English or French conversation skills.

## WEB & PYTHON DEVELOPMENT

Throughout the year, we offer a variety of training workshops to help newcomers gain skills that will help them with employment and entrepreneurship. Some of the workshops we have offered in the past include web development and python.



## **Newcomer Relocation Program**

FROM MONTREAL ACROSS CANADA

The Beyond the Big City project is a transformative resettlement and integration initiative designed to help individuals and families seeking a fresh start by relocating from Montreal to smaller cities across Canada. This innovative program promises to enrich the lives of participants and the communities they join by providing tailored support and carefully matching them with local employers. By promoting cultural integration and offering comprehensive assistance throughout the recruitment and settling process, the project aims to ensure a successful transition, creating new opportunities for participants to rebuild their lives and careers in welcoming, thriving environments.

### The program includes:

- Assisting candidates in securing housing and employment;
- Providing language and skills training for effective integration;
- Offering cultural integration opportunities;
- Preparing candidates for a confident transition; and
- Establishing local partnerships for long-term support.





### **PROGRAM OBJECTIVES:**



### **Facilitating Relocation:**

The primary objective of the Beyond the Big City project is to assist individuals and families in their transition from Montreal across Canada, by facilitating the logistical challenges of relocation and providing the resources necessary to ensure a smooth transition.

### **Improve Employment Opportunities:**

Participants will be matched with potential employers in other Canadian cities, leveraging their skills and experience to secure stable employment that matches their qualifications and interests.

### **Promote Community Integration:**

To foster a sense of belonging, the project will actively engage participants in the diversity of their new community, encouraging social interactions and fostering an inclusive atmosphere that supports cultural integration.

The Beyond the Big City project offers the promise of creating a better life for individuals and families seeking a new beginning in a new city in Canada. By providing tailored support, matching participants with employers and fostering cultural integration, the project aims to make this transformative journey a resounding success, enriching both the lives of participants and the community they join.

## WHAT IS DEVBLOC?



DevBloc is the first social enterprise community incubator meant to both educate and aid refugees and immigrants to be relevant in today's workforce. With training and certification in technologies related to today's emerging technology sector, DevBloc will ensure the integration of the immigrant and refugee population into the tech economy. Lastly, it will also aid individuals as well as groups to build/develop new technology to solve the existing refugee and migrant crisis, domestically and internationally.

This is essential for refugees and immigrants, as more and more skilled workers are needed in a very fast-paced market. Incubators accelerate the successful development of entrepreneurial ideas through an array of business support resources and services. Our main goal is to produce successful refugees/immigrants that leave the program financially viable and freestanding. Incubator graduates commercialize technologies, create jobs, and strengthen local economies.

The proposed mission of our Social Innovation Catalyst is to stimulate the establishment and growth of technology-based start-up companies and other compatible businesses in relation to social enterprise and community building. By fulfilling this mission, the incubator would contribute to job creation, enhance quality of life, and attempt to merge the tech world with the non-profit sector.

DevBloc will provide the Montreal refugee and immigrant community with the ability to engage in and learn about new and emerging technologies and businesses. We hope to foster an environment that will aid students and community members in developing businesses or technologies that will not only better the local community we reside in but also the world. Focusing mainly on the idea of social and community enterprise, DevBloc will be one of the few incubators in the world where the main focus of its business and technologies is geared towards life/social enhancement, rather than pure monetary gain. The proposed incubator includes facility space, flexible leases, shared use of common office equipment, direct business assistance and guidance, mentoring, networking to capital, and other technical resources. A network of existing resources in the community would be developed to support incubator/client needs.

## PAY IT FORWARD Fund

The Pay It Forward Basic Needs Fund helps provide new arrivals with financial support for urgent basic needs. These urgent basic needs can be defined as anything needed to access basic human rights services, and are divided into two categories: funds that go directly to beneficiaries and funds that are used to purchase basic necessities.

Of these funds, 66% go directly to beneficiaries and 34% are used for items that beneficiaries can get at our center, such as basic groceries, transportation passes, baby and hygiene products. Items covered by the funds that go directly to beneficiaries include: emergency housing, medical coverage, mental health services, pharmacy coverage, winter clothing, and school supplies.



### **LUNA AI**

LUNA AI is an artificial intelligence application that, through its interactive platform, will allow asylum seekers to exploit its conversational capabilities. Asylum seekers will talk to LUNA and, in turn, LUNA will control the conversation in order to extract all the information necessary for the asylum application. LUNA then automatically fills out all the forms and documents necessary to obtain refugee status in Canada, ensuring that applicants do everything according to the rules of the Canadian immigration system. This saves the government days of processing time and a large amount of management resources.



### **POINT OF ENTRY**

"Point of Entry," presented by The Refugee Centre, serves as a platform to amplify the voices of community members, newcomers, BIPOC individuals, and organizations. We delve into the experiences and challenges of resettlement and explore a wide range of intersectional topics, inviting a diversity of guests to share their unique perspectives on various "Points of Entry."

### **ALLOCANADA.ORG**

AlloCanada is a web application that has mapped the services available to newcomers in every major city in the country. Unlike any other resource tool, AlloCanada can filter all the organizations that can help its users based on their migration status and the types of services offered.



## **ADVOCACY**



The Refugee Centre's Advocacy department aims to work with political and community partners to create well-informed policies and social programs that positively impact the refugee community in Quebec and nationally. This department acknowledges the arduous processes that refugees face and honours this resilience by advocating with the community for better, more equitable social and political realities.

### **PROJECTS WE'VE DONE**

### **Community Ambassador Program Year 1 (September 2023 - May 2024)**

Internship program in which participants conducted primary research to identify bureaucratic barriers and address them through material creation.

### Social campaigns (launched in April 2024)

Highlighting issues facing refugees through social media posts accompanied with actionable campaigns(petitions, letter campaigns, etc) for community members to participate in.

## Advisory Member of National Newcomer Collective for Truth and Reconciliation (Since February 2024)

Participation and facilitation of a national member group dedicated to increasing allyship between Indigenous communities, newcomer communities, and the resettlement sector.

### **ADVOCACY**

### **Intersectional Youth Movement (Since February 2024)**

Involvement and participation in intersectional political and social issues that impact various communities. This movement works to put youth at the forefront of efforts to shape a better future.

## Community Ambassador Program Year 2 (September 2024 - May 2025)

Internship program to facilitate and influence positive policy change. Participants work to address prominent policy issues facing refugees in Canada through policy and grassroots solutions.

### **IRCC Special Measures Consultation (June 2024)**

Participating in information sessions on new special measures introduced by IRCC and providing feedback on what to improve.

### **COMMUNITY EVENTS**

Throughout the year, we hosted and participated in various community events that provided valuable opportunities to connect with the public, celebrate cultural diversity, and raise awareness about important issues.

### La Nuit des sans-abris - October 20, 2023

In partnership with Foyer du Monde and Le Pont, we set up a kiosk at the event to raise awareness about the challenges faced by asylum seekers, particularly those without status or with precarious status. We emphasized the intersectionality between asylum seeking and homelessness, highlighting that these barriers stem from systemic issues within public institutions and policies, rather than from the presence of asylum seekers themselves.

### **CCR Fall Consultation Workshop Planning**

### - November 17, 2023

We were part of the planning committee for a workshop at the CCR Fall Consultation 2023 titled Solidarity Across Communities: Coming Together to Build Advocacy. This workshop delved into the complex reasons behind migration, often rooted in imperial and colonial forces that lead to forced displacement and habitat destruction. By recognizing the shared experiences of Indigenous migrants to Canada and Indigenous communities on Turtle Island, the workshop explored common issues and developed systemic advocacy strategies grounded in solidarity and mutual respect.

## Salon de l'emploi et de l'intégration sociale des personnes demandant l'asile - December 4, 2023

At the Salon de l'emploi et de l'intégration sociale des personnes demandant l'asile, organized by INICI, we participated by hosting a dedicated table to present our services to refugee claimants. This allowed us to connect with attendees, provide essential information, and support their integration needs.



### First ROHMI's AGM - April 30, 2024

We were pleased to host the first Annual General Meeting (AGM) of ROHMI at The Refugee Centre location. This event highlighted our commitment to ROHMI's mission and emphasized our role in fostering collaboration among organizations working to improve migrants' access to housing.

### Official Launch New Office Space - June 7, 2024



### **WORKSHOPS & TRAININGS**

We believe it is essential to share our expertise by providing skill-building and informational workshops for our community partners. In 2023-2024, we offered two trainings aimed at enhancing knowledge and capacity within the community.

<u>From Barrier to Care</u> is a tailored presentation for service providers on how to work with newcomers through a culture and trauma-informed lens. We are aware that the healthcare system can be difficult to navigate, especially when newcomers face various barriers to accessibility. This training aim to explain everything you need to know about the Interim Federal Health Program (IFHP) and how to access medical care for refugees and refugee claimants. The training was delivered to 10 community organizations.

Refugee Pathways and Resources is a training designed for service providers to deepen their understanding of the complexities of refugee pathways and the various legal, social, and health eligibility. This comprehensive workshop equips participants with the knowledge and tools necessary to navigate the challenges faced by refugee claimants and to provide more effective support. In 2023-2024, we offered this training to 3 organizations.

### **JOINT INITIATIVES & PROGRAMS**

Through joint initiatives, we partner with other organizations to implement programs and services that leverage our combined expertise and resources.

### **Projet TRACES**

Conducted in partnership with TCRI, this 6-week program focuses on providing psychosocial support in a non-clinical setting, specifically designed for and with women. With a consistent group of 6-8 women, it fosters the sharing of experiences and the building of connections among participants while offering access to valuable information. The approach is mindful of the potential trauma linked to pre-, peri-, and post-migration experiences, incorporating elements of intersectionality and interculturality within a decolonial framework.

### **Ready Tours with Kinbrace**

In collaboration with IRB presenters, Kinbrace offers virtual Ready Tours workshops to help refugee claimants prepare for their hearings and understand the refugee appeal process. This year, The Refugee Centre has partnered with Kinbrace to deliver the Ready Tours in French

### **Empowering Youth Program**

In partnership with Résilience Montréal, the goal of this project is to provide community service experience for over 30 youth groups (ages 15-30) in Tiohtià:ke/Montreal, with priority given to Indigenous and refugee youth, providing them with valuable life experience and leadership skills, enhancing their project management capacity, and growing their networks of community partners and like-minded youth.

### **Capstone project with Concordia's Human Relations Department**

The Refugee Centre partners with Concordia University Human relations department for capstone projects aimed at enhancing services for refugee claimants and addressing the community's needs. The students, supervised by the Resettlement and Integration department, develop practical solutions focused on improving housing accessibility, language training, and community integration. Their work culminates in content creation or workshops to address different needs of refugee claimants. This collaboration fosters innovative approaches and strengthens the Refugee Centre's capacity to meet the evolving needs of the refugee community.

# COMMUNITY-BASED RESEARCH PROJECTS

### **PUBLIC HEALTH AGENCY OF CANADA (PHAC)**

Ongoing health project, funded by the Public Health Agency of Canada focuses on community-led research to understand the impact of lifestyle habits among newcomers and refugees. Emphasizing health promotion and chronic illness prevention, it aims to implement informed and tailored programs and activities for our community.

### **COMMUNITY JUSTICE CENTRE (CJC) PROJECT**

In collaboration with the Ministère de la Justice du Québec (MJQ), The Refugee Centre organized community mobilization sessions to evaluate the interest, feasibility, and priorities for a Community Justice Center (CJC) model tailored to the specific needs of Montreal's newcomer population.





### **OUR EXPENSES AND SAVINGS**

Below is a representation of our financial position as of the end of August 31, 2024. Our financial statements and expenses are independently reviewed annually by a third-party Chartered Professional Accountant (CPA) who provides a favorable financial opinion (provided on page 68) called a financial review engagement.

### What does a Full Audit by a CPA verify?

The individual performing a full audit must be a licensed practitioner. The practitioner is required to obtain evidence directly rather than rely on evidence provided by third parties. They perform procedures to reach a conclusion on whether anything came to their attention that causes them to believe that the financial statements are not prepared in accordance with the applicable financial reporting framework.

#### The review procedures that the practitioner is required to carry out include:

Inquiries on the accounting practices used by the company

Representations from management on the accuracy of the financial statements

Management responsibility for internal control systems

Management responsibility to detect and prevent fraud

Information on subsequent events

Knowledge of fraud

Ratios and relationships of recorded amounts

Analytical procedures on comparisons

Receipts of appropriate financial information

Procedures for recording financial information

The Refugee Centre hosts thousands of newcomers each year for multiple events, classes, workshops, and counseling appointments. We are located in downtown Montreal, near the Concordia University campus, in a 5553 sq. ft. space to hold classes, meetings, private legal consultations, workshops and much more.

### **COMMUNITY FUND**

At the end of each fiscal year, The Refugee Centre contributes at least 5% of its annual budget to its Community Fund. This is done in order to meet the legal obligations set by the provincial and federal governments, allowing us to be able to sponsor refugees each year.

For example: The Refugee Centre must have \$16,000 in savings to sponsor one refugee per year. Each year, depending on government quotas, The Refugee Centre sponsors 5 to 10 refugees.

#### INDEPENDENT AUDITOR'S REPORT

To the Members of Canadian Refugee Initiative,

#### Opinion

I have audited the financial statements of Canadian Refugee Initiative (the "CRI"), which comprise the statement of financial position as at August 31, 2024, and the statements of operations, changes in net assets, and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In my opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the CRI as at August 31, 2024, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

#### Basis for Opinion

I conducted my audit in accordance with Canadian generally accepted auditing standards ("Canadian GAAS"). My responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the financial statements* section of my report. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

#### Other Matter

I was appointed for the audit of the year ended August 31, 2024. As such, <u>I do not</u> provide an opinion on the comparative financial information for the year ended August 31, 2023, which was previously reviewed. A review is substantially less in scope than an audit and does not provide a basis for the expression of an opinion on financial statements as a whole.

As part of my procedures, I obtained sufficient appropriate audit evidence that the opening balances do not contain misstatements that may materially affect the <u>current period's</u> financial statements. However, readers should be mindful that the comparative information, in and of itself, is unaudited.
