Description of Building Product

PSP Limited supplies Archi-Line Battens manufactured by Knotwood in Australia.

Archi-Line Battens are non-structural, intended for internal/external wall, ceiling, and louvre applications. They are manufactured from extruded aluminium, and are supplied in various sizes with different coatings. Knotwood also supplies the aluminium extruded accessories for installation including mounting plates and joiners, batten spacers and endcaps.

The batten system may be installed vertical, horizontal, or diagonally. Archi-Line Battens can be fixed directly to the substrate, mounted on a subframe (top hat), or used in conjunction with a base mounting plate. Archi-Line is suitable for use on the following substrates; Timber, Aluminium, Steel, Concrete, and Masonry.

Archi-Line Battens have been subject to engineering and testing to AS/NZS standards. The battens are non-combustible and suitable for use where Group Number 1-S is permitted. Installation calculations have concluded that, subject to the conditions of the applicable engineering certificate, battens may be installed in all wind zones up to and including extra high, and at building heights of $\leq 20m$.
