Kids Adjustable Standard Wobble Chairs 14"-19"

Kids Adjustable Tall Wobble Chairs 16.5"-24"

(formerly Kids Grow With Me Adjustable Wobble Chair)

Suggested ages: 6+ for Standard Adjustable, 8+ for Tall Adjustable

Piston Actuator



Stool Seat



Rubber Pad for Base
(8" Diameter, 3/16" Thick)

- 1 Place Piston Base into Stool Base and press down firmly.



- 2 Place Piston Actuator assembly into Stool Seat and press down firmly.



- 3 Remove and dispose of Piston shipping cap.



- 4 Place Stool Seat on to Piston and press down firmly.



- 5 Now sit down carefully or tap the chair firmly on floor to push all the parts together.



- 6 Clean the bottom to remove any grease or debris. Remove and dispose of self-adhesive cover from rubber pad.



Peel

- 7 Apply rubber pad to center of base and press firmly to ensure all of rubber pad adheres to plastic surface.



- 8 Use easy-access 360° Actuator Ring to adjust height. Stand to raise the seat. Sit to lower.

WARNINGS:

- The Kore Design® fixed-height wobble chairs are intended to move (wobble, rock, swivel, etc.) while seated.
- The Kore Design® adjustable height wobble chairs are intended to move (wobble, rock, swivel, etc.) and raise and lower while seated.

It should not be used for any purpose other than sitting. NEVER STAND ON THE WOBBLE CHAIR.

Individuals using the wobble chair should be able to rest the bottoms of their feet on the floor while seated. This wobble chair shouldn't be used by individuals who have any difficulty with balance or any disability that makes use of a moving seat unsafe. All users of the Kore wobble chair use it at their own risk.
