Residents are compensated 98% of the salary of a comparable staff physical therapist. Salary adjustments (increases) are applied upon attainment of Certified Orthopaedic Manual Therapist certification, Certified Dry Needling Specialist certification, Certified Strength and Conditioning Specialist, and successful completion of ABPTS Sports Board Certification all of which are incorporated within the residency program.

Residents who terminate employment from OSS after completing the 18-month program but prior to fulfilling the four-year employment agreement will be required to repay the remaining tuition and financial assistance on a prorated basis.
