- At least 400 sq. ft. and double wide
- Constructed to the "HUD Code" for manufactured housing
- Built on a permanent chassis
- Installed on a permanent foundation system
- Titled as real property with 433 recorded
- Built after July 1978

If the home you're trying to get financed meets those standards, you may be eligible for a Manufactured Home Loan!
