# Managing Director's Report



**The 2025 financial year marks another transformative year for ANDHealth, as Australia's digital and connected health sector continues its extraordinary trajectory, growing at a rate of over 50 per cent year on year since 2019.**

Since its incorporation in 2017, ANDHealth's business has evolved substantially, now spanning programs and activities across Australia, and the globe. We have a singular purpose, which is to accelerate the commercialisation and uptake of evidence-based digital and connected health technologies and a team dedicated to creating value for the sector across three key areas: non-dilutive investment programs, commercialisation capability development, and industry development and advocacy.

In April 2025, we released our comprehensive State of the Industry Report, '*The Rising Giant: Creating a New Economic and Health Future for Australia*'. The report outlined that Australia is now home to well over 1,000 digital and connected health companies.

The report also highlighted a significant maturation of the sector, with the proportion of mid to late-stage companies outpacing growth in early-stage ventures. However, it also revealed the majority of companies (88%) are still navigating commercialisation challenges, prior to market launch, underscoring the critical need for continued support and development initiatives to help these companies reach their full potential. ANDHealth is uniquely positioned to provide this support, with proven programs designed to support innovators throughout the commercialisation pathway, from "idea to exit".

Within our non-dilutive investment activities, our flagship program ANDHealth+ has continued to cement its position as one of the leading accelerators in Australia with the 28 companies that have participated in the program since FY18 raising \$187 million in follow on financing, generating over \$77 million in new revenue, creating over 500 new, high value jobs and undertaking 38 new international market launches to the end of FY25. In addition, these companies have undertaken 102 clinical studies, 967 commercial pilots, secured 20 new regulatory approvals and, most importantly, impacted over 2.9 million patients over the same period.

Throughout FY25 we also continued working closely with Brandon Capital in support of the Medical Research Future Fund (MRFF) BioMedTech Incubator and BioMedTech Incubator Dementia and Cognitive Decline (DCD) initiatives, which total \$100 million of MRFF funding, through the CUREator+ program. Across the CUREator+ and CUREator+ DCD programs, the ANDHealth Non-Dilutive Investment (NDI) team has reviewed a total of 263 digital and connected health applications and is providing hands on support to six companies so far to 30 June 2025.

Our Investment Readiness, Education and Events (IREE) team continues to demonstrate significant impact, delivering 79 programs and events across the year, including the Victorian Connected Health Innovation & Commercialisation Centre (CHICC), the highly regarded Activate scale-up program (funded by LaunchVic), the Software as a Medical Device (SaMD) specialisation course for the NSW Commercialisation Training Program (in

partnership with Cicada Innovations), two significant international delegations to the US and the UK/Europe and a range of other targeted events and activities.

In funding news, this financial year ANDHealth successfully applied for and was privileged to be awarded a further \$33 million from the MRFF 2024 BioMedTech Incubator Program grants round to continue and expand the ANDHealth+ program until 2030. In addition, we also received confirmation of funding to continue to deliver the LaunchVic ACTIVATE program for a further two years, through until 2028.

This support reaffirms not only the maturity of our model, but also the compelling results achieved so far: ANDHealth delivered and supported non-dilutive investment programs deliver critical outcomes on follow on funding raised, revenues generated, jobs created, and patients impacted at rates that far surpass other leading accelerator programs across technology and health.

Beyond the economic impact of our flagship programs, ANDHealth's broader impact cannot be underestimated. As of 30 June 2025, the ANDHealth team has delivered >3,700 hours of direct programming to >4,200 participants. We have supported digital and connected health SMEs with >1,100 hours of one-on-one coaching and mentoring sessions to over 8,100 attendees driving industry growth, commercialisation outcomes and economic and health benefits for all Australians.

# Managing Director's Report



As an organisation founded on the premise of "harnessing the collective" we were delighted to welcome new partners in FY25. The Royal Melbourne Hospital, Monash University and Commercial Eyes all joined as Core Partners of ANDHealth and we thank our long-term Core Partners – Murdoch Children's Research Institute, Telstra Health, Planet Innovation, and Curve Tomorrow, along with our Industry Partners – HPM Executive and HLTH Community – for their ongoing support.

During the year we also welcomed AusBiotech, Care Economy CRC and Australian Society for Medical Entrepreneurship and Innovation as Ecosystem Partners.

Our policy and industry leadership and advocacy has also continued at pace. Amongst an incredibly active policy landscape, ANDHealth supported the Department of Health, Disability and Ageing with the '*Safe and Responsible Artificial Intelligence in Health Care*' report and the Therapeutic Goods Administration (TGA) with the '*Clarifying and strengthening the regulation of Medical Device Software including Artificial Intelligence (AI)*' report and its '*Proposed changes to the regulation of exempt medical devices and exempt Other Therapeutic Goods*'. Against a backdrop of significant policy initiatives such as the National Health and Medical Research Strategy and the Strategic Examination of R&D, ANDHealth actively participated in various industry and sector roundtables and one on ones with key participants and will continue to engage closely over the coming months.

We also lodged submissions on key areas of policy reform, including the *Australasian Institute of Digital Health (AIDH) mHealth Assessment Framework*, and the *Statutory Review of the Data Availability and Transparency Act 2022*, focusing our efforts on policy reform which is directly related to our purpose of accelerating the commercialisation and uptake of evidence-based digital and connected health technologies.

Further augmenting our activities in Canberra, I was deeply honoured to be reappointed to the National Health and Medical Research Council as the Member with Expertise in Business for the 2024-2027 triennium, and also as the inaugural Chair of the newly formed Industry, Philanthropy and Commercialisation Committee advising both the NHMRC and the Medical Research Future Fund.

Looking forward, we remain cognisant of our financial position and resilience and continue to evolve our business and operations to ensure future sustainability. One example of this is the new partnership with the Care Economy CRC, a groundbreaking initiative that will see researchers working with care providers and technology companies to deliver benefits at scale. We have taken on the role as the commercialisation partner, bringing our deep domain expertise in commercialisation alongside the CRC's research and development capabilities.

The team will be continuing to build out our commercialisation and capability development services throughout the coming years.







## ANDHealth+

Our flagship, national digital health commercialisation program, designed to accelerate the growth of digital health businesses by providing a share in up to \$3.75M non-dilutive funding per intake, plus access to expert guidance and industry support. Applicants are selected via a proven competitive process informed by a cross-section of multi-sectoral industry leaders.

## CUREator+







# Our Non-Dilutive Investment Capabilities

ANDHealth has four streams of funding through the Australian Government's Medical Research Future Fund (MRFF) under management to deploy through the ANDHealth+ and CUREator+ programs.

The MRFF Early-Stage Translation and Commercialisation (ESTAC) initiative-backed funding for the ANDHealth+ program has now been fully allocated. This financial year, ANDHealth successfully applied for and was awarded a further \$33 million from the MRFF 2024 BioMedTech Incubator Program grants round to expand and evolve the ANDHealth+ program.

# ANDHealth+



The ANDHealth+ program, funded by the \$19.75M MRFF Early-Stage Translation and Commercialisation Initiative, has invested \$15M into projects driving clinical and commercial impact of breakthrough technologies being developed by digital and connected health companies developing breakthrough technologies. Final projects for companies in Cohort 4 and Cohort 3 companies with follow-on funding have been already off-boarded or are on track to be completed before the completion of the grant period on 30 November 2025.

# ACTIVATE



ACTIVATE is a six-month program delivered with support from LaunchVic. In March 2025, it was announced that LaunchVic has extended the funding for ACTIVATE for an additional two years, through to 2028.

The purpose-built accelerator program for Victorian based digital and digitally enabled medical technology companies features 1:1 mentoring and small group coaching with more than 100 external speakers help deliver six face-to-face modules.

In FY25, we selected 15 promising Victorian SMEs to complete this year's program and welcomed our new ACTIVATE Executive in Residence, A/Prof Mo Dirani. Mo is an Australian entrepreneur, scientist and the founder of health tech startup Plano.

# TGA SaMD Regulation Navigation Support



Since September 2021, ANDHealth has worked with the Therapeutic Goods Administration (TGA) to provide regulation and registration support for software as a medical device (SaMD) companies looking to commercialise new products that can help improve health outcomes for Australian patients.

The program helps digital and connected health companies understand the scope of products that are subject to regulation and require listing on the Australian Register of Therapeutic Goods (ARTG), software as a medical device classification, compliance with regulatory requirements and post-market responsibilities for manufacturers and sponsors of SaMD through webinars and one-on-one meetings.

This year we again had our full schedule of 10 webinars sell out with 400 attendees across the program.





# Media & Communications



Industry growth, development and advocacy is a core area of focused activity for ANDHealth to help achieve our purpose of accelerating the commercialisation and growth of Australian digital health companies.

Key publications included *The Rising Giant* state of the industry report and an industry capabilities report for Austrade. In consultation with our members and cohort companies, we contributed policy submissions to inquiries including:

- Australian Government Strategic Examination of Research & Development
- National Health and Medical Research Strategy
- AIDH mHealth Assessment Framework
- Statutory Review of the Data Availability and Transparency Act 2022
- TGA Proposed changes to the regulation of exempt medical devices and exempt Other Therapeutic Goods
- TGA Clarifying and strengthening the regulation of Artificial Intelligence
- Department of Health, Disability and Ageing's final review into Safe and Responsible AI in Healthcare

ANDHealth's engagement with members and the sector was also a focus area across both traditional media and digital channels, including a 31 per cent increase in LinkedIn followers.



# The Rising Giant Industry Report



Our latest state of the industry report, *The Rising Giant: Creating a New Economic and Health Future for Australia*, shows that Australia was home to 1,005 digital and connected health companies at the end of 2024, with the sector growing at a compound annual growth rate (CAGR) of 52% since 2019.

The report highlights a significant maturation of the sector, with the proportion of mid to late-stage companies outpacing growth in early-stage ventures. Early-stage companies now represent 55% of all digital health companies, down from 73% in 2020, while mid-stage companies have increased to 33% from 20%. Companies in the later stages of market uptake and exit have grown from 7% to 12%.

*The Rising Giant* report follows ANDHealth's previous industry analyses, including *The Awakening Giant* (2022) and *The Sleeping Giant* (2020), which have tracked this emerging sector's remarkable trajectory. *The Rising Giant* was launched at events held in Sydney and Melbourne, attended by more than 130 guests in total.


