Approval of September 18, 2025 Meeting Minutes

<u>Award of Procurement ID LCLGRPB-07-2025 Economic Valuation of Clean Water in the Lake</u> <u>Champlain Basin</u>

Ms. Gilles explained that LCLGRPB received a \$199,000 grant from the Lake Champlain Basin Program for the economic valuation of clean water in the Lake Champlain Basin. A Request for Proposal (RFP) was sent out and received 5 responses. Interviews were conducted with 3 of the organizations, which include Impact Infrastructure dba AutoCase, One Water Econ, and ESI eConsults. It's been determined that Impact Infrastructure truly understood and will deliver on the requests while staying within budget. The RFP contained a maximum spending amount of \$125,000 and Impact Infrastructure came in at \$124,900, so Ms. Gilles would like to award LCLGRPB-07-2025 to Impact Infrastructure dba AutoCase.
