Review of By-Laws, Ethics Policy, Investment Policy, Workplace Violence, Videoconferencing Policy and Sexual Harassment Policy

There were no questions or comments from committee members, so Ms. Gilles asked for a motion to reaffirm the policies.

Loan Balance Report and 2025 Loan Overview

Ms. Gilles explained the following information to committee members.

- RLF 1
 - o New Way Lunch: Loan matured in 2025 and they're officially paid off.
 - o Brand Redemption: We're waiting for an update from the attorneys.
 - o Washington County Agri Park #2: The borrower is late on their payment by 19 days, but he's been on-time previously, so he'll be reminded of the overdue payment.
 - o MSRY Rentals: They're current on their loan after a short default.
- RLF 2
 - o Phaseline Properties: The borrowers have had late payments for the last few months, which could be attributed to the owners opening a new restaurant in Glens Falls. They're currently 17 days late on this loan, and it's being monitored by Ms. Gilles.
- RLF 4
 - o Pizza Shop: The loan is almost paid off and the business is going well.
- RLF 5
 - o Christopher's Restaurant, FW Arcade, and RL Gould & Son all paid their loans off early in 2025.
 - o Trailhead Restaurant: They're now current on all payments.
 - o Slickfin Brewery: At the date of this meeting, they're 2 days late on their payment.
 - o Savor and Scoop: At the date of this meeting, they're 213 days late with their loan payments. Our attorney was tasked with offering the borrower's attorney with a

deal, but Ms. Gilles hadn't heard back from our attorney about whether the deal was approved or not.

- Karasell Flowers: Ms. Gilles requested the attorney's file for foreclosure, but she hasn't received any updates recently.
- RLF 6 / Small Business Loan Fund (SBLF)
 - In 2025, there were 5 new loans added to this fund.
 - Karasell Flowers: This loan is currently in default.
 - Scarlotta's: They're currently behind on payments and it happens occasionally, so Ms. Gilles will be reminding them of the non-payment to date.

Ms. Gilles provided an overview of the loan funds, which currently have 54 loans. Warren County has 21 loans (38.9%), Washington County has 8 loans (14.8%), Essex County has 12 loans (22.2%), Clinton County has 5 loans (9.3%), Hamilton County has 4 loans (7.4%), Jefferson County has 2 loans (3.7%), and both Lewis and St. Lawrence Counties have 1 loan each (1.9%).

In 2025, there were 5 new loans that all went to the SBLF, which is equivalent to \$5.04 million in lending capital. There were no loans denied, one loan matured, three loans were paid off early, and two loans were modified. The current defaulted loans are Brand Redemption, ELF Property, Karasell Flowers, and RC Spot. There is \$1.4 million in RLF 5, and there's \$886,000 in the SBLF still available to lend. There's an applicant that Ms. Gilles and Ms. Calabrese are working with to acquire an independent living facility in Saranac Lake. The funding request of \$200,000 would be for the acquisition of the building along with the bank, and operational funds from Essex County IDA, NCA and AEDC.

2026 Interest Rates

Ms. Gilles asked for 2026 interest rate recommendations from the committee. The interest rates from 2024 and 2025 were between 5-9%, and the committee members all agreed that that range is still reasonable for 2026.

Other

Ms. Gilles informed the committee that with Juan Gonzales no longer being on the committee, they needed a representative from Washington County. Ryan Roberts from Great Meadow Federal Credit Union has volunteered to be the Washington County representative on the Loan Administrative Committee. Ms. Gilles will be nominating Mr. Roberts for appointment at the LCLGRP.B.ORG Board of Directors meeting on January 13, 2026, along with committee members whose appointments expired December 31, 2025.
