

## **SOPA: Approved input suppliers – as of**

**27/01/26**

The SOPA Evaluation Scheme monitors the approval of products that may be used in organic systems. This includes livestock minerals, feed supplements, soil conditioners, fertiliser inputs and supplementary nutrients.

There are two types of Approvals: full approval, where there is no restriction on use on organic farms, or Restricted use where the farmer must seek permission to use the product. Permission can be sought by using the appropriate derogation form (available on the SOPA members portal). SOPA members are recommended to check with their Certification Officer if there is any query, to collect approval certificates from suppliers, and keep all records available for inspection.
