**DECLARATION OF ZHOUYANG "MASON" SONG IN  
SUPPORT OF APPOINTMENT OF CHAPTER 11 TRUSTEE**

Zhouyang "Mason" Song hereby declares pursuant to 28 U.S.C. § 1746:

1. I, Zhouyang "Mason" Song, respectfully make this Declaration in support of my *Joinder in Creditors Committee's Motion to Appoint Chapter 11 Trustee*. I am advised that Joinder is being filed along with this Declaration, and that the Committee's Motion is scheduled for hearing in this Court on November 18, 2025.

2. My name is Zhouyang "Mason" Song. I am over the age of twenty-one years old, of sound mind, have never been convicted of a felony, and am capable of making this

Declaration. I have personal knowledge of the facts stated herein, except as set forth below. All of the facts herein are true and correct to the best of my knowledge. I further state that I am fully authorized and competent to testify to the matters set out in this Declaration.


3. I am a creditor of the Debtor in this case, having filed a proof of claim in the amount of \$28,248,673.70 on August 27, 2024 [Claim No. 3]. As set forth in that proof of claim, the basis for the debt owed to me is a loan agreement and secured promissory note with the Debtor, effective as of January 2, 2023, for which I furnished collateral in the form of Bitcoin of a value that as of the Chapter 11 petition date exceeded the balance owed on my loan by the amount of my claim.

4. On October 31, 2025 I appeared voluntarily to be interviewed via Teams by a special agent and forensic specialist at the FBI working out of its offices in Utah, as part of an ongoing criminal investigation into alleged criminal fraud perpetrated by the Debtor and its principal, Aaron Tilton. I did not reach out to the FBI for this interview, but rather participated at their request after they contacted me as part of their investigation.

5. Based on questions posed to me at the interview it appears that the focus of the investigation includes, but may not be limited to, certain of the pre-petition business activities of Power Block, including as relate to the loan made to me and secured by my Bitcoin as collateral and the refusal to sell that collateral at my request to pay off that loan when Power Block demanded repayment. Although I was not specifically told this, I also believe based on the questioning that Mr. Tilton has been made aware of the existence of this investigation; however, I am not aware that he has disclosed that knowledge to this Court in connection with the Chapter 11 case in which he remains in control of the Debtor.

6. To the best of my knowledge and that of my counsel, there are no restrictions on my ability to disclose the fact or substance of my interview or the underlying investigation as I know them, and accordingly I am at liberty to submit this Declaration for use in connection with this Chapter 11 bankruptcy case.
