

## QC WARE PRIVACY POLICY

This privacy policy explains how QC Ware Corp. (“QC Ware”, “we”, “us”) collects and uses information about you when you use QC Ware websites, products or services or otherwise interact with QC Ware or provide QC Ware with information about you.

### Categories of personal information we collect and basis for processing

Types of personal information that QC Ware collects and uses as well as the basis for processing are set forth in the table below:

Payment information. If you make a purchase through a QC Ware website or the AWS Marketplace, your payment-related information, such as credit card or other financial information, may be collected by a third-party payment processor and covered by that party’s applicable privacy policy, which you should review carefully.

### **How we collect your personal information**

We may collect your personal information when you:

- Register for or use a QC Ware product and/or service.
- Complete a form or provide feedback on a QC Ware website.
- Email QC Ware.
- Use or view a QC Ware website.
- Participate in a Q2B event as a speaker.
- Register or check-in at a Q2B event.
- Scan your badge or otherwise provide your information in connection with your attendance at a Q2B event.
- Reserve a hotel room through a QC Ware hotel reservation website for a Q2B event.
- Otherwise interact with QC Ware and provide your personal information to us.

### Cookies and automatically collected information.

When you use the QC Ware websites, we and our third-party service providers may collect information from you through automated means, such as cookies, web beacons, and web server logs.

A cookie is a piece of text which can be placed on your device (for example, your personal computer or mobile phone) by us or a third party and can be subsequently read as you visit a website to identify you and provide functionality. A cookie may be a session cookie that remains on your device for a limited period and then disappears (for example, while you are logged on to a particular web site), or it may be a persistent cookie that remains on your device over a longer period. Cookies may be served directly by the website you are visiting (“first party cookies”) or may have been set by third parties outside the domain of the website you are visiting (“third party cookies”). The information collected in this manner may include IP address, browser characteristics, device IDs and characteristics, operating system version, language preferences, referring URLs, and information about the usage of the applicable website. Web beacons, pixels or other similar technologies can do the same or similar things (for purposes of this policy, we refer to all these technologies as “cookies”). ### How do we use cookies?

QC Ware uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in.
- Understanding how you use our websites.
- Tracking which content you consume and for how long.

There are several different types of cookies that our website may use including:

- Necessary - Necessary cookies are essential for the website to function properly. These cookies ensure basic functionalities and security features of the website, anonymously.
- Functional - Functional cookies help to perform certain functionalities like sharing the content of the website on social media platforms, collect feedback, and other third-party features.
- Performance - Performance cookies are used to understand and analyze the key performance indexes of the website which helps in delivering a better user experience for the visitors.
- Analytics - Analytical cookies are used to understand how visitors interact with the website. These cookies help provide information on metrics the number of visitors, bounce rate, traffic source, etc.
- Advertisement – Advertisement cookies are used to provide visitors with relevant ads and marketing campaigns. These cookies track visitors across websites and collect information to provide customized ads.

Some browsers may allow you to automatically transmit a “Do Not Track” signal to online services you visit, but QC Ware websites are not currently set up to recognize those signals. Accordingly, we do not monitor or act with respect to “Do Not Track” signals or other mechanisms. For more information on “Do Not Track,” visit <http://www.allaboutdnt.com>.

QC Ware uses Google Analytics, which uses cookies and similar technologies to collect and analyze information about use of the Site and report on activities and trends. This service may also collect information regarding the use of other websites, apps, and online resources. ### How to manage cookies

You can set your browser not to accept cookies, and [allaboutcookies.org](http://allaboutcookies.org) tells you how to remove cookies from your browser. We also provide cookie management functionality through our website. However, if you disable cookies, some of our website features may not function as a result.

### **How we use your personal information**

QC Ware collects your personal information so that we can:

- Operate, maintain, enhance, and provide features of QC Ware websites and products.
- Provide information and/or support that you request.
- Respond to comments and questions that you submit.
- Process your registration for a QC Ware software product, including payment, and create/manage your account.
- Process your registration for a Q2B event, including payment, and create/manage your account.
- To give you access to the content and capabilities that you purchased.
- Reserve a hotel stay in connection with a Q2B event.
- Email you Q2B event information.
- Email you QC Ware newsletters and other marketing information.
- Share such data, only with your consent, to Q2B event sponsors for sponsor communications in connection with such sponsors’ products and services.
- To contact you for administrative or informational purposes. This may include responding to a message or notifying users of changes to our policies.
- For our business purposes, such as data analysis, audits, security, fraud monitoring and prevention; and operating and expanding our business activities.
- To enforce this Privacy Policy or other legal rights.

If you participate in a Q2B event as a speaker or exhibitor, your personal information may be used in connection with the running of the event, including advertising and promotion of the Q2B event.

In addition, photos and videos are taken at Q2B events, which may feature attendees, speakers, sponsors, or exhibitors. Where we have taken photos and videos at our events that feature you as an attendee, speaker, sponsor, or exhibitor, to the extent permitted by applicable data protection laws, those photos and videos may be used for our promotional purposes.

Where Q2B events and exhibitions use badge scanning technology, your personal information will be used to identify you at certain access points, such as to access VIP areas, seminars, entry and exit in other areas of the event. This may provide certain location information. The personal information obtained from badge scanning will be used for access control, security and analyzing visitor traffic with a view to improving the event experience for visitors and others.

If you unsubscribe, we may still send you non-promotional communications, such as security alerts and notices related to your use of our services, including your attendance and/or participation at Q2B events.

### **How we share your personal information**

We do not disclose the information that we collect through QC Ware websites to third parties except in the following circumstances:

- To our third-party service providers who provide services such as website hosting, data analysis, information technology and related infrastructure provision, auditing, and other services.
- To a potential or actual acquirer, successor, or assignee as part of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of our business, assets, or stock (including in bankruptcy or similar proceedings).
- If required to do so by law or in the good faith belief that such action is appropriate: (a) under applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from public and government authorities, including public and government authorities outside your country of residence; (d) to enforce our terms and conditions; (e) to protect our operations or those of any of our affiliates; (f) to protect our rights, privacy, safety or property, and/or that of our affiliates, you or others; and (g) to allow us to pursue available remedies or limit the damages that we may sustain.
- Only with your consent, to Q2B event sponsors for sponsor communications in connection with such sponsors' products and services.
- If you allow your badge to be scanned by a Q2B event exhibitor, your contact details may be shared with the relevant exhibitor.
- If you participate in a Q2B event as a speaker or exhibitor, your personal information may be used in connection with the running of the event, including advertising and promotion of the event.

By registering for a Q2B event and providing your consent to share with sponsors, you give permission to QC Ware to share your personal information with such sponsors and for such sponsors to use your personal information to contact you regarding their products and services. You may refuse to provide your consent to share your personal information with sponsors or withdraw your consent by contacting QC Ware as described below.

By allowing an exhibitor at a Q2B event to scan your badge, you give permission to QC Ware to share your personal information with such exhibitor and for such exhibitor to use your personal information to contact you regarding their products and services.

If you provide consent to share your personal information with sponsors and/or allow an exhibitor at a Q2B event to scan your badge, such sponsor and/or exhibitor shall be a data controller (or equivalent function under applicable

law) with respect to such personal information and such sponsor's and/or exhibitor's privacy policy shall apply to its use of such personal information. QC Ware shall not be responsible for a sponsor and/or exhibitors actions with respect to your data when the sponsor and/or exhibitor acts as the data controller.

We do not share your personal information with unaffiliated third parties for their own direct marketing purposes unless we have your permission to do so. We may use and disclose information that does not identify or otherwise relate to an individual for any purpose, except where prohibited by applicable law.

### **Services used to store, collect and/or process personal information**

QC Ware may provide your personal information to vendors that provide services to QC Ware, which will change from time to time and may include, but is not necessarily limited to, the following:

- Agence Yes (provides a service to assist in the execution of Q2B events)
- Hyatt Regency group (provides accommodation services for Q2B events)
- Marriot Hotels (provides accommodation services for Q2B events)
- Curiosity Works Inc. (provides a service to assist in the execution of Q2B events)
- Juice (provides a service to assist in the execution of Q2B events)
- Microsoft (provides cloud storage services for data)
- Amazon Web Services (provides cloud computing services for QC Ware's software services)
- Zoominfo (provides B2B data intelligence services)

We will retain your personal information for different periods depending on the nature of the relationship (e.g., account administration, event participation, marketing), legal requirements, and legitimate business needs. You may always request that we delete your personal information, subject to applicable legal retention obligations, by contacting us as set forth below.

### **Security**

QC Ware maintains reasonable administrative, technical, and organizational measures designed to protect personal information against unauthorized access, loss, misuse, and alteration.

### **Privacy policies of other websites**

QC Ware websites contains links to other websites. Our privacy policy applies only to our websites, products, and services. If you click on a link to another website, you should read their privacy policy.

### **Children's privacy**

We do not knowingly collect, maintain, or use personal information from children under 13 years of age, and no part of a QC Ware website, product or service is directed to children. If you learn that a child has provided us with

### **California privacy rights**

California residents may have the right to know, access, correct, or delete personal information; to opt out of the sale or sharing of personal information; and to limit the use and disclosure of sensitive personal information. QC Ware will not discriminate against individuals for exercising these rights. If applicable, you may exercise applicable rights by contacting us using the contact details below.

California's "Shine the Light" law (Civil Code Section § 1798.83) permits users of QC Ware websites that are California residents to request a detailed list of any third-party entities with which we share personal information for their own marketing purposes. ### **Notice to EU and UK residents**

The GDPR and UK-GDPR provides EU and UK residents with rights regarding their personal information.

The right to access – the right to request QC Ware for copies of your personal information.

The right to rectification – the right to request that QC Ware correct any information you believe is inaccurate or incomplete.

The right to erasure – the right to request that QC Ware erase your personal information, under certain conditions.

The right to restrict processing – the right to request that QC Ware restrict the processing of your personal information, under certain conditions.

The right to object to processing – the right to object to QC Ware's processing of your personal information, under certain conditions.

The right to data portability – the right to request that QC Ware transfer the personal information that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we will respond promptly and in all cases within the time allowed by applicable law. If you would like to exercise any of these rights, please contact us as described below. You may lodge a complaint with your local data protection authority if you have any complaints about the way your personal information is being processed. You may also withdraw any consent that you've provided us to process your personal information by reaching out at the contact information below.
