



# Seton Catholic Summer PreK Program 2026 Registration Form

## Program Description

Seton Catholic is offering a Summer PreK program to continue to provide quality education in a safe environment for current and future PreK students. The program will operate Monday-Friday, 7:30am to 4:30pm, from July 6 to August 21. The program will be held in our current PreK classrooms, with plenty of outdoor activities on our campus. Pickup and drop-off will occur each day at the doors next to our playground. Food will NOT be provided for the summer. Students must bring lunch and two snacks each day. Registration is for all seven weeks at a cost of \$200 per week. No part-time options are available. To be eligible, students must: 1) be potty-trained and 2) have attended Seton Catholic's PreK during the 2025/26 school year or intend to enroll in 2026/27.

I understand that there are risks of physical injury associated with participating in Summer PreK activities. I authorize qualified emergency medical professionals to examine and in the event of injury or serious illness, administer emergency care to the student. I understand every effort will be made to contact me to explain the nature of the problem prior to any involved treatment. In the event it becomes necessary for the sponsor staff in charge to obtain emergency care for my child, neither he/she nor the sponsor assumes financial liability for expenses incurred because of the accident, injury, illness and or unforeseen circumstances. All activities are an extension of the mission of the sponsor program and participants' conduct is to be in accordance with the sponsor's rules and regulations.
