V. TOUR CONFIRMATION / OTHER CONDITIONS OF TRAVEL & PARTICIPATION

Upon receipt of registration form and requisite deposits, Friends of the National World War II Memorial will forward confirmation of tour itinerary, travel arrangements, and final balance due.

What is Not Included

Airfare between your home and The Netherlands; airfare between Germany and your home; airport transfers; travel insurance; meals and beverages other than those specified in the detailed itinerary; personal expenses such as laundry, telephone calls, internet service, and alcoholic beverages.

Reservations and Deposits

Space is reserved in the order of receipt of application or phone reservation. Deposits are applied to the price of the package. \$1,500 per person deposit, payable by check to Friends of the National World War II Memorial, is due with the application no later than March 27, 2026. Balance is due on or before July 15, 2026.

Cancellations and Refunds

Please understand that there will be no exceptions to our cancellation policy.

- Written cancellation received by the Friends of the National World War II Memorial up to 120 days prior to departure: full refund minus a \$750.00 per person cancellation charge.
- Written cancellation received by the Friends of the National World War II Memorial between 60 and 120 days prior to departure: full refund less a \$1,500 per person cancellation charge.
- Written cancellation received by the Friends of the National World War II Memorial within 60 days of departure: no refund may be made.
- Cancellation after tour departs: no refund.
- Cancellation of tour by Friends of the National World War II Memorial: full refund.

Air Tickets Purchased Independent of the Tour: We urge you to check airline cancellation penalties before purchasing airline tickets since international departure times and flights can change. Tours can also be cancelled due to low enrollment. Friends of the National World War II Memorial accepts no liability for cancellation penalties related to domestic or international airline tickets purchased independently in conjunction with this tour.

Travel Insurance: Friends of the National World War II Memorial strongly urges all tour participants to purchase travel insurance.

Itinerary or Program Modifications: The itinerary, as contained in the tour materials, is subject to modification and change by Friends of the National World War II Memorial. Every effort will be made to carry out the program as planned, but alterations may still occur after the final itinerary is sent.

Physical and Medical Considerations: If you have any physical and/or medical considerations or special requests that may affect your full participation in tour activities, we strongly advise you to notify our office in advance of the tour. While Friends of the National World War II Memorial cannot be responsible for these matters, we will endeavor to assist.

Special Arrangements: Participants may join the tour en route and/or stay on or after the end of the program. In such cases, however, no refund can be made for unused portions of the tour.

The FNWWIIM also reserves the right, without penalty, to withdraw the trip announced, to decline to accept any person as a participant in the trip, or to require any participant to withdraw from the trip at any time, when action is determined by FNWWIIM staff to be in the best interests of the health, safety or

general welfare of the tour group or of the individual participant, subject only to the requirement that the recoverable portion of the total amount paid that corresponds to the cost of unused services and accommodations be refunded, if any. Participants are encouraged to purchase airline tickets no sooner than 60 days before the trip begins to avoid airline cancellation penalties if the trip is canceled or otherwise modified subsequent to the participant's purchase of those tickets.
