CONFERENCE HIGHLIGHTS INCLUDED DAILY PRESENTATIONS AND TOURS BY ENGAGING PRESENTERS AND GUIDES, INCLUDING FRIENDS' RESIDENT HISTORIAN ALEX KERSHAW, AND A REMEMBRANCE CEREMONY AT THE WWII MEMORIAL. DOZENS MORE EDUCATORS WERE ABLE TO PARTICIPATE VIRTUALLY, AND VIDEOS OF THE PRESENTATIONS AND TOURS ARE ARCHIVED ON FRIENDS' WEBSITE (WWW.WWIIMEMORIALFRIENDS.ORG).
