## **DIRECTOR POSITIONS**

THE FOLLOWING PETITIONS WERE RECEIVED

#### DISTRICT 2 - RURAL DIRECTOR FOR EDMUNDS, FAULK AND HYDE COUNTIES

Longtime Faulk County resident and incumbent director, Jeff Stoecker of Onaka, has filed a petition for re-election in District 2. Stoecker has lived in the district for 64 years and is a graduate of Hoven High School and the Wyoming Technical Institute. Together with his wife, Carole, he operates a family farm near Onaka. Their two sons and their families also live and work on the main farm.

Stoecker is an active member of the Tolstoy Methodist Church and serves with the Tolstoy Volunteer Fire Department. Over the years, he has also contributed his time as a member of the Faulk County FSA Committee and the Hoven School Board.

When asked about his motivation to continue serving on the WEB Water Board, Stoecker shared:

"Having spent my entire life on the farm, I understand firsthand how essential a dependable water supply is for both agricultural and household needs. I want to continue working to ensure our area has access to reliable, high-quality water for generations to come."

#### DISTRICT 5 - RURAL DIRECTOR FOR SPINK, BEADLE & HAND COUNTIES

Incumbent Director R. Craig Oberle of Mellette has filed a petition for District 5. A lifelong resident of Spink County, Oberle has lived in the area for 70 years. He is a graduate of Northwestern High School and Northern State University, where he earned a degree in Business Management. Now retired after a 40-year career in banking, Oberle continues to stay active in his community. He currently serves as chief of the Mellette Fire Department, chair of the Mellette Housing Commission, and director of the Northeastern Council of Governments (NECOG) Development Corporation. He is also a past director of Grow Spink Inc.

When asked why he would like to continue serving on the WEB Water Board, Oberle stated:

"To continue to work for area WEB members to provide safe, clean, quality water to their homes, farms and businesses, and to provide continuity to the Board as WEB works to update the water system for future generations."

### DISTRICT 9 - BULK DIRECTOR FOR MARSHALL, DAY, CLARK, BEADLE, SPINK & HAND COUNTIES

No petitions were received for this district. To avoid a vacancy in Board representation for District 9, the sitting Director will continue to serve as the Director for that District until a successor becomes a Director, by election or default, or until the Board has appointed a replacement Director as outlined in the bylaws.

This seat is an important opportunity to represent the community and plays a vital role in guiding WEB's commitment to reliable, high-quality water service. Anyone interested in serving or learning more about the responsibilities of the board is encouraged to reach out and get involved.
