1. Project Overview

The Mohawk Hudson Land Conservancy seeks a qualified consultant to develop a comprehensive Master Plan for Public Art along the Albany County Helderberg-Hudson Rail Trail in Albany County, New York.

This Plan will guide Art on the Rail Trail's mission to support and improve the Rail Trail through the placement of public art, and to promote it as a destination for both art and recreation.

2. Project Background

The Albany County Helderberg-Hudson Rail Trail (the Rail Trail) is a multi-use trail that spans approximately 9 miles from the City of Albany to the Village of Voorheesville. It traverses diverse neighborhoods, natural landscapes, and cultural landmarks, offering a unique platform for community engagement through public art.

Art on The Rail Trail (ART) has facilitated numerous temporary art projects and events along The Trail since 2017. This Master Plan will provide ART with a strategic guide for commissioning future artworks and cultural programming.

3. Scope of Work

The selected Plan consultant will:

- Conduct a comprehensive, on-site review of the Rail Trail and make recommendations
 for specific art locations, with attention to current site conditions as well as locations that
 could be developed to allow for art installations.
- Gather community input on public art along the Rail Trail through activities such as public meetings, workshops, and surveys, allowing residents, stakeholders, and trail users to express their ideas and concerns.

- Provide a detailed summary of the community input, including respondents' demographics.
- Report County and municipal code requirements and preferences for placing art installations along the Rail Trail.
- Recommend types of temporary outdoor public art and associated viewing timeframes (seasonal versus multi-year; very ethereal or time-based versus longer-duration).
- Identify strategies for conservation, preservation, and security of art installations.
- Provide a map of the Rail Trail with recommended site locations.
- Prepare a phased implementation plan that includes project prioritization and annual growth objectives.
- Recommend the process of project development, review, administration, installation, and maintenance.
