



SDG IMPACT PROJECT OVERVIEW

This project plan is the primary course requirement and is due **May 31, 2026**.

Participants will design a **local SDG-aligned impact project** grounded in the **Land and Peoples Relationship Model (LPRM)** and situated within their own work, study, or community context. Projects align with **SDG 13 (Climate Action), SDG 14 (Life Below Water), or SDG 15 (Life on Land)**.

The project unfolds gradually across the mentorship program so that:

- Each step deepens relationship, clarity, and readiness
- Weekly assignments build directly into the **final written project plan**
- Participants finish with a project that is **ready to begin after the program**, with care and consent

FINAL PROJECT OUTCOME

By the end of the course, participants will submit a **Final SDG Impact Project Plan** that includes:

- A clear project purpose and SDG alignment
- Place-based and relational context
- Identified responsibilities, relationships, and permissions
- A phased, realistic implementation approach
- Resource and funding pathways
- Accountability and care considerations
- Clear next steps for post-program launch

- Short landscape summary + 2–3 possible project directions

Week 3 — Project Direction & Purpose Statement

Focus:

- Selecting one project direction
- Writing a clear purpose statement
- Defining scope and boundaries

Deliverable:

- Clear project description and purpose statement

Week 4 — Relationship & Responsibility Mapping

Final Plan Sections Drafted:

- **Section 4: Key Relationships & Responsibilities**

Focus:

- Mapping affected lands, waters, communities, species, and organizations
- Identifying permissions, protocols, and guidance needed

Deliverable:

- Written relationship map and responsibility narrative

- Drafting 2–3 relational, achievable goals
- Ensuring alignment with SDG and LPRM principles

- Clearly articulated goals with indicators of progress

- Relationship-first sequencing

Focus:
