END OF SEASON

WINTER SEASON will be upon us in a few weeks or sooner. Please be advised that our office may not be able to conduct all septic system inspections.

Field inspections requested by installers, complainants, and/or clients during adverse weather conditions will be evaluated on a case by case basis.

The two (2) primary factors that contribute to delaying or denying inspection requests are safety conditions and field conditions.

SAFETY CONDITIONS

Adverse weather conditions combined with remote destinations, high elevations, and unpaved roads pose a serious safety issue to Environmental Health Inspectors travelling to these sites.

Current vehicles are not properly equipped to reasonably access these inspection sites during adverse weather conditions.

Remote areas are of particular concern due to the lack of mobile service in these areas.

The safety of our inspectors is a primary responsibility of Chelan-Douglas Health District and should be prioritized during adverse weather conditions.

FIELD CONDITIONS

Approving septic system installations during or after adverse weather conditions places an increased liability on Chelan-Douglas Health District for the following reasons (based on the Onsite Wastewater Treatment Systems Manual (EPA):

Construction (installation) Practices

- Soil porosity is a critical factor in determining the satisfactory performance of an onsite septic system. Adverse weather conditions creates an excessive amount of moisture to the surface as well as raises ground water tables. Any work conducted in this environment results in compacting of soils in and around the designated septic system area and drainfield reserve area.
- Site preparation activities during or after adverse weather conditions results in further degradation of the soils surrounding approved septic system areas with compaction and smearing.

Excavation Activities

- Excavation and trenching activities during or after adverse weather conditions cause severe reduction in soil porosity and permeability. Compaction and smearing of the infiltrative surface occur from equipment traffic and vibration, scraping actions of the equipment. Compaction and smearing of the infiltrative surface seriously reduces the effectiveness of the installed septic system thus resulting in failed inspections and requiring new septic system designs and installations.
- Cover material for open trenches, septic systems are not adequately protected during or after adverse weather conditions. Cover material shall be loose, dry soils. Heavily saturated cover soils diminish the effectiveness of the installed drainfield.

Over the last year our issued septic permits and approved designs indicate the Soil Type and specify if the system may be installed in wet soils. These system installs are limited to sandy, gravelly soils (Soil Types 1, 2, and 3).

Soil Types designated as silt loams, sandy loams, or clay loams are not permitted to be installed in wet soils for reasons listed above. These soil types are designated as 4, 5, and 6 and should be indicated on your permit and approved design.

WINTER SEPTIC INSPECTION ALTERNATIVES

If Chelan-Douglas Health District cannot conduct a final septic inspection prior to cover:

- 1. Take photos of septic tank inlet and outlet, dose tank inlet and outlet (if applicable) and drainfield (trenches, bed, & drip system). Notify health district prior to cover and provide the photos via email to Onsite staff. If pressurized system, we can arrange on a later date to complete the pressure test.
- Contact Licensed Designer for final inspection Licensed Designers are approved to conduct final inspections.

Please submit all inspection requests to our dedicated email listed below. This ensures your inspection request has been received. This email is checked often on a daily basis. Requests should be 48 hours in advance to provide inspectors time for scheduling.

Please feel free to upload a completed <u>As-built Form & Drawing</u> with the inspection request. I have asked our inspectors to request the As-built Form & Drawing prior to conducting our final inspection.

Please refrain from and advise clients not to request inspections through the SmartGov Portal as inspectors are not tracking these requests.

TRAINING OPPORTUNITIES

CDHD hosted three courses with exam certification with WOSSA, Washington On-Site Sewage Association over the last 6 months. WOSSA – Basics of Installation Course and Exam on April 2nd & 3rd and again on October 2nd & 3rd. Also offered was O&M A-Z Troubleshooting Basics and O&M Level 2 Exam on October 1st. Completion of the Installer's Basic course and successfully passing the exam through WOSSA are required to become licensed as an Installer for Chelan & Douglas Counties.

Additionally, for next renewal cycle all existing Licensed O&M Service Providers will be required to complete the O&M Basics course and successfully pass the O&M Level 2 Exam to be re-certified.

WAC 246-272A Revision became effective April 1st of 2025

After nearly 7 months, few issues have been encountered with the revision. The nitrogen calculation has been implemented on only a handful of designs, and those that exceeded the nitrogen limits, a waiver is available if the exceeded nitrogen limit was the only waiver required for approval.

Local CDHD Code Revision

The CDHD Board of Health district successfully passed our local code update for Ch. 4.20 Onsite Sewage Disposal Systems in June of this year. Many of the changes were linked to the WAC 246-272A revisions but implemented a few additional changes to strengthen the On-site Program.

Key changes are as follows:

- Reserve area must be at least 5' from primary drainfield.
- Minimum of two (2) test pits required for new construction projects.
- Gravity drainfields must have minimum depth of 18" below native grade.
- Minimum design flow for one additional dwelling unit served by the same
 OSS is 120 gallons per bedroom or per building connection. Detached shops or garages with only a toilet and sink are exempt from this provision.






Creating a User Account in SmartGov:


- 1.) Go to SmartGov homepage: SmartGov
- 2.) Click on Sign up and choose your preferred language to create your account.




3.) Enter all information that is being requested to create your account. (*Keep this login information in a safe place for future use*). Then click the blue "NEXT" button.




4.) Enter necessary information and click on the blue "NEXT" button.



5.) Review your information for accuracy. Then check off the box to the "Terms and Conditions" and click on the blue box "Create My Account".




You only have 30 minutes to verify your SmartGov account. Please log into your email and verify account. An example of the email notification is down below:




You have created your User account in SmartGov, now it is time to log into your user account through SmartGov. You will be able to apply for your permit.
