OFFICIAL RULES

A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The Screencastify Conference Booth Sweepstakes (the “**Sweepstakes**”) begins on January 30, 2023 at 9:00 am Central Daylight Savings Time and ends on February 2, 2023 at 11:59 pm Central Daylight Savings Time (“**Sweepstakes Period**”).
