- I am also attaching an email about the work the California DD Council is doing for folks with IDD who have been impacted by the fires in their state. I am sharing this as information as an FYI only and do not mean to pressure any of you into contributing. I think this is such an amazing way for a council to support their community and wanted you to see it.
- Finally, we called a few different places including the Transportation Service Authority (TSA) about the Real ID requirements we discussed on Thursday. We confirmed that everyone boarding an airplane <u>WILL</u> need a Real ID or other forms of identification starting May 7th, 2025. Here is more information about that change in requirements. Please be sure you have the correct identification if you will be flying for council meetings or business:

Beginning May 7, 2025, every passenger must present a REAL ID-compliant ID, or another acceptable form of ID, to fly within the United States. REAL ID-compliant licenses are generally marked by a star on the top of the card. Enhanced driver's licenses and IDs from Michigan, Minnesota, New York, Vermont, and Washington are acceptable and are marked with a flag.
