# MESSAGE FROM THE PRESIDENT & CEO

#### **June Storm Restoration**

In the early hours of June 21, a severe storm moved through North Dakota and into Northwestern Minnesota. High winds snapped limbs and trees which broke poles and overhead lines and knocked out power to thousands of our members. Our linemen responded immediately, working through the night to assess the damage, look for downed poles, and remove power lines over roadways. The Waukon area was especially hard hit, with 21 poles either broken or leaning.

As the extent of the damage became clear, our operations staff prioritized the hardesthit areas and dispatched line crews to begin restoration work as quickly and safely as possible. This approach allowed us to send our line crews to the areas where they were needed the most to start bringing power back to our members.

The storm caused widespread damage across our service territory. As the damage assessments came in, we reached out to our pole replacement contractor, Legacy Power Line, who quickly responded with multiple crews and equipment to replace the downed poles at Waukon and other areas.

One of the principles of cooperatives is "Cooperation among Cooperatives". By working together, co-ops strengthen each other and improve services to our members. Nowhere is this principle more evident than during storm recovery efforts. Crews from Cavalier Rural Electric, Itasca-Mantrap Electric, and Red Lake Electric arrived to assist our team, helping us restore power to our members. Their quick action to provide assistance helped lessen the impact of the storm on our members. We extend a heartfelt thanks to these neighboring cooperatives and to Legacy Power Line for their critical assistance.

We are deeply grateful to our linemen and operations team for their dedication and skill to work efficiently and safely during this restoration effort. They worked extremely long hours in challenging conditions and we thank them for their work restoring power to our members after such a devastating weather event.

Restoring power after a major storm is never easy, but it is a responsibility we take seriously. We thank our members for their patience and understanding as we worked to restore power as safely and quickly as possible.

#### **Honoring Our Retirees**

In June, we gathered to celebrate our retired employees who dedicated many years of service to our cooperative. The 2nd annual Retiree Rally was an opportunity to show our appreciation for the hard work and commitment of those who helped build the system we have today. It was a privilege to honor them with a gathering that included fun stories from the past and a healthy dose of laughter. We thank our retirees for their years of dedication and for the example they set for all of us working today to keep the lights on for our members.

The Board of Directors held their monthly meeting on May 27, 2025. During the meeting, the Board was given an overview of the Operation Round Up meeting held May 7, 2025 and heard a presentation on credit card fees.

# Look up for Power Lines

Harvest is one of the busiest times of the year in our region, but no one is ever too busy to be reminded about the importance of electrical safety.

## LOCATE AND IDENTIFY

Make sure you, your family and your farm workers know where power lines are located on your property.

# WORK AT A SAFE DISTANCE

It is best to always assume a power line is energized and dangerous. A good rule of thumb is to stay at least 10 feet away from all power lines.

### LOWER BEFORE YOU GO

Lowering your equipment to the lowest possible setting is one way to not fall powerless to power lines.

### STAY AWAY AND STAY CALM

If you ever come in contact with an electric pole, STAY PUT. CALL 9-1-1. If equipment catches fire or becomes unsafe, avoid contact as you exit. Cross your arms, jump clear with both feet together to prevent electrical pathway.
