MESSAGE FROM THE PRESIDENT & CEO

As the new year approaches, we look back on the progress we made in 2025 to improve reliability for our members and to support our local communities. Looking ahead to 2026, we remain focused on delivering safe, dependable power and finding new ways to help our members and local communities be successful. Progress has been made, but there is still much work ahead.

Reflecting on 2025

We made many positive strides in 2025. We completed the first year of our new vegetation management program, trimming the rightof-way along approximately 120 miles of overhead lines. This work helps reduce tree-related outages and improves overall reliability for our members. Additionally, we were able to convert 29 miles of overhead power lines to underground. Our joint effort with Arvig to install underground lines will further improve reliability and reduce future vegetation management costs. We also worked through the June 2025 storm, which tested our system and highlighted the dedication of

our crews, who worked long hours to restore power safely and efficiently.

In the area of communications, we're excited to see our Facebook community continue to grow, allowing us to share updates and connect with more members than ever before. We attended local basketball games to promote our services and we added an "Ask-the Expert" column to our newsletter to help educate our members. And we're especially proud to have launched a new STEAM (Science, Technology, Engineering, Art, and Math) program to help local educators provide unique learning experiences for their students.

Looking Ahead to 2026

As we look ahead to 2026, we want to inform our members of an anticipated increase in wholesale power costs. Minnkota Power Cooperative, our wholesale electricity provider, is planning a rate adjustment as part of their budget for the new year. We will share updates and provide details about this increase as more information becomes available.

In the coming year, we will continue to improve our electric distribution system and support our members. As we enter the second year of our vegetation management cycle, we will focus on clearing rights-of-way in the southern and eastern parts of our service area. Our partnership with Arvig will also continue as we work together to install underground electric lines around area lakes. This partnership has allowed us to save money on installation costs while providing our members with improved reliability.

We also plan to improve our communication tools. This includes developing more informative material for new members, as well as updating material that explains our vegetation management practices. Additionally, we will explore new social media options to better connect with the next generation of co-op members.

From the Board of Directors and all of the employees of Wild Rice Electric Cooperative, thank you for your continued trust and support. We wish you and your family a safe, joyful holiday season and a Merry Christmas.

Highlights from the Board Room:



A quorum of directors was present and the following actions were taken:


- Approved the board minutes and financial reports and statements for August 2025

WATCH THE WIRES HOLIDAY TRAVEL SAFETY

In the Upper Midwest, driving during the holiday season can turn treacherous, with icy roads, reduced visibility and unpredictable conditions descending at any moment. When you add the risk of hitting a power pole or a downed power line, knowing what to do can be lifesaving.



IF YOU HIT A POWER POLE

1

STAY IN THE VEHICLE

Unless the car is on fire, the safest place is inside your vehicle. The ground around the car may be energized.

2

CALL 911

Let dispatch know you may be in contact with live electricity. They'll coordinate with the coop/utility to shut off power before you exit.

3

WARN OTHERS

Warn others to stay away by signaling or shouting to keep bystanders away from the vehicle or any downed lines.

4

ONLY EXIT IN AN EMERGENCY

If you must get out due to smoke or fire, jump clear of the vehicle with both feet together,

without touching the car and the ground at the same time. Then, shuffle away, keeping both feet on the ground to avoid creating a path for electricity through your body.

IF YOU SEE A DOWNED POWER LINE

1

STAY AT LEAST 35 FEET AWAY

Electricity can arc across distances – even the length of a school bus. This is especially true on ice or slush. 2

DO NOT DRIVE OVER THE LINE

Even if it looks harmless, a live wire can energize your car and the surrounding ground.

3

CALL 911 AND YOUR CO-OP/UTILITY

Emergency crews are trained to handle electrical hazards safely.

GENERAL WINTER TIPS

Always slow down in winter conditions, especially near power poles, intersections, or bends.

Keep an emergency kit in your car, including a flashlight, blankets, water and a phone charger.
