The Humanity Share (THS) works hand in hand with East African communities to break cycles of poverty and build sustainable, equitable futures. THS invests in community-led initiatives that address access to safe, reliable water systems and quality education, primarily for girls. In 2025, this included drilling and equipping a water source in rural Kenya serving a community of 4,000 people, providing tuition support to over 200 students from primary school through university, hosting five week-long leadership conferences for teen girls in rural Kenya, providing 400 hygiene supply kits, and participating in several community events and trainings to address community challenges aligned with THS's mission and vision.
