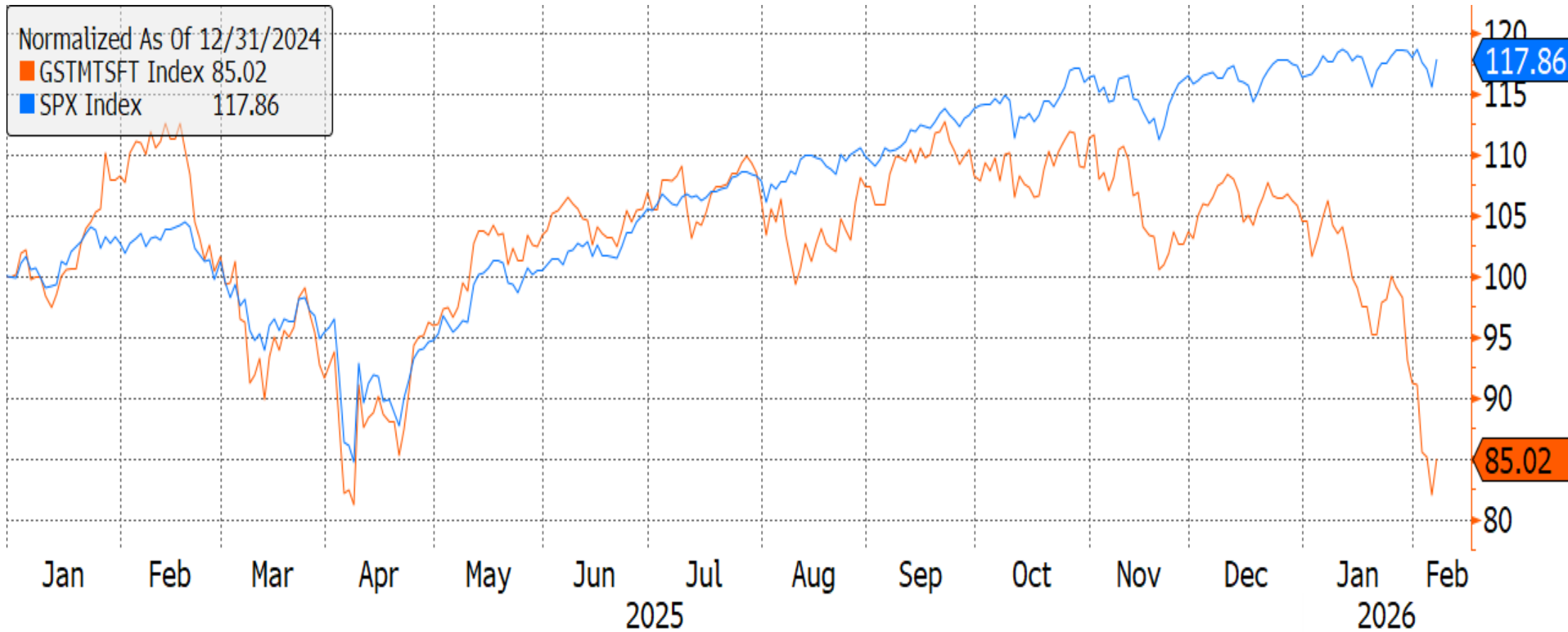

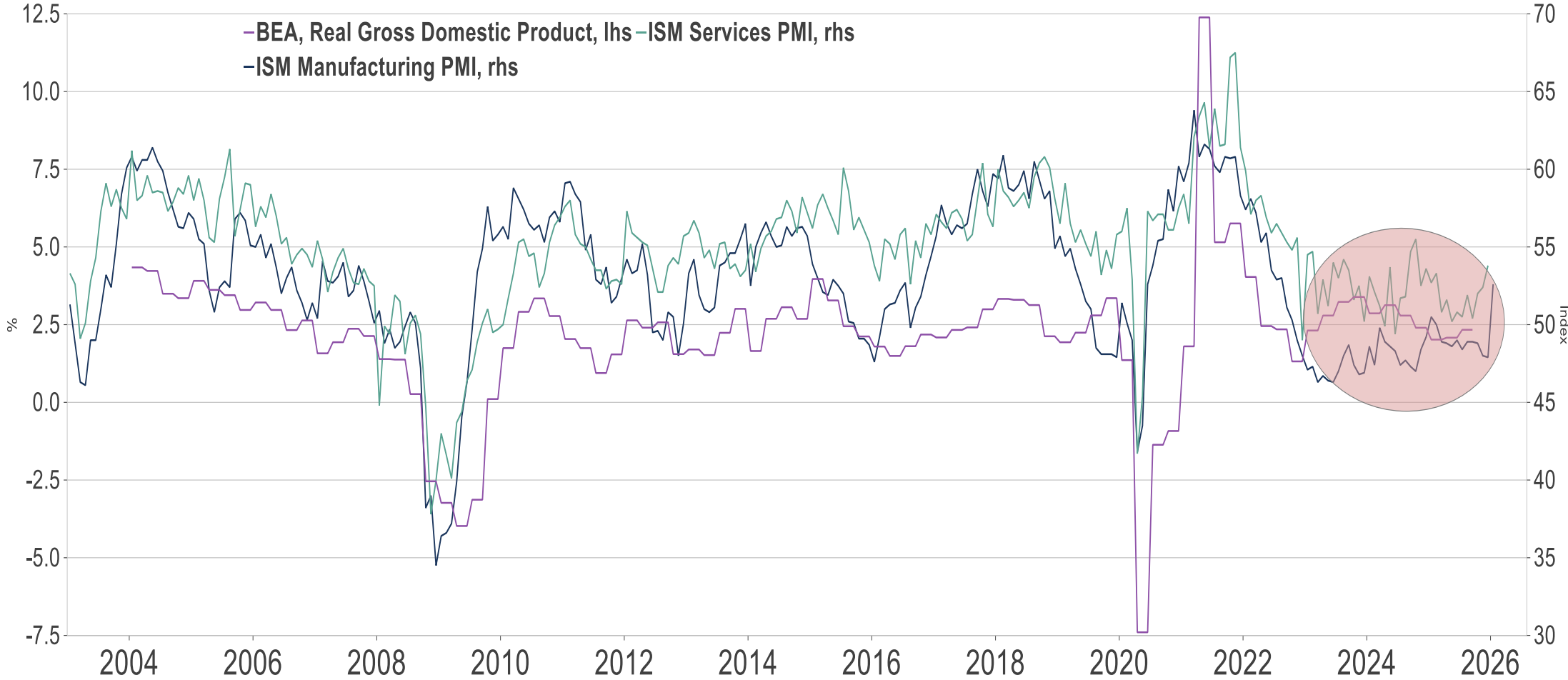
GSTMTSFT Index (GS Software Basket) Software vs. SPX Daily 31DEC2024-06FEB2026

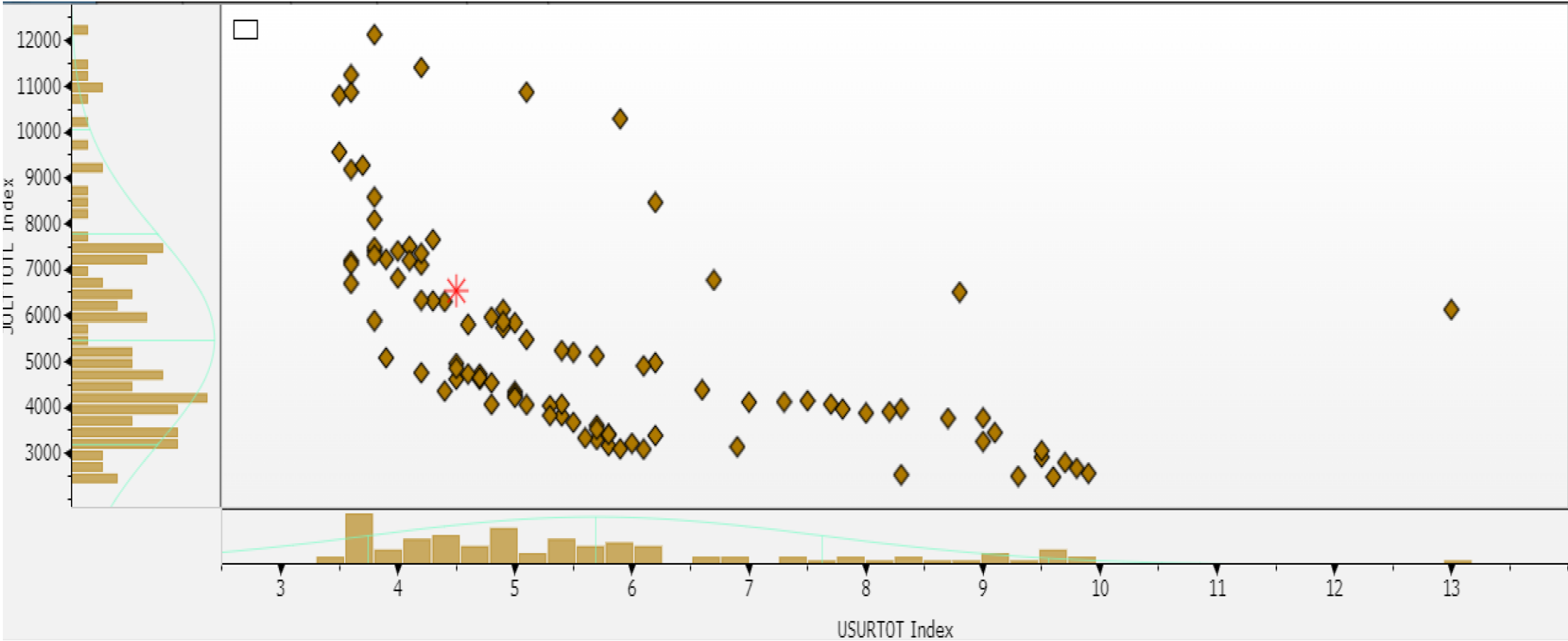

Business Sentiment Improves



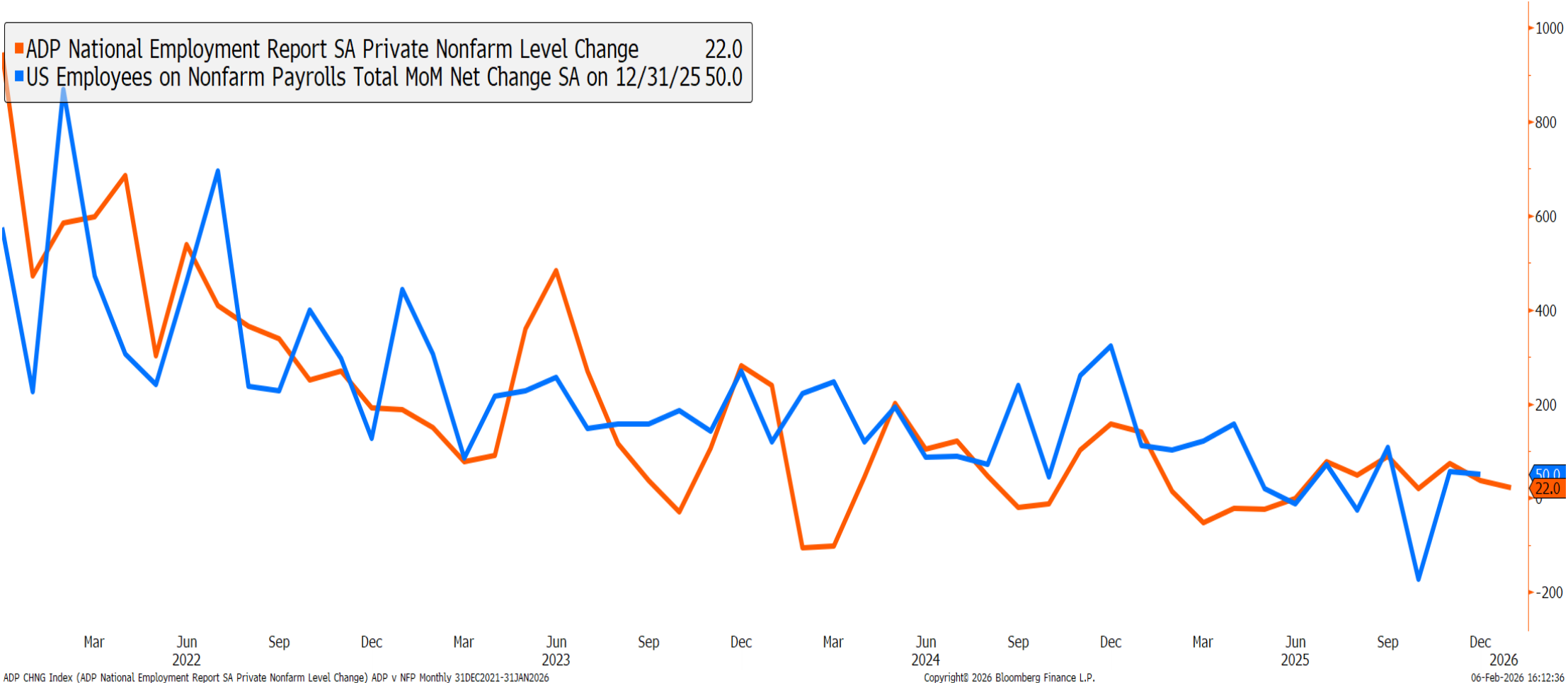
