## Investment Strategy

The Wilshire Global Allocation Fund (the "Fund"), seeks to realize a high long-term total rate of return consistent with prudent investment risks. Total rate of return consists of current income, which includes dividends, interest, discount accruals and capital appreciation.

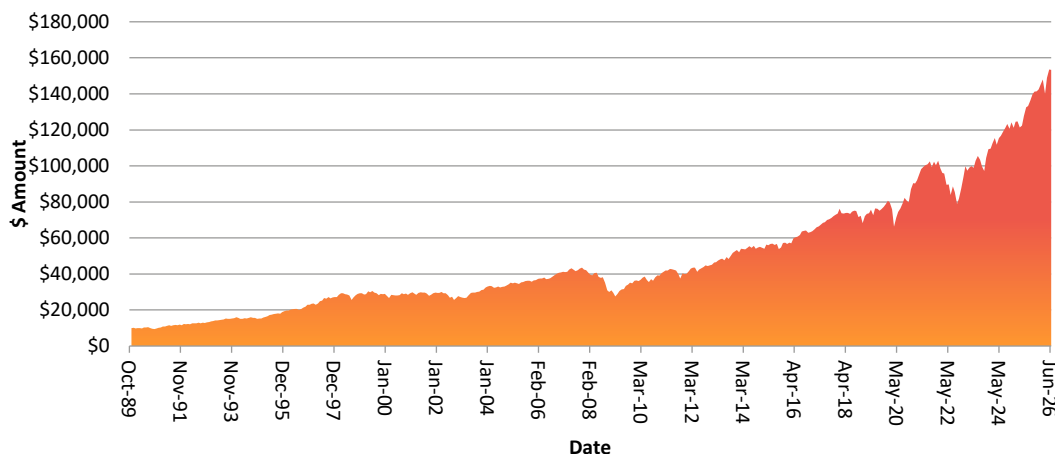

<sup>2</sup> Effective duration is a duration calculation for bonds with embedded options. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Yield to effective maturity is the total return anticipated if a bond is held for its lifetime. Wilshire Advisors LLC, the Fund's Adviser, has entered into a contractual agreement to limit expenses to 0.50% of average daily net assets (excluding taxes, brokerage expenses, dividend expenses on short securities, acquired fund fees and expenses and extraordinary expenses) through April 30, 2026. The expense ratio does not reflect the ability of the Adviser to recover all or a portion of prior waivers, which would result in higher expenses for the investor. This option is available contractually to the Advisor until April 30, 2026.

Prior to September 22, 2014, the Wilshire Global Allocation Fund was known as the Wilshire Balanced Fund.

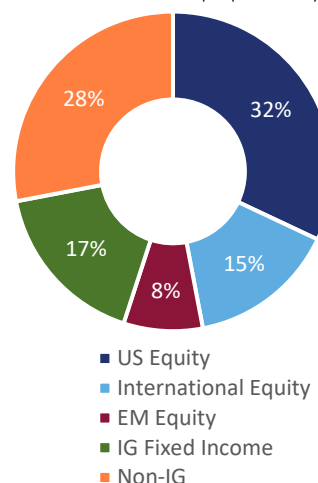
