LIFETIME LIMITED WARRANTY

The following limited warranty ("Limited Warranty") applies only to vinyl windows and doors (the "Products") sold by Windows USA, LLC, an Arkansas limited liability company ("Windows USA", "us", "we" or "our") which are provided and installed by Windows USA or its subcontractors within owner-occupied single-family homes, subject to the stated conditions and limitations below. If the original purchaser of the installed Products ("you" or "your") sells or cease to occupy your home within the term of this Limited Warranty (calculated from the original date of installation), the Limited Warranty will apply for the remainder of its term. This Limited Warranty is fully transferable. To transfer the Limited Warranty, the original purchaser must contact Windows USA to provide the new owner's contact information and the date ownership was transferred. WE LIMIT THE DURATION AND REMEDIES OF ALL IMPLIED OR EXPRESS WARRANTIES, INCLUDING WITHOUT LIMITATION THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE TO THE DURATION OF THIS EXPRESS LIMITED WARRANTY. VINYL FRAME -LIFETIME LIMITED WARRANTY

Except as otherwise provided herein, Windows USA® warrants that for as long as the original purchaser owns the home ("Vinyl Frame Limited Warranty Period") the window and sliding door mainframe only (not including hardware such as balances, pivot bars, tilt latches, locks, keepers, glazing, sash components, and Insulated Glass Units of its Products) will be substantially free of defects in material or workmanship that significantly impair their proper operation and function of the Products (failure to adhere to the foregoing warranty a "Vinyl Frame Defect"). If Windows USA® is given timely notice in accordance with the specific claims notice requirements set forth in this Limited Warranty of a Vinyl Frame Defect, Windows USA® shall, at its sole option and discretion: (1) repair or replace the defective frame or Product(s) (excluding the cost of shipping and labor thereto) with a commercially available product that

is substantially similar in design, color and styling to original purchased Product; or (2) refund a portion of the original Product purchase price reasonably applicable to the Vinyl Frame Defect of the Products on a straight-line depreciation basis over a twenty-five-year period.

GLASS – LIMITED WARRANTY

Except as otherwise provided herein, Windows USA® warrants that for a period of twenty (20) years after installation of the Product(s) into your home ("Glass Limited Warranty Period"): (1) insulated glass units will be substantially free from material obstruction of vision as a result of dust or film formation on the internal glass surfaces; and (2) glass will remain free of breakage or cracking (each failure to adhere to the foregoing warranties a "Glass Defect"). If Windows USA® is given timely notice in accordance with specific claims notice requirements set forth in this Limited Warranty of a Glass Defect, Windows USA® shall, at its sole option and discretion: (a) repair or replace the Glass Defect (excluding the cost of shipping and labor relating thereto) with a commercially available product that is substantially similar in design, color and styling to original purchased Product, or (b) refund a portion of the original Product purchase price reasonably applicable to the Glass Defect of the Products on a straight-line depreciation basis over a twenty year period. Replacement parts, including upgrades, are warranted for the remainder of the original product warranty.

HARDWARE AND SASH - LIMITED WARRANTY

Except as otherwise provided herein, Windows USA® warrants that for a period of five (5) years after installation of the Product(s) into your home ("Hardware and Sash Limited Warranty Period") the hardware and sashes will be substantially free of defects in material or workmanship to the extent such services significantly impair their proper operation and function of the Products ("Hardware Defect"). Windows USA® shall, at its sole option and discretion: (a) repair or replace the specific hardware component or sash (excluding the cost of shipping and labor relating thereto) with a commercially available product that is substantially similar in design, color and styling to original purchased Product, (b) refund a portion of the original Product purchase price reasonably applicable to the Hardware Defect of the Products on a straight-line depreciation basis over a five-year period. Replacement parts, including upgrades, are warranted for the remainder of the original product Limited Warranty

INSTALLATION SERVICES – LIMITED WARRANTY

Except as otherwise provided herein, Windows USA® warrants that for a period of two (2) years after installation of the Product(s) into your home ("Installation Services Limited Warranty Period") the installation services will be substantially free of defects in workmanship to the extent such services significantly impair their proper operation and function of the Products ("Installation Services Defect"). If Windows USA® is given timely notice in accordance with specific claims notice requirements set forth in this Limited Warranty of an Installation Services Defect, Windows USA® shall, at its sole option and discretion: (a) reperform the services, or (b) refund a portion of the original Product purchase price reasonably applicable to the Installation Services Defect.

WHAT THIS LIMITED WARRANTY DOES NOT COVER

The foregoing limited warranties do not cover:

- · Windows or doors with laminated, tempered or impact-resistant glass.
- Claims of air infiltration in excess of NFRC rating more than 1 year after installation
- Claims of water infiltration where window frames have not been kept clean and free of debris and dirt
 or in the event of abnormal weather events that could be deemed and act of God
- Glass breaks or cracks during any remodeling of the structure or removal of the window from the structure.
- Damage caused by any occurrence of vandalism.
- Damage caused by accidents, acts of God, including flood, earthquake, high wind events, fire, civil
 unrest, war, or riot.
- Breakage or damage which is covered under any insurance policy.
- Vinyl windows and doors sold by Windows USA® which are installed in buildings or structures which
 are not considered owner-occupied single-family homes.
- Screens
- · Normal wear and tear.
- Damage to the Products caused by improper installation, use, modification, alteration, cleaning or maintenance of the Product(s) by you, your agents, contractors, guests, or invitees.
- Damage to the Products as a result of Product installation occurring prior to completion of all
 construction, finishing or modifications to the interior or exterior of the structure containing the
 Product, whether structural, cosmetic, or otherwise, including, but not limited to, any (i) siding or
 exterior cladding work, (ii) interior or exterior painting, (iii) interior or exterior trim work, (iv) structural
 modifications or repairs, (v) masonry or stucco work, (vi) drywall installation or repair, and/or (vii)
 electrical or plumbing modifications near window/door openings.
- Damage to the Products caused by mechanical abrasion to finishes.
- Damage to the Products caused by non-factory-applied finishes, applied sealants or caulking.
- Damage to the Products caused by structural settlement, movement or vibration.
- Damage to the Products caused by exposure to excessive localized heat, high in-home humidity (condensation, frost or mold), high-moisture environments (including pools, hot tubs and greenhouses) or water leakage.
- Damage to the Products caused by normal wear, fading or discoloration of finish from Product usage, age or exposure to direct sunlight.

- Damage to the Products caused by acid rain or other atmospheric pollutants and corrosive elements.
- Damage to the Products caused by accidents, including accidental glass breakage except as
 expressly provided herein.
- Damage to the Products caused by application of after-market window films to glass surfaces.
- Damage to the Products caused by inappropriate finishes, solvents, brick-wash or cleaning chemicals.
- Glass breakage, not the fault of Windows USA®, that results in seal failure.
- Products subjected to conditions outside Product design limitations.
- · Damage to the Products caused by security system installations.
- Ripping, tearing or other damage not the fault of Windows USA® to window screens associated with wear and tear through Product use.
- Damage to the Products caused by insects.
- Products that have not been paid for in full.
- Minor imperfections, slight glass curvature, minor scratches, or other imperfections in glass that do not significantly obscure vision or affect the Product's structural integrity.
- · Minor variations in glass color.
- · Any Products that have not been installed by Windows USA® or its authorized subcontractors.
- Condensation.
- · Mildew buildup.
- · Surface imperfections.
- The transportation or installation of the Product(s) at altitudes in excess of 3,500 feet above or below point of manufacture unless equipped with capillary or breather tubes.
- Damage to the Products caused by stresses arising from glass surface temperature differentials or caused by building settlement or movement.
- · Rattling of grille bars within an air space.
- Use of Products under abnormal conditions, conditions that exceed the stated performance
 parameters of the Product as provided on the Product's labeling or under conditions not reasonably
 foreseeable to, or beyond the control of, Windows USA®.
- Windows that have been painted.
- · Any re-installation of alarm or burglar bars.
- Any other exclusions set forth in this Limited Warranty.

Further, no warranty is made as to the amount or percentage of argon present in the insulating glass. It is known that argon within insulating glass dissipates over time. Windows USA® makes no warranty regarding the rate of dissipation of argon or the amount of argon remaining in the Product at any time after the Products are manufactured. Further, it is important that the existing wall systems in your home be designed and constructed to properly manage moisture. Windows USA® is not responsible for claims or damages caused by anticipated or unanticipated water infiltration in Your home which are not caused by Windows USA® Products, including but not limited to deficiencies in building design, construction or maintenance; failure to maintain or operate Windows USA® Products in accordance with Windows USA® instructions; or the performance of Windows USA® Products in barrier wall systems, which do not allow for proper management of moisture within the wall system. The determination of the suitability of all building components is your sole responsibility. All risks related to building design and construction shall be assumed exclusively by you.

PROMPT NOTICE OF CLAIM

During the applicable Limited Warranty Period, you shall notify Windows USA immediately, and in no case more than ninety (90) days, after any defect or other basis of a claim covered by this Limited Warranty is discovered or should have been discovered. Any claims otherwise covered by the foregoing warranties, but for which Windows USA did not receive notice during the applicable Limited Warranty Period and within ninety (90) days from the time the problem first became known, shall be barred and you expressly waive any remedy or claim for damages against Windows USA. The Limited Warranty shall not be effective after the applicable Limited Warranty Period.

LIMITED WARRANTY CLAIM PROCEDURE

Claims for this Limited Warranty must be submitted in writing via certified mail or our website.

Claims must include the following information: (a) claimant's name, address and phone number and the installation address (if different); (b) a description of the Product, purchase price, the Product's SKU, the date and location of purchase, and copies of Product invoices; (c) A description of the Product defects (photos should be included); and (d) a brief summary of any attempts made to correct the defect. If shipping and/or installation is requested, you will be responsible for all applicable shipping and installation costs which must be prepaid by you prior to sending the Products to Windows USA.

With respect to any claim, you agree to pay a fee for the costs of an inspection (\$250/visit), to be paid upfront, which shall be refundable if a defect is determined to be present. If action is required, Windows USA shall proceed with a resolution to repair or replace the covered part or component, which shall be completed within 180 days, by following the below defined labor provisions:

- During the one (1) year period from date of product installation, Windows USA will provide the labor at no charge for any warranted repair required subject to the limitations and considerations listed herein
- During the subsequent periods from the above, Windows USA shall be responsible for providing, free of charge, replacement parts or components only, which shall expressly exclude labor and other costs

Replacement parts or components furnished by Windows USA under this warranty cannot be guaranteed to color match. A color variance may occur between replacement part and the original components. Windows USA reserves the right to discontinue or make changes in any of its Products. If the Products applicable to this Limited Warranty are not in production at the time of the claim, Windows USA shall have the right to substitute a product that in Window USA's sole discretion is equal quality or value.

LIMITATION OF LIABILITY

THE LIMITED WARRANTY AND REMEDIES DESCRIBED ABOVE ARE YOUR SOLE AND EXCLUSIVE REMEDIES AND OUR ENTIRE AND SOLE LIABILITY FOR ANY DISPUTE BETWEEN THE PARTIES, INCLUDING ANY BREACH OF THE LIMITED WARRANTY. YOU WILL SUBMIT ANY DISPUTES ARISING FROM, OR RELATED TO, THIS DOCUMENT, THE PRODUCTS, THE LIMITED WARRANTY, AND ANY DISPUTES BETWEEN THE PARTIES, INCLUDING DISPUTES ARISING FROM OR CONCERNING THEIR INTERPRETATION, VIOLATION, INVALIDITY, NON-PERFORMANCE, OR TERMINATION, TO FINAL AND BINDING ARBITRATION UNDER THE RULES OF ARBITRATION OF THE AMERICAN ARBITRATION ASSOCIATION APPLYING TEXAS LAW. THE SEAT OR LEGAL PLACE OF ARBITRATION WILL BE DALLAS, TEXAS. YOU AGREE TO ARBITRATE IN YOUR INDIVIDUAL CAPACITY ONLY – NOT AS A REPRESENTATIVE OR MEMBER OF A CLASS – AND YOU EXPRESSLY WAIVE ANY RIGHT TO FILE A CLASS ACTION OR SEEK RELIEF ON A CLASS ACTION BASIS. FURTHERMORE, UNLESS YOU AND WINDOWS USA® AGREE IN WRITING, THE ARBITRATOR MAY NOT CONSOLIDATE MORE THAN ONE PERSON'S CLAIMS, AND MAY NOT OTHERWISE PRESIDE OVER ANY FORM OF A REPRESENTATIVE OF CLASS PROCEEDING. ALL ARBITRATION PROCEEDINGS ARE CONFIDENTIAL, UNLESS BOTH YOU AND WINDOWS USAAGREE OTHERWISE. ARBITRATION ORDERS AND AWARDS REQUIRED TO BE FILED WITH APPLICABLE COURTS OF COMPETENT JURISDICTION ARE NOT CONFIDENTIAL AND MAY BE DISCLOSED BY THE PARTIES TO SUCH

COURTS. A PARTY WHO IMPROPERLY DISCLOSES CONFIDENTIAL INFORMATION WILL BE SUBJECT TO SANCTIONS. THE ARBITRATOR AND FORUM MAY DISCLOSE CASE FILINGS, CASE DISPOSITIONS, AND OTHER CASE INFORMATION AS REQUIRED BY A COURT ORDER OF PROPER JURISDICTION. THIS AGREEMENT, AND ANY DISPUTE BETWEEN THE PARTIES, WILL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS, WITHOUT GIVING EFFECT TO ITS CONFLICT OF LAWS PROVISIONS.
