

TIP TOP / THE WAREHOUSE LIMITED SUMMER PROMOTION 2025

TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these terms and conditions.
2. The Promoter is Tip Top Ice Cream, 113 Carbine Road, Mount Wellington, Auckland (**"Promoter"**).
3. The promotion is only open to New Zealand residents aged 18 years and over.
4. Employees of the Promoter and The Warehouse Limited and their immediate families are ineligible to enter.
5. This promotion is limited to The Warehouse Limited stores that have been invited by the Promoter to participate, which display promotional material advertising this promotion during the Promotional Period (**"Participating Store"**).
6. Entries into the promotion open at 12.01am on 08/12/2025 and close at 11.59 pm on 31/01/2026. (Promotional Period).
7. To enter, individuals must purchase any two qualifying Tip Top or Kapiti Ice Creams (**"Qualifying Products"**) in a single transaction from a Participating Store during the Promotional Period and fill out a Tip Top Entry form and attach their receipt, then place the entry into the Tip Top Entry box at the Participating Store.
8. Multiple entries are permitted. Each entry requires a separate purchase of qualifying Products in one transaction during the Promotional Period.

The Promoter and its agents are not responsible for late, lost, misdirected or incorrectly submitted entries. Incomplete or indecipherable entries will be deemed invalid.
