Summary	In no more than 250 words summarise why your project deserves to win this award.
Project Outline	Please provide a brief description of the project including the overall contract value, dates of commencement and completion. The project scale and delivery model (design-build, PPP, modular)?
Design Features	Showcase the use of sustainable design principles and construction practices in the building project. Highlight features such as energy-efficient design, use of eco-friendly materials, and innovative construction methods.
Quality & Compliance	Demonstrate construction quality, structural integrity, acoustic, thermal, and fire performance. Show regulatory compliance and quality assurance throughout off-site manufacture to on-site commissioning.
Energy Efficiency and Renewable Energy Integration	Demonstrate how the building project prioritizes energy efficiency and incorporates renewable energy sources. Provide data or case studies illustrating the reduction in energy consumption and the use of on-site renewable energy.
Resource Efficiency and Circular Economy Principles	Highlight efforts to optimize resource use and minimize waste throughout the building project. Showcase circular economy principles, such as the use of recycled materials, and highlight how the project contributes to a more sustainable building industry.
Indoor Environmental Quality and Wellness Considerations	Showcase features that enhance indoor environmental quality and promote the health and well-being of occupants. Highlight the use of natural light, ventilation, and other factors that contribute to a healthier and more comfortable indoor environment.
Certifications and Industry Recognition	Highlight certifications and industry recognition received for sustainability and green building standards. Showcase any awards, ratings, or third-party certifications that validate the project's commitment to environmental sustainability.
Supporting Statements & Testimonials	Include testimonials, case studies, client endorsements, charts, photos, or other documentation that strengthen your submission. Data, case studies, performance metrics should be included to show tangible value beyond typical methods.

Essential tips for a successful entry

A successful application **must** address all the points above.

Project **must** have been completed within the last **18 months**.

Marks will be allocated only on the evidence you provide.

Don't underestimate the power of presentation! You can use bullet points, charts, photographs, and client feedback in your submission. The more impressive your application appears and the stronger your evidence, the more it will support your case with the judges.

Please make sure you have included your Client References where applicable.

Make sure to include information on your exceptional successes during the year such as business systems, innovations or techniques that have reaped significant benefits.

Remember your document should be no more than 2500 words.

DO NOT include company marketing brochures in your entry.
