Mayor Knight gave the Invocation and Vice- Mayor Stoneberger led the Pledge of Allegiance.

#### PRESENTATIONS:

Rebecca Armstrong with Page Economic Development and Tourism stated she was here representing and supporting the VA250 committee. She introduced Chairman of the committee, Rod Graves to the stand. Mr. Graves stated this committee is planning a celebration with all three towns of the 250<sup>th</sup> anniversary of the Revolutionary War. This commemoration is scheduled to begin in 2026 through 2031. There will be historical marker locations in each town and for The Town of Stanley they are looking at Ed Good Memorial Park. The goal for each marker is to ensure high visibility amount tourists and locals by featuring a short story to the town where it is placed. The Economic Development and Tourism Department recently submitted a VA250 grant application, if approved the project will receive \$10,000. Mr. Graves also stated he will pledge a various in-kind service towards the project. Mr. Graves thanked the council for their time.

#### **PASSED MINUTES APPROVAL:**

Mayor Knight asked the council if they had any additions or changes to the past regular meeting minutes and the past budget meeting minutes. With there being none, a motion was made by Councilman Mauck, seconded by Vice-Mayor Stoneberger. Passed Unanimously.

#### TREASURER REPORT:

Town Manager Pettit started off the Treasurer Report stating #84 SVFD, \$15,000 is a grant the Fire Department receives yearly. Vice-Mayor Stoneberger questioned what CSCJTA for was \$4,320.00. Treasurer Stout stated it was for Police training. Mayor Knight questioned what Voya is for \$688.90. Treasurer Stout stated it is a retirement platform for newer employees. With no other questions a motion was made by Councilman Knight to approve the Treasurer's Report, Pay Warrant, in the amount of \$234,583.01 and the Loan Portfolio, seconded by Councilman Mauck. Passed Unanimously.

#### MANAGER'S REPORT:

There have been two grant applications submitted for the assistant sewer program for Chapel Village.

After reviewing the contract with High Country Contract a motion was made by Councilman Mauck to allow Town Manager Pettit to sign the contract for High Country Contracting replace four windows in the back of the town office in the amount of \$9,250.00, seconded by Councilman Knight. Passed Unanimously.

#### **MOTION CARRIED**

The County EMS will be relocating into the vacant building in the Social Services complex.

To lock in the same company to perform the fireworks at Homecoming we need to book them as soon as possible. After brief discussion a motion was made by Councilman Knight to allow Town Manager Pettit to sign the contact with Pyrotechnic for the 2026 Homecoming fireworks show, seconded by Councilwoman Good. Passed Unanimously.

#### **OLD BUSINESS:**

Town Manager Pettit will be meeting with Muddy Feet and the stone mason to begin the sign project at Ed Good Park on Friday 7/18 at 10:00am.

#### **POLICE REPORT:**

Chief Dean gave the police report stating there were 487 calls for service, 7 citations, and 373 self-initiated calls. The department has also increased the number of property checks, making a total of 193 in the month of June.

#### PARK AND RECREATION REPORT:

The next event will be a night swim/ movie night sponsored by PACA on July 19<sup>th</sup>. There are 3 more-night swims planned for July 28<sup>th</sup>, August 5<sup>th</sup>, and August 26<sup>th</sup>.

As of July 1st, there has been a total of 3,370 swimmers this season.

The Cottage renters are paid and up to date.

# **WATER/SEWER REPORT:**

There will be E. Coli testing done on Monday, July 21st at Well #7.

There has been a total of 19 applications put in the Public Works position. Town Manager Pettit gave copies of the applications to Councilman Knight and Councilman Mauck to go over.

Forest Atwood's retirement party will be held July 29<sup>th</sup> at 12:00 during business hours for those Council members that want to attend.

Well #6 the motor was replaced, and well #2 the starter was replaced.

The Lead and Copper project will need to be finalized by September.

Pump station E's, seal is leaking again. Town Manager Pettit stated it may need to be replaced completely and moved underground.

During the bad rainstorm we had it washed out Petefish Drive exposing water and sewer pipes. A-Team came in the next day and fixed the issue.

Foreman Gaunt asked the council what they would like to do with the trash truck? It has been looked at by multiple mechanics and they don't know how to fix the breaks. Councilman

Mauck asked what the truck is mainly used for. Town Manager Pettit stated for the dumpsters at the parks. The Council suggested looking into the cost of dumpsters through Waste Management.

# **NEW BUSINESS:**

There were no Enhancement Awards for the month of July.

Mayor Knight stated he would like to see money deposited monthly into a reserve fund account.
