#### COMMITMENTS

- 1. At the time of signing this contract I have entered into an agreement to deliver and offer my vehicle for sale with Electric Garage Inc. for the reserve price stated. The Reserve Price is an expected selling price that is inclusive of the auction commission. The Auction Company reserves the right to lower the commission in order to sell the car with the seller's net figure being unchanged. The seller may verbally agree to lower the reserve price during the auction process. A reserved vehicle whose reserve is lifted on the block is still subject to the 8% commission fee. If the vehicle is checked into the auction and is withdrawn or does not cross the auction block to be offered for sale, I agree to pay the sale commission in full plus the buyer's fee on the stated reserve price unless specific written authorization is obtained from Electric Garage Inc. waiving said fees.
- 2. Entry fees are non-refundable and do not apply to commission. "With Reserve" means the owner may place a minimum protective price on the vehicle. "No Reserve" means that the vehicle will sell to the highest bidder regardless of price. These must be offered as No Reserve prior to any bids being taken. Owners may not bid on their own vehicles.
- 3. Electric Garage Inc. completes transactions and releases vehicles based on the buyer's / bidder's contract and terms. After funds are verified, vehicles will be released to new owners. Net sale proceeds will then be paid to the seller. Once auction reconciliation is complete, cheques will be mailed out approximately 15-20 banking days from the sale date. Cheques may also be PICKED UP in person at our facility in Sylvan Lake. Please let EG AUCTIONS staff know upon check-in should you wish to pick up cheque.
- 4. Consignor represents and warrants that they have the right to consign and sell the said vehicle and that its title/registration documents are in order and match the vehicle. Furthermore, states that the said vehicle is free and clear of all liens and encumbrances to all or any financial institution or individual agent.
- 5. Consignor warrants the vehicle to be accurately described to the best of their knowledge including items working poorly or no function, its history, description, or mileage. Electric Garage Inc. and/or any agents or companies related to the auction are in no way liable for the vehicle description or accuracy therein. Any discrepancies following the sale will be between the buyer and seller.
- 6. Vehicle check-in info will be emailed along with lot confirmation. Please check in with our floor staff once you reach the facility then proceed to the show office to finalize paperwork. You must give your registration to the ladies upon check in. You must pick up your registration following the sale, should your vehicle not sell.
- 7. Vehicle check-out: vehicles cannot be checked out until the last vehicle crosses the block for the day. We will NOT check out any vehicles prior to the conclusion of the sale. To check out your vehicle, you must obtain a gate release form from the EG AUCTIONS show office and present your request to one of the floor staff. NO EXCEPTIONS. Vehicles removed by noon on the Monday following the auction.
- 8. We cannot guarantee that any changes made to postings after 12pm on the Friday of the auction will appear on the LIVE AUCTION GROUP website. Internet bidders may not see changes to the lineup done after this time. Please have all information in early to avoid disappointment. Consign early so that necessary changes/ additions may be completed with plenty of time.
- 9. Electric Garage Inc. will, at its own discretion, choose run times and particular lot numbers for your vehicle. Premium lot segments are available through your agent. Lot confirmations will be emailed approximately 5-7 days prior to the auction.
- 10. A current Carfax report must be provided by the consignor for any vehicle newer than 1980. Please print or email the report and include it with this form when submitting. You can purchase a Carfax HERE.

### **VEHICLE DROP-OFF & CHECK-IN**

#### Location:

Westerner Park – Prairie Pavilion (East Side) 4847A – 19th Street, Red Deer, Alberta

Please check in with a member of floor staff before unloading.

Do not unload or drive your vehicle into the venue until you've checked in.

You must sign in with the EG Show Office and present your **original** registration, Form 1, or bill of sale. Failure to check in will result in your vehicle being withheld from auction.

All vehicles must be dropped off and checked in by 3:00 PM on Friday, September 5th.

Your vehicle must be:

- Clean
- Contain no more than ½ tank of fuel

There is a car wash located across from the venue.

Clean vehicles sell for more money!

# **CONSIGNOR REQUIREMENTS**

- You must be present (or have a representative) at the stage when your vehicle crosses the block
- Bring two sets of keys per vehicle, if possible

# **VEHICLE PICK-UP**

Vehicles will not be released until the auction concludes each day. After the last vehicle runs, obtain a Gate Release Form from the show office and speak with floor staff.

All vehicles must be removed by NOON on Monday, September 8.
