### 7. COMMITMENTS

1. At the time of signing this contract I have entered into an agreement to deliver and offer my vehicle for sale with Electric Garage Inc. for the reserve price stated. The Reserve Price is an expected selling price that is inclusive of the auction commission. The Auction Company reserves the right to lower the commission in order to sell the car with the seller's net figure being unchanged. The seller may verbally agree to lower the reserve price during the auction process. A reserved vehicle whose reserve is lifted on the block is still subject to the 10% commission fee. If the vehicle is checked into the auction and is withdrawn or does not cross the auction block to be offered for sale, I agree to pay the sale commission in full plus the buyer's fee on the stated reserve price unless specific written authorization is obtained from Electric Garage Inc. waiving said fees.
2. Entry fees are non-refundable and do not apply to commission. "With Reserve" means the owner may place a minimum protective price on the vehicle. "No Reserve" means that the vehicle will sell to the highest bidder regardless of price. These must be offered as No Reserve prior to any bids being taken. Owners may not bid on their own vehicles.  
  
Electric Garage Inc. completes transactions and releases vehicles based on the buyer's / bidder's contract and terms. After funds are verified, vehicles will be released to new owners. Net sale proceeds will then be paid to the seller. Once auction reconciliation is complete, cheques will be mailed out approximately 15-20 banking days from the sale date. Cheques may also be PICKED UP in person at our facility in Sylvan Lake. Please let EG AUCTIONS staff know upon check-in should you wish to pick up cheque.
3. Consignor represents and warrants that they have the right to consign and sell the said vehicle and that its title/registration documents are in order and match the vehicle. Furthermore, states that the said vehicle is free and clear of all liens and encumbrances to all or any financial institution or individual agent.
4. Consignor warrants the vehicle to be accurately described to the best of their knowledge including items working poorly or no function, its history, description, or mileage. Electric Garage Inc. and/or any agents or companies related to the auction are in no way liable for the vehicle description or accuracy therein. Any discrepancies following the sale will be between the buyer and seller.
5. Vehicle check-in info will be emailed along with lot confirmation. Please check in with our floor staff once you reach the facility then proceed to the show office to finalize paperwork. You must give your registration to the ladies upon check in. You must pick up your registration following the sale, should your vehicle not sell.
6. Vehicle check-out: vehicles cannot be checked out until the last vehicle crosses the block for the day. We will NOT check out any vehicles prior to the conclusion of the sale. To check out your vehicle, you must obtain a gate release form from the EG AUCTIONS show office and present your request to one of the floor staff. NO EXCEPTIONS. Vehicles removed by noon on the Monday following the auction.
7. We cannot guarantee that any changes made to postings after 12pm on the Friday of the auction will appear on the LIVE AUCTION GROUP website. Internet bidders may not see changes to the lineup done after this time. Please have all information in early to avoid disappointment. Consign early so that necessary changes/ additions may be completed with plenty of time.
8. Electric Garage Inc. will, at its own discretion, assign run times and lot numbers for your vehicle. Premium lot segments are available through your agent. Lot confirmations will be emailed approximately 5-7 days prior to the auction.

## **BIDDING CONTRACT Event:**

### **TERMS OF SALE**

1. **Terms are cash, E-transfer, certified cheque, bank draft or wire transfers.** Personal cheques and/or business cheques will be accepted only when accompanied by an irrevocable letter of guaranteed credit from the bank stating buying limit and authorized by an officer of the bank. All other arrangements must be approved by senior management.
2. All bidders must have a bidders pass in order to bid.
3. All bidders must provide The Electric Garage Inc with proof of means to pay for any purchases. The Electric Garage Inc retains the right to request a \$500 CASH deposit.
4. All vehicles, or any other purchases, are sold "AS-IS" and without guarantees by The Electric Garage Inc. In no event shall the auction be responsible for any guarantees.
5. All statements by the Auctioneers and those statements printed in advertisements are believed to be correct and are provided by the consignor; however, bidders are to examine all cars and other items before bidding and do so upon his or her opinion and examination.
6. The Electric Garage Inc is not responsible for correctness or year genuineness or any description of the vehicles.
7. All cars are offered for sale subject to reserve price set by the seller unless otherwise stated.
8. Ownership of an item passes to bidder when Auctioneer says "SOLD". At that time, the new owner assumes full responsibility of the item, including but not limited to insurance, damage, whether self-inflicted or by a third party, fire, theft or any other damage that should occur.
