Re: **2025 General Job Pick for EMD, Telecommunications Telephone
Maintenance Supervisors Level I**

On May 15, 2025, a call in Job Pick will be conducted for all Telephone Maintenance Supervisors Level I and will be implemented on a Sunday June 1st 2025 , (incoordination with the 2025 / 2026 TM Job Pick). The implementation of this date shall not exceed one month. The Pick Line phone number is 718-694-1758.

Attached is the information for the 2025 general job pick and a seniority list. Any employee who cannot attend due to extenuating circumstances must designate and instruct an alternate who will make their selection. However, such intentions must be made known in writing to Assistant Chief Anthony Tester Office at 2976 Northern Blvd th Fl LIC , NY, 11101, at least three (3) business days prior to the date of the General Pick. Note: A schedule of the Pick times and call in number will be posted on the employee bulletin boards.

Failure to comply with the above instructions will result in an assignment of a job by management.

Each Telephone Maintenance Supervisor, Level I should read the attached assignment and responsibility sheets prior to the pick date. All selections will be made in accordance with an approved seniority list, please be prepared with several job choices, in case your first choice has been selected when it is your time to pick.

NOTE: Some Jobs reporting locations (Primary and Secondary) on this pick may be changed (with proper notice) to a future EMD reporting location after this pick's implementation. All reassignment of job reporting locations will be in accordance with the collective bargaining agreement (CBA). Supervisors with dual reporting locations (Primary (P) and Secondary (S) will be paid travel time when directed to report to the secondary location in accordance with the CBA.

Persons picking 2976 Northern will re-locate to 3300 Northern quarters upon completion of construction as per the CBA.

Persons picking 7th Ave. Upper level tours will be temporarily relocated to EMD's quarters at Hoyt street on commencement of rehabilitation of 7th Ave facilities in the latter part of 2025 as per CBA.

Notes:

1. All MS1's will be required to provide coverage as needed within any of the Telecommunication and Telecom & Electronic Maintenance groups as directed by management during emergencies.
 2. Jobs CS 01, CS 02 and CS 03-U – Capital Support will be required to complete training as supervisors for lead cable work and confined space.
 3. Language of first shift, second shift, third shift denotes:
1st shift = 12-8 or 11-7 or 10-6
2nd shift = 8-4 or 7-3 or 5-1 or 6-2
3rd shift = 4-12 or 3-11 or 2-10
 4. Holiday Coverage *- 1st and 3rd shift jobs will work all holidays.
 5. Utilities Job: This will require RDO / Tour changes to accommodate vacation coverage and in support of Capital Contracts. This assignment will be of no less than one week. This changes will be in accordance with the CBA.
 6. The total number of Jobs on the 2025 MSI Job Pick is **54**

TELECOMMUNICATIONS Supervisor Primary Responsibilities

RESPONSIBILITIES

First and foremost, it is the responsibility of ALL EMPLOYEES to ensure the safety of each other and the riding public.

Supervisors are responsible for the supervision of assigned staff in the maintenance, installation, inspection, testing, alteration and repair of telephones, carrier lines, telephone switches, key equipment, Help Point, Passenger Station local area network (PSLAN), public address systems and intercom, audio processing and amplification equipment, digital master remote clock systems, cables and emergency, intrusion and fire alarms, fiber optic Networks & equipment, communications room 48VDC power plants which include rectifiers, inverters, control panels, and related wiring, pick up, delivery and replacement of cabinet air conditioning units, DC power plant battery replacement and all related communications equipment along underground and elevated train ways, in yards and on other New York City Transit property. In addition, accident investigation, review and update documents, prepare reports, oversees the cleaning and maintenance of communications rooms, may drive motor vehicles, as well as, any on the job/in-service training and procedure development / implementation necessary to oversee the proper performance of duties and/or operation of power tools/ machinery/ equipment and perform related work. Ensures all assigned work is following NYCT policy and safety rules and regulations. All positions are required to work desk and field as necessary.

All of the above responsibilities are applicable to all positions (primary responsibilities areas are described below).

MSI's picking a PA/CIS (Customer Communication Systems, CCS) supervisory position will supervise personnel in the performance of their duties, when telephone maintainers install, troubleshoot, test, repair and perform necessary scheduled maintenance and adjustments on all station communications systems (Public Address/Customer Information Signs (PACIS), Train Dispatcher System, Help Point, Station Agent Booth IP Phones, BEACON Train Arrival CIS, etc.).

MSI's picking the Field Support Desk (FSD) positions will supervise personnel in the performance of their duties when interfacing with other EMD units and customer departments from office and field. Assign and /or record trouble ticket information, update and close trouble tickets. The MSI will review queries and reports, daily logs, employee absence reports and unusual occurrence reports, as well as update and apprise management of information contained in these reports. MSI will create ,update and closed incidents on the Kezava reports. FSD/MSI's must have basic computer skills and be familiar with Microsoft Office Software. First and third shift FSD MSI's will supervise Northern Blvd Storeroom activities.

MSI's picking Capital Support are expected to supervise the support of external contractors and internal groups in the build-out of varied Communications systems. This support will consists of but not limited to logistical, A &P and actual equipment installation and removal. The MSI's will assign Access and Protection (A &P) to EMD communication facilities and systems. MSI's will supervise telephone maintainers in the construction of Communications Systems and the execution / support of Communications Bulletins. MSI's will supervise the certification and testing of metallic and optical communications media. MSI's will also be required to generate reports in support of Capital Work and keep track of TA labor numbers and hours.

Management reserves the right to maintain adequate supervisory coverage on each shift for each group by control of scheduled vacation and requested time off.

Utility -U Jobs **CS03(U)** and **CS07(U)** is to accomodate C&D (CPM) work schedule changes. Assignment changes will be of no less than one (1) week and no more than eight (8) consecutive weeks at a time except when emergency situations occur. Management will make every effort to ensure that no less than two (2) weeks shall elapse between new job assignments. Management will make every effort to notify Utility personnel at least seven (7) days in advance unless an emergency situation dictate a more immediate notification.

Restricted duty and Long term Sick employees will not be permitted to pick. They may be assigned a job consistent with their ability to perform the work involved provided that such jobs are available.

Employees who are out on long term sick (30 days or more) will not be permitted to pick. If/when the employee returns (to full duty) they will be assignedJobs assigned in accordance with the verbiage in this paragraph shall automaticlly be designated as Relief or Utility Jobs.
