Afternoon Daily Funded Consumables Package includes: Afternoon snack, Tea, nappies and wipes, milk or formula milk, creams and lotions (for example nappy rash cream or sun cream), and a Little Angels bag.

FUNDING ELIGIBILITY

At Little Angels we accept the government childcare funding.
What age can I claim Funding:

Age	Eligibility	How do i check my Eligibility?
3 & 4 year olds	All 3 year old are entitled to 15 hours funding. Working families will be entitled to 30 hours. If you are not eligible for the working parent offer you will still receive the 15 hour entitlement for all 3 and 4 year olds	To check if you are eligible you need to complete an application on the Childcare website: https://www.beststartinlife.gov.uk This will be linked to your tax free childcare account if you use this. You will need to provide us with your Funding Code and your National Insurance number
2 Year olds	Working families will be entitled for 30 hours	
	Some children are eligible based on other aspects, you will receive a separate code from the local authority.	
Term after turn 9 Months	Working families will be entitled to 30 hours funding	

The funding is provided the term after your little angel has reached the required age:

Month your child is born to the month your funding starts:

January to March – Funding begins April

April to August – Funding begins September

September to December – Funding begins January

The parental declaration form

Every school term we need to complete a parent declaration form via Funding Loop. This provides us with lots of information that we share with the local authority. It is a legal requirement that we have to adhere to, therefore if you do not complete your parental declaration form we will not be able to claim the funding and apply the funding to you. This must be done before your child's start date. You will receive more information in regards to this when you complete our application form.

FREQUENTLY ASKED QUESTIONS

1. Little Angels stretches funded hours across 51 weeks. What does this equal in relation to the Government's 30 hours per week offer?

Little Angels stretches funded hours across the 51 weeks we are open. The table below shows what this looks like in weekly hours and minutes, alongside the equivalent Government term time offer.

Please note: the maximum funded entitlement is equivalent to 30 hours term time only, so the weekly stretched funding amount remains the same for 4 or 5 days.

1	5.6 hours (5 hours 36 minutes)	7.5 hours
2	11.2 hours (11 hours 12 minutes)	15 hours

4	22.4 hours (22 hours 24 minutes)	30 hours
5	22.4 hours (22 hours 24 minutes)	30 hours

2. Can I share my funding?

Yes you can, you can share your funding with another early years educational provider. Please note here at Little Angels you can only claim in 5.6 hour blocks and it is offered for 51 weeks.

For example if you attend Little Angels 1 day, claiming 5.6 hours per week this equates to 7.5 hours funding, you may have a remainder 7.5 or 22.5 hours funding to use at another provider.

You will be required to place this on the funding parent declaration form.

3. Is your child about to turn 2 years old and you have just received a code from Oxfordshire County Council? It will look something like this XY-1A2B-3C

5. How do I claim my funding?

The amount of funding you are entitled to depends on your application, you need to complete the 30 hours application on the website:

Once you have received confirmation of your funding entitlement you will receive a code. You need to provide this on your parental declaration form with your National Insurance number for us to confirm eligibility.

You need to make sure you complete your application form for funding before the new 'school term' you will be entitled to claim funding from.

Once confirmed we will automatically update your records to reflect your funding, resulting a change in your invoice.

You will have to update and confirm your eligibility regularly, this is managed separately from Little Angels.



Your Monthly Fee

Here at Little Angels every month you will receive an invoice in advance for the upcoming month. For example you will be required to pay the fee for your early years education and care for February on 1st February.

The invoice will vary each month depending on the number of days you are attending Little Angels in the month.

You will be required to pay by 10th of each month. If this has not been paid you will receive a late payment charge as per stated in your contract.

You will see all your invoices and payment's made on Blossom on the finance section. This will show you your current balance.

Ways to Pay

You can pay your invoice in the following way:

1. Via Parent App

Within our Parent App you will have a financial section, where you can make payment by card for the amount due

2. Tax Free Childcare

You may be eligible for a Tax free childcare account where you transfer payments from the account to us. Full details can be found at Tax Free Childcare [website here](#).

Once you have an account created please let us know your reference code so we can allocate payment correctly.

What if my child does not attend a booked session?

If your child is booked for **(non-funded) sessions, or any additional extension of session hours, the session fee is still payable if your child does not attend.** This includes absence due to illness, exclusion following illness and holidays.

If there is severe weather we will follow our Adverse Weather Policy and will notify parents as soon as possible if we are unable to open. In this situation will not charge for the session (funded or privately paid). If we remain open as normal our usual absence policy will apply.

If your child is attending on **funded-only hours, those funded entitlement hours are provided free of charge and we do not charge for the funded childcare hours if your child is absent, the Daily Optional Consumables Charge is still charged due to supplied already being orderd.** *If you give us 2 months notice in writing that you will be going on Holiday we will not charge the Daily Optional Consumables Charge for funded only sessions.*

Attendance and longer absences (funded children): Oxfordshire County Council can continue funding during short-term absences (up to 20 school days, unless the child is unable to attend due to sickness or unavoidable cause). For continued absence, the council may withdraw funding from the end of the current term or, if earlier, halfway through the term. If your child will be away for an extended period, please let us know as early as possible so we can agree next steps with you.
