



# PRODUCER FEE DISCLOSURE AND AGREEMENT

These are the fees we charge and what they are for.

The purpose of this Disclosure statement and Agreement is to comply with certain state requirements and confirm with you that if we perform any of the following services on your behalf, you agree to pay the amount indicated as compensation for the services provided or expenses incurred.

### Your First Policy with OCHO

When you buy your car insurance through OCHO, we charge a producer fee of **\$160.00**. This is a one-time fee that you agree to pay according to your schedule of payments with OCHO, which may or may not include a Premium Finance Agreement. The producer fee is composed of 4 parts:

<b>CUSTOMER REPORTS FEE</b>	<b>\$10.00</b>
This helps us to pre-fill your information in your application, so it is a faster and more accurate process for you.	

<b>DIGITAL PLATFORM FEE</b>	<b>\$40.00</b>
This fee helps to cover the cost of our digital platform and related technologies so we can deliver our services digitally to you.	

<b>AGENT AND UNDERWRITING FEE</b>	<b>\$60.00</b>
This fee covers agent and underwriting tasks, including collecting information we need from you in order to provide your final quote.	

<b>APPLICATION FEE</b>	<b>\$50.00</b>
This fee covers all other operations needed to process your application.

### Your Renewal Policy or Policies with OCHO

If your policy is renewed by your insurance company, you can accept your renewal, cancel your renewal, or do nothing. If you do nothing, your policy will be automatically renewed for your convenience and OCHO will send you a new schedule of payments according to the terms of your Premium Finance Agreement. We charge a producer fee of **\$100.00** for each renewal. This is a one-time fee that you agree to pay each time your car insurance policy is renewed according to your schedule of payments with OCHO, which may or may not include a Premium Finance Agreement.

All collection activities will be conducted in accordance with applicable law.
