



Recent Accident Reports

- Marshall Islands – The RMIMA has released an [investigation report](#) into the fatal March 2025 occurrence on the bulk carrier 'Amphitrite' in the Java Sea, on 10 March 2025. The ship's port side anchor had been 'stuck' in the hawse pipe, and two crew members entered the pipe with the intention of using a hydraulic jack to try and free it. Suddenly, it moved, pinning them between the anchor chain and the wall of the hawse pipe. The suddenly moved, pinning them between the anchor chain and the wall of the hawse pipe. The investigation found that between the anchor chain and the wall of the hawse pipe, the anchor had been made without consulting the management company, and without adequate risk assessment. In addition, other crew members did not exercise their stop-work authority.

- Offshore supply vessel 'Jack Edwards' and the cargo vessel 'Julie C' near Georgetown, Guyana on 17th March 2024. The OSV was inbound, about 3 miles from Georgetown, when it veered to the port and struck the outbound cargo vessel. Two crew members were injured in the collision, and two 2000 gallons of diesel fuel were released into the water. The investigation found that the steering system had been noticed in the week prior to the incident, and that the steering behaviour had been noticed several hours before the collision. Had the chief engineer been informed, he could have inspected the system before the collision occurred.

- Gibraltar – The OMICo has released an [investigation report](#) into the fatal accident on board the tanker 'Nisyrus' in the port of Gibraltar on 20th May 2025. The ship was mooring ship-to-ship in preparation for bunkering operations when the crew member operating the port forward mooring winch became entangled between the heaving rope and the winch, sustaining fatal injuries. The investigation found that the exact cause of the accident could not be determined. The investigation found that there were several operational failings around the mooring operation, including inadequate mooring parties, and risk assessment.
