Dear Investors,

We, Argo Blockchain PLC (the "Company") are writing to you because our records show that you are someone who has acquired and currently holds shares in the Company (with ISIN: GB00BZ15CS02; CUSIP: 0401261047) and/or American Depository Receipts ("ADRs") or bonds (with ISIN: US0401262037; CUSIP: 040126203) issued by the Company.

As previously announced on the Regulatory News Service, the Company is undertaking a financial restructuring by way of a restructuring plan under Part 26A of the Companies Act 2006 (the "**Restructuring Plan**").

The Restructuring Plan will be structured to enable the Company to rely on the exemption provided by Section 3(a)(10) of the U.S. Securities Act of 1933, as amended, and certain other available exemptions under the U.S. Securities Act of 1933 and applicable state securities laws, in each case with respect to securities expected to be issued under the plan.

You are receiving this letter to inform you that a Claim Form under s 901C(1) of the Companies Act 2006 seeking to convene meetings of the Plan Participants in respect of the Restructuring Plan has now been filed at the Court, and the accompanying witness statements have been lodged at the Court.
