Notice is hereby given by the Benewah County Commissioners, pursuant to Idaho Code 63-1311A, that a public hearing will be held at a regular meeting on **Monday, April 13, 2026, at 9:00 a.m.** or as soon thereafter as it can be heard, at the Office of the Benewah County Commissioners, Benewah County Courthouse, 701 W. College Avenue, Suite 106, St. Maries, Idaho 83861.
