## Purpose of the Meeting

Review Title I, Title II, and Title IV budgets and spending to date

Ensure transparency and shared understanding of how funds support student needs

Provide opportunity for stakeholders to offer input and guide spending decisions

Maintain compliance with NCDPI expectations for stakeholder involvement



#### SRCA is a Title I School

- A "Title I school" is a school with low-income students making up more than 40% of the student body.
- SRCA receives a grant from the Federal Government to support students and provide them with the best possible education.
- The TOTAL amount of money SRCA receives each year is based on the Free and Reduced Lunch Forms. Higher Turn-In = Higher Funding



## Title I Budget Overview

**Total Allocation:** \$163,226

#### **Budgeted:**

Salaries & Benefits: \$149,619.99

- Remedial & Family
   Engagement Supplies: \$5,000
- Workshops & Travel Expenses: \$1,000
- Computer equipment: \$2,000
- Library books: \$5,000

Remaining Balance: \$606



## Staff Members Paid by Title I

- Title I Coordinator & K-5 Interventionist 100%
- K-3rd Grade Interventionist 50%
- 3rd & 5th Grade Interventionist 50%

Combined salaries, benefits paid out of Title I:

\$149,619.99

Time & effort spent on Title I remediation work per employee equals the percentage of salary and benefits received from the PRC 050 grant (Title I).



#### What is Title II?

Title II supports effective instruction and the development and retention of high-quality educators.

#### **Funds may support:**

- Professional development and training
- Mentoring and coaching
- Recruitment, support, and retention strategies

Title IV supports students' access to a well-rounded education and safe, healthy learning environments.

#### **Funds may support:**

- SEL and behavioral supports
- Student enrichment programming
- Technology and instructional tools



## Enrichment - Title IV Budget

#### **Title IV Funds**

- Total: \$11,199
  - Used to cover a portion of our Spanish Teacher's salary



#### School Needs & Priorities

Based on student performance data, teacher feedback, and School Improvement Plan goals, our current instructional priorities include:

- Use check-in assessments and benchmark assessments to monitor growth and adjust instruction
- Implement tiered intervention groups based on assessment data
- Provide targeted instruction based on student needs
- Utilize remediation/enrichment time to work with those tiered groups







Which of the following Title I-funded supports are most helpful to your child's learning? (Select all that apply)



Which areas would you most like to see Title I funds used for in the future? (Select all that apply) 44 responses




What kinds of family engagement activities would you be most interested in attending? 39 responses




What barriers make it difficult for you to participate in school events or activities? (Select all that apply)







In your opinion, how important is teacher professional development to improving student success?

#### **Parent Priorities for Additional Supports**

- Expanded arts/enrichment (arts, music, movement, after-school options; stronger Spanish program).
- Increased **reading & math intervention** with more staff and small-group/1:1 support.
- Strengthened **social–emotional/behavioral support** (separate counselors, SEL, neurodiversity training, specialized classroom).
- More **real-world experiences** (field trips, life-skills class).
- Additional **sports opportunities** (baseball, basketball).

#### **Parent Priorities for SRCA's Greatest Needs**

- **More staffing & smaller class sizes** (additional teachers, assistants, smaller groups, improved teacher–student ratios).
- **Stronger academic foundations** in early grades (reading/math intervention, decodable readers, more 1:1 time).
- Enhanced social—emotional support (counselors, proactive SEL beyond the classroom teacher, team-building).
- Improved communication & logistics (better parent communication, more reliable transportation).
- Support for teachers (manageable class loads, fair pay).
- Hands-on, enriched learning opportunities (outside-classroom education tied to core skills).

#### **Next Steps**

Continue reviewing stakeholder feedback.

Adjust spending plans as needed to align with priorities.

Submit updates to NCDPI.

Monitor and report on program impact regularly.



### Comments / Suggestions

- Invest in morphology materials for upper elementary literacy support
- Continue expanding our Title 1 intervention, remediation, and enrichment supports
- Parent workshops in math, reading, SEL, etc.
- More human resources
- Possibly utilize subs for part-time tutoring
