- Contract management for project vendors working with Santa Fe Community Foundation staff to draft contracts and oversee scope of work delivery.
- Data Strategy
 - Support the coordination of existing efforts among CHP fund partners, City of Santa Fe, and Santa Fe County to align data sources and use, including the creation of a Data Platform.
 - Track and research support materials (e.g., city, county, and state reports and plans.)
- Policy-Advocacy Strategy
 - Support the learning and engagement for elected officials at city, county and state levels (i.e., legislators), including site visits, caucus organizing, and convening community groups, e.g. housing developers.
 - Stay abreast of local and state policy updates and activity.
- Grantmaking Strategy
 - With guidance from fund partners, track grant documents (i.e., guidelines, applications, reporting), conduct outreach to potential grantees, prepare application materials for fund partner review, and follow up with grantees on reporting.
- Communication Strategy
 - With guidance from the fund partners, coordinate communication efforts with a range of stakeholders, including brand identity, website updates, and report dissemination.

Education & Experience

- Bachelor's degree required in nonprofit management, social work, public administration, or a related field.
- Experience working in community housing development, including affordable housing and related services, is preferred.
- 3–5 years of experience in program management, preferably in a nonprofit or community-based organization.
