Please consider this correspondence as a formal request to the Missouri Public Charter School Commission ("Commission") for records pursuant to the Missouri Sunshine Act, Chapter 610, Revised Statutes of Missouri. I request that you make available to me the following records:

1. All records (including drafts of records), including, but not limited to, emails, letters, documents, checklists, rubrics, writing, notes, summaries, text messages, memoranda, meeting minutes, and voice mail or other recordings and/or transcripts thereof, relating to the Commission's communications for the November and December commission board meetings regarding St. Louis Voices Academy of Media Arts ("SLVA") corrective action and probation.
2. All Commission board meeting minutes and notes (including drafts of minutes) discussing SLVA between October 1, 2025 to present.
3. All records (including drafts of records), including, but not limited to, emails, letters, documents, checklists, rubrics, writing, notes, summaries, text messages, memoranda, meeting minutes, and voice mail or other recordings and/or transcripts thereof, relating to the Commission's internal board communications of the board regarding SLVA between October 1, 2025 to present.
4. All records (including drafts of records), including, but not limited to, emails, letters, documents, checklists, rubrics, writing, notes, summaries, text messages, memoranda, meeting minutes, and voice mail or other recordings and/or transcripts thereof, relating to the Commission's board communications with commission staff regarding SLVA between October 1, 2025 to present.
