1. Welcome and Apologies

The President, Mr Matthew Sweeney, opened the meeting at 6:00pm, welcoming members and guests to the 2024 Annual General Meeting of the Tamworth Business Chamber.

Matthew acknowledged the Traditional Custodians of the land, paying respect to Elders past and present, and extended a warm welcome to all attendees.

A total of 59 members were in attendance. A list of attendees is recorded in the Chamber's AGM attendance register.

Apologies: No formal apologies were recorded.

2. Confirmation of Minutes - 2023 AGM

The minutes of the 2023 Annual General Meeting were circulated to all members prior to the meeting.

3. President's Report

The President, Mr Matthew Sweeney, presented the President's Report as included in the 2023–24 Annual Report.

Matthew reflected on the Chamber's 60th anniversary year, highlighting the strategic review undertaken to ensure the Chamber's continued alignment with member needs. He noted the rebranding of the Tamworth Junior Chamber to Chamber Connect, the appointment of a new Operations Manager, and the Chamber's strong advocacy focus including engagement in crime prevention initiatives and leadership forums.

Matthew also thanked departing directors Jocelyn Cockbain and Llewellyn Owens for their service and confirmed he would not be seeking re-election after his two-year presidency. He acknowledged the support of the Board, Chamber Connect Committee, members, sponsors, and operational team.

4. Treasurer's Report



The Treasurer, Mr Martin Howes, presented the Treasurer's Report and Financial Statements for the year ending 30 June 2024.

Martin noted that while the Chamber reported a small deficit of \$27,236, this reflected deliberate investment in future capability including consultancy, recruitment, and governance improvements. He confirmed a sound financial position with cash assets of \$120,533, ongoing sponsorship support, and a current membership base of 369 members.

Martin thanked Roberts + Morrow (Jenna Rice) for conducting the annual financial review.

Motion: That the Treasurer's Report and Financial Statements for the year ended 30 June 2024 be received and adopted.

6. Election of Board Directors

The Chair declared three (3) positions vacant.
