It is with great pride and sincere appreciation that I present the President's Report for the Tamworth Business Chamber, summarising the key achievements, initiatives and developments of the past 12 months.

### A Year of Energy, Impact and Growth

The 2024–2025 financial year has been one of strong performance, renewed focus and deeper engagement with our business community. In an environment marked by continued economic uncertainty, workforce pressures and digital transformation, Tamworth's businesses have shown remarkable adaptability and it has been a pleasure to stand alongside to provide support, advocacy and connection.



We have seen positive momentum across all areas of operation, from rising membership and record event participation to new strategic programs designed to help our local businesses scale and succeed.

### **Membership and Engagement**

Chamber membership has grown over the past year, with more than 380 active members representing a vibrant mix of industries across Tamworth and the region. But just as importantly as the numbers is the quality of engagement.

We've seen a rise in participation, feedback and member driven ideas, clear signs that businesses view the Chamber as a trusted platform for connection and growth.

### **Business After 5 (BA5)**

Our Business After 5 events have continued to go from strength to strength this year. Run and refined by our Chamber Connect committee, the BA5 series has evolved into a seamless, professional and well-attended monthly touchpoint for our business community.

Averaging over 93 attendees each month, BA5 provides a dynamic space for businesses to network, share ideas and build real connections. This year, we also introduced Member Spotlights during BA5 events. giving new members an opportunity to introduce their business to the community and make meaningful early connections.

# Key Programs and Initiatives 2025 Quality Business Awards

The 2025 Quality Business Awards were a hit again this year with over 870 guests attending one of our biggest-ever celebration of business excellence in Tamworth. We also received the highest number of nominations in the event's history, reflecting both the scale and diversity of our local business community

The evening was more than an awards night. It is a celebration of resilience, innovation and community pride. It remains one of our most powerful platforms to elevate the stories of local businesses and champion the individuals and teams driving our region forward.

### Scaling Up Program

This year also marked the launch of our Scaling Up Program, developed to support established businesses as they navigate growth, leadership development and operational scale.



Delivered through high-impact workshops, the program attracted a diverse group of participating businesses, many of whom have already reported measurable changes in clarity, structure and performance. With such strong feedback, we plan to grow the program further in 2026 and ensure that more of Tamworth's businesses are equipped to thrive long term.

### Ignite Initiative - Launching Early 2026

Looking ahead, we're thrilled to announce the upcoming launch of the Ignite Initiative; a new Chamber Connect-driven program aimed at early-stage entrepreneurs and emerging businesses, to support them to power their businesses to success.

Set to launch in early 2026, Ignite will provide access to mentorship, marketing resources, networking and a full 12-month Chamber membership to selected participants. Designed to support new businesses in their critical first years, the program will also encourage innovation, strengthen leadership skills and help participants integrate into the wider business community.

We're confident Ignite will become a cornerstone of our business development offering, nurturing Tamworth's next generation of entrepreneurs and reinforcing our commitment to a thriving, inclusive business ecosystem.

### **Shop Local Campaign**

Our Shop Local campaign this year delivered record-breaking results, a strong testament to the power of community-driven promotion.

The campaign attracted over 18,000 entries and saw more than \$1.2 million in receipts submitted. This year we went back to the future with paper entries, wide-reaching media exposure and strong retailer participation across the region.

We feel that this campaign not only boosts short-term retail activity but reinforces the importance of choosing local all year round. We thank all participating businesses and sponsors for their support and collaboration.

### **Advocacy and Representation**

This year, the Chamber continued to be an active voice in local and regional advocacy, engaging with Tamworth Regional Council, state representatives and industry bodies on key issues affecting our members.

### Focus areas included:

- Infrastructure investment and revitalisation of commercial precincts
- Workforce development and housing solutions
- Support for tourism and the local events economy
- Streamlining compliance and reducing red tape for small businesses

Through these efforts, we assist in overcoming barriers to cultivate a business environment that fosters sustainable growth, confidence and innovation.

## **Challenges and Opportunities**

While 2025 has brought many wins, we remain mindful of the challenges that still face our members.

Labour shortages continue to affect a wide range of sectors. We are working with education providers and government bodies to explore long-term skills development strategies.

Digital capability and cybersecurity have emerged as growing concerns, particularly for small businesses. We are exploring new initiatives to provide training and support in this space.

### **Looking Ahead**

As we move into 2026, our focus will be on building momentum, broadening our impact and delivering value where it matters most.

### **Key priorities include:**

- Expanding the Scaling Up and Ignite programs to provide targeted support for both early-stage and scaling businesses.
- Enhancing communication, engagement and feedback loops with our members, ensuring that their voice continues to guide our direction.

# Treasurer's Report - 30 June 2025

On behalf of the Board of Directors of the Tamworth Business Chamber, I am pleased to present the Treasurer's Report for the financial year ended 30 June 2025.

The Board has continued to exercise careful financial management throughout the year, ensuring that the Chamber remains focused on both responsible governance and strategic growth. This year's result marks a turning point for the Chamber, achieving a surplus of \$818 after four consecutive years of operating deficits.

This year's surplus has been driven by growth in membership subscriptions and event ticket sales, reflecting strong member engagement and the quality and relevance of the Chamber's events.



Cost management continues to be a key focus and maintaining a disciplined approach to expenditure across all programs. The updated profit and loss format, with costs now reported according to the events or activities to which they relate, is an example of this disciplined approach providing a more informed view of performance.

Whilst the result is modest, we are now starting to see the benefits of the investment made in prior years through our internal review and organisational change process, initiatives that have strengthened the Chamber's internal systems and laid the foundation for the long-term.

Chamber continues to recognise the need to rebalance its income sources to ensure ongoing financial resilience, particularly in response to the declining market for corporate sponsorships. Like many organisations, Chamber has experienced a reduction in sponsorship income which reflects the broader market as businesses exercise caution around discretionary spending.

But while sponsorship income remains an important source of income, moving forward, adjustments have been made to membership subscription rates, to better align the value of member benefits, and to reduce Chambers reliance on corporate sponsors.

The Chamber's financial position remains sound, with cash assets of \$204,337, comfortably exceeding liabilities and providing a strong platform for the year ahead. This stability enables the Chamber to continue investing in programs and initiatives that support local business and drive regional prosperity.

Our thanks go to our outstanding team, Kate Spradbrow and Kate Davidson, for their dedication and commitment in delivering on the Chamber's objectives throughout the year.

We also extend our appreciation to our members and sponsors for their ongoing support and engagement, which are central to the Chamber's continued success.

Again, this year Roberts + Morrow have performed a review of the accounts and have prepared the financial statements included as part of the annual report. I'd like to thank Carolyn Cooper and her team for their efforts.


