## **AFS and Cook Solutions Group Partner to Bring Deposit Fraud Intelligence to Conveyance Serverless Check Imaging**

The integration will connect AFS's consortium-based deposit fraud detection with Conveyance, CSG's serverless cloud check imaging solution for ATM and ITM deposits.

Designed for financial institutions that want to modernize ATM and ITM check deposits without adding operational complexity, the partnership will help financial institutions screen deposits against AFS's real-time fraud intelligence as checks move through Conveyance's automated imaging and x937 file creation workflows.

Conveyance is the first true serverless cloud solution for bank and credit union check imaging, eliminating the need for physical servers and reducing infrastructure and maintenance costs. It captures check images and associated data from ATMs and ITMs, consolidates them into configurable X9.37 settlement files, and delivers those files to a financial institution's image processor or review process of choice.

By embedding AFS's deposit fraud intelligence into that workflow, financial institutions will be able to identify suspicious items earlier in the process, reduce manual review, and give fraud teams back critical hours in their day. AFS's solutions—*are already trusted by more than 1,200 institutions to detect and prevent fraud across check, ACH, and wire transactions in real time.*

“Fraud teams are dealing with rising check fraud, more channels, with the same number of hours in the day,” said **Jordan Bothwell, Chief Partnership Officer at Advanced Fraud Solutions.** “By pairing Conveyance’s serverless check imaging with AFS’s real-time deposit fraud intelligence, we’re helping financial institutions automate more of the work that slows fraud teams down, so they can focus on preventing losses.”

Conveyance is powered by RemoteView, CSG's managed services platform that helps financial institutions remotely monitor and support ATM and ITM fleets. Together, Conveyance and AFS will give institutions an integrated path to modernize their deposit infrastructure, tighten fraud controls, and reduce reliance on aging, server-based imaging systems. The companies plan to introduce the integration with an early adopter program in Q1 2026.
