Student Transfer to another Class

A transfer is defined as when a student commences in their course and then wishes to transfer to a different class.

A transfer to another class is not encouraged for various reasons.

Student Recommencement after Withdrawal

Recommencement in the same calendar year as commencement

Where a student who has withdrawn from their course requests to restart the same qualification, within the same calendar year they commenced, this is a **recommencement**.

Applications for recommencement must be made in writing to the Course Consultant.

A recommencement fee will apply, and the materials fee applicable to that qualification may apply.

The decision to waive or reduce the student's recommencement fee rests with the Manager Education & Student Success.

Recommencement fee: \$150

Recommencement in a different year to commencement

Where a student who has withdrawn from their course requests to restart the same qualification, in a different calendar year to that when they commenced, they are not eligible for recommencement.

This is considered a new enrolment, and the student will undertake the full enrolment process.
